### **CALL TO ORDER**

**ROLL CALL:** Ms. Hartman, Ms. Underwood, Ms. Bailey, Mr. Miller Novak, Mr. O'Shea all present. Ms. Bailey moved to excuse Ms. Zorb and Mr. Hedger. Ms. Underwood seconded. Motion passed. 5-0.

**AGENDA:** Ms. Bailey moved to accept the agenda; Ms. Underwood seconded. Motion passed 5-0,

# **Committee Reports:**

**Budget & Finance:** Ms. Bailey reported a meeting was held January13 at 7:30 pm to discuss the finished audit reports ending in years 2017 and 2018. Next meeting will be held February 10, 2020 at 7:30 PM

**Public Safety:** Ms. Underwood reports: First meeting, January 27, 2020 at 6:30 pm.

**Rules and Public Policy:** Mr., O'Shea reports: First meeting will be the 4<sup>th</sup> Monday of the month, January 27,2020at 6:30 pm.

<u>City & Community Development & Recreation.</u> Ms. Bailey reports: Next meeting January 27, 2020 at 7:30 pm.

<u>Ad Hoc Reports</u>: No report, Ms. Underwood reported no appointments as of yet. Mr. O'Shea did point out that Ms. Zorb was sworn into office as an appointment for Ms. Dewald on January 13, 2020.

#### ADMINISTRATIVE REPORTS:

#### <u>Mayor:</u>

- Ms. Nichols reports there have been 8 interviews for the opened position of Administrative Assistant. Three have been moved to the 2<sup>nd</sup> round which should occur by the end of the week.
- Ms. Nichols inquired if the Ms. Zorb and her Serve NCH group was able to plant
  the tulips in the islands on Hamilton Ave. Mr. Mosby reported yes they had
  successfully planted the bulbs and it was made possible with the help of Public
  Works providing safety and traffic control and other assistance.
- The owner of Curl up and Dye has a back to school special and mentioned that City, Community Development and recreation should get with her for community development.

## **City Administrator:**

- Mr. Mosby welcomed new members of council, Mayor, President of Council and Council clerk to their new positions.
- The Hamilton County transit tax, 0.8% on the March ballot, if passes could be a catalyst for a transit center in North College Hill and economic development. Hamilton County is setting aside 1.5 million dollars for economic development for suburbs in Hamilton County. Mr. Mosby is working closely with the county, private developers and C.I.C for possible redevelopment. He hopes Council will support him with legislation for the proposed project.
- Mr. Mosby has started planning for Suicide Prevention month and has reached out to Mt. Healthy, Springfield Township and Colerain Township with positive feedback. Ms. Driehaus has agreed to help again as well. Hopes are to have the third reading in August with September being the dedicated month for Suicide prevention.
- I.C.R.C. has sent their 202 proposed budget and an invitation to the liaison for the January 23 meeting.
- We currently enjoy \$70,000 more than projected in tax revenue in December most likely from the subpoenas that were sent out in October by our tax department R.I.T.A. We are not to expect this every month.
- Public Works has the new equipment in place at Dumley Park and waiting for the new surface and cooperative weather,
- Water Works project will conclude in March. Centerridge to begin about that same time (March or April).
- Gas Tax revenue is approximately \$170,000.00.
- Public Works will be cutting down dead or dying trees that can become a hazard to our city.
- Hamilton County's tax levy for 911 calls could lower fees and over 2 years and could mean approximately \$100,000.00 immediate results to the General Fund in 2020/2021.
- Shots fired, no injuries and suspect apprehended. Special thanks to the Hamilton County Coroners Office with a quick analysis of the DNA sample from the NCH P.D.
- Request for funding for flooring in the offices at the City Center. They are substandard and hazardous.
- Also, Mr. Mosby wants to work with council to get legislation to them in a timely manner for 3 readings, such as the Tax Budget due to Hamilton County in July right in the middle of Council's summer session.

Mr. O'Shea: Thanked Ms. Dewald for filling the need as Clerk of Council. He also pointed out the need for the city website to be updated with current members of council and the link on the home page for legislation to work. Discussion regarding the legal aspects of the agenda, charter vs new amendment. As chair of Rules and Public Policy he will investigate this.

#### REMARKS FROM THE AUDIENCE:

No one signed in but Mr. Jim Dewald, 6714 Jamar wanted the publicly thank Public Works for their help and the safety they provided with the planting of 1300 bulbs in the islands on Hamilton Avenue.

Councilmember also wanted to commend Public Works for their quick response to clean up the broken branches strewn all over the street from the previous night windstorm Councilmember Mr. Miller Novak expressed his appreciation for the planting of the tulip bulbs especially in such cold temperatures and to recognize the efforts of the department for a quick clean up after the windstorm.

<u>First reading:</u> Resolution 01-2020; A resolution authorizing the use of an employee dishonesty and faithful performance of duty policy. Discussion, Mr. Mosby explained this replaces the bond for the positions of Police Clerk, City administrator and Finance Director. It covers te position and not the person, for example if one of these individuals should leave their position there is no need to reapply for bonding. The position remains bonded.
