LEGISLATION


Second Reading; Ordinance 08-2020; AN ORDINANCE REQUIRING THE USE OF FACIAL MASKS IN PUBLIC TO MITIGATE THE SPREAD OF COVID-19 AND DECLARING AN EMERGENCY. Discussion. This Ordinance was not requested or reviewed by council Hamilton County already has requirements similar to this and Ordinance 8 has conflicts with the county mandate and unenforceable. Mr. O'Shea moves to defer this legislation to the safety committee for proper review. Ms. Zorb 2nd. Mr. Miller-Novak questions why we are voting on this again and for Mr. O'Shea to define conflicting and continues to speak asking if he means different. An ordinance can have things that are different than the county. That doesn't mean it's a conflict. Ms. Underwood said council did request a mask ordinance. It has been drafted by the Law Director and should have no potential liabilities. Motion to defer Ordinance 8 to Safety Committee fails 3 yes votes, 2 no votes.

Third reading; Resolution No. 12-2020, A RESOLUTION APPROVING A PURCHASE AGREEMENT FOR AN AMBULANCE FOR THE CITY OF NORTH COLLEGE HILL AND DECLARING AN EMERGENCY. Mr. O'Shea moves to adopt. Ms. Zorb 2nd. No discussion. Motion passes 5-0
