**Minutes for NCH Special Virtual Council Meeting, November 30, 7:00 pm**

**CALL TO ORDER** 7:00 pm

**ROLL CALL** Ms. Bailey, Ms. Blythe, Ms. Underwood, Mr. Miller-Novak, Pres. Pro Tempura Ms. Zorb, Ms. Hartman, Ms. Anderson, All present.

**Charter Review commission;** Ms. Bailey moves to start a charter review commission. Ms. Underwood 2<sup>nd</sup>. No discussion. Motion passes 7-0. Discussion after the vote. Mr. Miller-Novak asks if it needs to be seated with the 7 members at this time. Ms. Zorb reads section 14.06, Charter Review of the City Charter, that the commission shall be "created". It was undetermined council will look to the Law Director Bill Deters for clarification and answers.

**Mask adherence issues/concerns.** Discussion of city employees not wearing masks. Governor's mandate was discussed. Ultimately a mask ordinance adherence needs to be enforced my administration, not council.

**2021 City Operating budget.** Due to the late hour and the time it would take to look at the budget because of such a tight budget. It was agreed to set up another meeting time to discuss the budget due to the details that need to be addressed .Council agreed to meet Wednesday, December 9 at 7:00 pm as a Committee of the Whole meeting.
