ARRESTS MADE IN OCTOBER 2014

There were a total of **76** arrests made within the City of North College Hill in OCTOBER 2014.

36 of the arrests were recite arrests (the person arrested was not physically taken into custody but issued a citation and told to appear in court).

40 of the arrests were physical arrests (the person was physically taken into custody).

Of the total arrests made within the month of OCTOBER 2014, **45** were residents of North College Hill and **31** were non-residents.


VEHICLE CRASHES REPORTED IN OCTOBER 2014

There were a total of 28 auto accidents within the City of North College Hill in OCTOBER 2014.

3 of these crashes involved injuries.

19 of the auto accidents were on the public roadways.

9 of the auto accidents were on private property.



TRAFFIC CITATIONS ISSUED

IN OCTOBER 2014

The North College Hill Mayor's Court had year-to-date receipts totaling \$160,889.08 as of OCTOBER 2014.



There were a total of **176** traffic citations issued within the City of North College Hill in OCTOBER 2014.

68 of the citations were for moving offenses (Speeding, Fail to stop at a Stop Sign, etc.)

29 of the citations were for non-moving offenses (Expired license plates, not wearing a seatbelt, etc.)

21 of the citations were for parking related offenses (Parked where prohibited by signs, etc.)

58 of the citations were written warnings (the person cited was not required to pay a fine or appear in court).



VEHICLES TOWED OR IMPOUNDED IN OCTOBER 2014

There were a total of 11 vehicles either towed or impounded within the City of North College Hill in OCTOBER 2014.



FALSE ALARMS RECEIVED IN OCTOBER 2014

There were a total of 33 false alarms received that required a response by the North College Hill Police Department in OCTOBER 2014.

10 of these false alarms were to businesses.



23 of these false alarms were to residences.

326 Total false alarms have been received in 2014.



The following narratives are a small sampling of the various calls for service the North College Hill Police Department routinely receives.

CALLS FOR SERVICE

Criminal Damaging (2909.06)

Officers were dispatched to investigate for a criminal damage in progress by an ex-girlfriend. As PO Jones arrived on the scene he observed a figure standing next to the victim's truck. The figure was facing the truck and had something white in its hands, near the open fuel tank. The figure, now determined to be a female, was ordered to turn around and show PO Jones her hands. She refused and turned around further and appeared to be manipulating something with her hands. PO Jones drew his taser, activated the laser, and



ordered her several more times to show her hands. She eventually complied and turned around. She was ordered to the ground, handcuffed and taken into custody, and placed in PO Jones car.

At that time, Sgt. Petrocelli arrived on the scene. PO Jones and Sgt. Petrocelli found a 4 lb. Bag of sugar and a paper funnel on the small ledge below the fuel door, and open gas cap. There were sugar granules around the opening to the fuel tank.

The female was transported to the police station was processed, and transported to HCJC. She was charged with Criminal Damaging. She was also

issued a citation for parking her vehicle in the fire lane. The vehicle was then towed from the fire lane by A1 Classic towing.

She was also issued a Criminal Trespass Notice, which she signed acknowledging that she was not to return to the property on Meis Ave. The victim was also advised to obtain a restraining order.

Theft (2913.02)

PO Henn was called to Tom's Drive Thru for a theft that occurred the previous night. Upon arrival, PO Henn was met by the reportee who stated an unknown male black entered the store at approximately 1900 hours, walked directly to a store display and selected a 750mL bottle of Seagram's Gin. The subject then concealed that bottle in the front of his pants and left the store, passing all points of sale, without paying for the alcohol. The incident was captured on the store's surveillance system. The subject appears to be a male black, approximately 25-35yoa, 5'10 and 220lbs. The subject was wearing dark pants and a gray t-shirt with "Levi's" printed on the front. The subject was also wearing a dark



baseball cap, turned around backwards. The subject appears to have been with a smaller black vehicle which went through the drive thru and made a purchase. The subject exited the store through the drive thru, meeting up with the black car in the drive thru. According to the reportee, they have had several similar thefts recently, and upon doing an audit of the surveillance system, last night's theft was the only incident captured on the system.

The reportee was advised a report would be on file with our department to document the incident. He was further advised to contact our department should the subject return.

Auto Theft (2913.02)

On 10/06/2014, at 10:32 am, PO Maus was dispatched to Simpson Ave for an auto theft report. He arrived on scene and spoke to the complainant, who stated he left the Duke Energy truck (#16106)



running in the driveway of the residence while he was inside on a customer call. The complainant stated he came back outside and discovered

the truck missing. The complainant described the truck as being marked on both doors with the Duke Energy emblems, white tool boxes in the rear bed and the truck number 16106 on both front quarter panels. The vehicle was entered into the Police data base and a broadcast was put out throughout Hamilton County.

Criminal Damaging **(2909.06)**

Officers were dispatched to investigate for a parent having trouble with her son destroying property. Upon arrival, it was found the son had departed the residence. The parent stated that her son had gotten into a verbal argument with his friend. The argument escalated to a physical confrontation in which the son stated to the friend, "I'm gonna cut you". The son then ran into the kitchen and attempted to pull open the drawer in the kitchen which contained silverware and knives.

The friend was able to grab the son from behind and physically restrain him so as to deny access to the knife drawer. Becoming frustrated, the son kicked out the

lower cabinet door directly below the knife drawer. He then was released whereby he ran from the house.

The friend declined to prosecute the son for the assault and the threats. The parent stated that her son is completely out of control, has been suspended from school, does what he pleases, refuses to listen to her because "He is now taller than she is". She stated the juvenile court does not provide any punishment for her son when he engages in this type of activity. She further stated that her son has a history of assaults on other people, has a history of threatening



people with knives, has been arrested having a concealed firearm, and is generally a violent person. She states that her son has been diagnosed with

Oppositional Defiance Disorder and ADHD.

The parent fears for the safety for her other children if her son remains in the home. Her other children, ages three to thirteen were all present in the home at the time this altercation.

The son has been entered as a missing juvenile; charges have also been filed for Criminal Damaging.

Breaking & Entering

(2911.13)

On 10/07/2014 @ 2201 hours, officers were dispatched to W. Galbraith Rd. to see a complainant regarding a Burglary report. Upon arrival, officers were met by the victim, who stated that someone had entered his property and removed numerous firearms from the trunk of one of his vehicles that he parks inside the property listed. More

specifically, the victim advised officers that over the past week or so, there have been numerous issues pertaining to his girlfriend and her family. He also stated that he



has known his girlfriend's family for many years and that her parents were fully aware that they were dating while he has been married. He further stated that he had hired his girlfriend's father to work for him but that approximately one week ago, he had to terminate his employment due to ongoing issues on the job.

After the victim fired the father, the tension between all parties involved has been escalating with incidents such as someone slashing numerous

tires on the victim's trucks while they were parked at his shop. It was even reported today that the victim, who resides in the City of Mt. Healthy, had to contact their police department today to file a criminal damaging report after someone smashed the driver side window to one of his vehicles that he had parked in the driveway at his residence.

After first, Mr. Sawyer stated that he didn't notice anything missing from his vehicle when the report was filed. It

wasn't until the victim and his girlfriend responded to his property on W. Galbraith Rd. that he figured what had actually been removed from his vehicle that had

been damaged in his driveway. More specifically, he stated that he possess two (2) separate garage door openers to his property on W. Galbraith Rd. and that he usually alternates the garage door openers between several of his vehicles that he may drive each day.

When he and his girlfriend stopped by the property to pick up a few things before their trip to Arkansas in the morning, he stated that he opened the trunk to one of his vehicles in the

garage and that was when he noticed that the large quantity of firearms he had in the trunk had been stolen. It was stated by the victim that he had placed all the firearms in the trunk of his vehicle the other day because he and several others had gone shooting / target practicing with them. When he noticed that the firearms had been stolen and that there were no signs of forced entry into his secured property, as well as the vehicle in question, he quickly put together the reason his other vehicle in Mt. Healthy had been broken into.

It was reported that the other garage door opener he has, which had been attached to the visor in his other car at his residence had been stolen and then used to gain access into his garage on W. Galbraith Rd. The victim stated that nothing else, other than the firearms and numerous rounds of ammunition, had been removed from his property.

The victim stated that due to the ongoing issues between he and his girlfriend's family, he stated that he truly believes that his girlfriend's brother is the one responsible for stealing the firearms. He believes the brother knew the firearms were in the trunk of his vehicle and that the brother has a lengthy criminal history and is a known drug user

The victim was advised to write down an itemized list of each and every firearm that was stolen and their respected serial numbers so the stolen property could be added to the initial report and the database as well.

Aggravated Robbery **(2911.01)**

On 10/14/14 at 7:45 PM, PO Smith was dispatched to Goodman Ave to meet a complainant reference his juvenile grandson being robbed at taser point while walking home. Upon arrival, PO Smith made contact with the complainant and the victim. The victim stated that he was returning back home from Long John Silvers and was walking south on Savannah Ave., when a group of four young, black males approached him, and ordered him to give them his money. The victim then stated that one of the suspects put their hand in his pocket, at which time, the victim grabbed his hand. The victim then stated that one of the suspects brandished a Taser, and told him to give him his money, or he would "taze" him. The victim then stated that once again, one of the suspects reached into his pocket, and



removed \$10 in cash. The victim then stated that he ran into his house on Goodman Ave. The victim described the suspect with the Taser as approximately 16 to 20 years of age, wearing a green hooded sweatshirt, jeans, and brown boots. The victim described suspect #2 as wearing all black, with a black hat. Suspect #3 was described as wearing a black jacket and tan pants. Suspect #4 was described as wearing a white t-shirt with brown pants and Nike gym shoes.

After obtaining all of the information, the victim, who stated that he has previously seen the suspect with the Taser previously in the neighborhood, rode with PO Smith in his cruiser and visually pointed out the residence on Dearmand Ave. The victim also advised that he could pick the suspect with the Taser out of a photo line-up.

in a red pickup truck. Per the anonymous complainant, he saw the subjects using needles. Upon arrival, PO Henn located the vehicle and occupants parked on Parrish. He approached the driver side of the vehicle and observed the male driver making furtive movements toward the driver side door. PO Henn opened the door and observed what appeared to be a hypodermic syringe on the floor between the driver seat and door. He removed the male subject from the vehicle and patted him down for officer safety. That subject was placed in handcuffs and placed in a cruiser. The male was advised his

Miranda warning, and freely admitted to having just used heroin. PO Maus arrived a short time after PO Henn and contacted the female who was seated on the passenger side of the vehicle.



After securing the male in his cruiser, PO Henn recovered the syringe from the floor next to the driver door, and observed an unknown substance inside that syringe that is believed to be heroin. A search of the vehicle found an aluminum clipboard/paperwork box in the rear floorboard which contained two more hypodermic syringes as

Possession of **Drugs/Possession of** **Drug Paraphernalia** **(2925.11/2925.14)**

Officers were dispatched to the area of Parrish Ave near Goodman Ave for male and female using drugs

well as a metal spoon which had an indentation in the center of the bowl and burn marks on the bottom. The clipboard also contained paperwork and technical information that would belong to an HVAC technician. PO Henn asked the male what kind of work he did, and he advised he was a heating and air technician. The syringes and spoon were recovered and entered onto our property room. The syringe containing the unknown substance will be submitted to the Hamilton County Coroner's Lab for analysis.

The male was transported to our station for processing, and then transported to the Hamilton County Justice Center.

Burglary (2911.12)

Victim stated that she was losing a great deal of weight. This inspired her to attempt to try on her mother's (heirloom) engagement ring. Victim went to the small jewelry box, where she kept the ring to find it missing. She then noticed several other pieces of jewelry missing which prompted her to call to police. Once on scene, the victim advised officers of a long, ongoing harassment issue with the suspect. The



victim then said the suspect had called several times today.

According to the victim, the suspect, during one particular call stated she had pawn tickets for the victim's merchandise. The suspect then demanded the victim and her husband pay \$600.00 in exchange for the pawn tickets. Officers were able to hear approximately 7 messages, allegedly left by the suspect on the victim's home phone. This messages included phrases like "It's all about to go down", which, according to the victim, was a threat. Both the victim and her husband stated the calls were unwanted and the suspect was aware. Victim stated they had not changed their numbers due to some logistical issues. When the weather was a bit more manageable (September) they would leave the back window up in the bedroom. This is about the time the jewelry was last seen and is believed to be the point of entry as there are no signs of forced entry.

The victim was advised to check with local pawn shops in an attempt to locate their property. They were also advised a change in numbers, both home and mobile, may stop the unwanted calls. Additionally, a civil protection order may

also aid this situation. The victims were advised of this as well.

Assault (2903.13)

PO Smith was dispatched for a squad run where a female had been injured during an assault. The squad stated they were going to stage down the street. He was updated by dispatch that the male who had assaulted the female was still on scene.

Upon the arrival of police, a female stated her husband was inside the home with his babies' mother and they had been involved in a physical altercation. Officers entered the home and brought both subjects into the living room for questioning. The husband stated his babies' mama came over because her car was acting up and he was going to fix it for her. The vehicle wasn't able to be fixed and due to that he and his babies' mama got into a verbal argument in the upstairs of the home.

When officers spoke to the babies' mama, she stated that nothing was physical at all. She stated that the light scratches on the side of her face were due to her falling into a wall.



She claimed to be very clumsy on her feet which the babies' daddy immediately agreed with. She advised the officers that he never hit her and that they were only yelling at each other. She was not forthcoming with information and stated that her babies' daddy's wife was a liar.

When asked about why babies' mama was allowed at the home, the wife stated that they were all friends and were together all the time. The wife added that she was also the god mother of her husband's babies' mama's child. Parties were separated for the night and advised of consequences if further incidents occur.

Theft of Firearm (2913.02)

The victim came to our station to report an unknown person or persons removed her loaded firearm from her unlocked vehicle without her knowledge or consent. The victim states she is in the process of moving and had the weapon in a storage compartment of her van, however the rear door of the van does not lock. The victim does not have a serial number for the firearm; however she states she purchased the weapon

from Peterson's Gun Shop, which is now out of business. She was advised by someone she contacted from the business that all the information was forwarded to the ATF when the business closed.

The victim was advised a report would be on file with our department to document the incident. She was further advised our department will attempt to obtain information for the weapon from the ATF so the weapon can be entered as stolen.
