# ARRESTS MADE IN NOVEMBER 2014

There were a total of **100** arrests made within the City of North College Hill in NOVEMBER 2014.

**36** of the arrests were recite arrests (the person arrested was not physically taken into custody but issued a citation and told to appear in court).

**64** of the arrests were physical arrests (the person was physically taken into custody).

Of the total arrests made within the month of NOVEMBER 2014, **43** were residents of North College Hill and **57** were non-residents.


# VEHICLE CRASHES REPORTED IN NOVEMBER 2014

There were a total of 36 auto accidents within the City of North College Hill in NOVEMBER 2014.

4 of these crashes involved injuries.

31 of the auto accidents were on the public roadways.

5 of the auto accidents were on private property.



# TRAFFIC CITATIONS ISSUED IN NOVEMBER 2014

The North College Hill Mayor's Court had year-to-date receipts totaling \$176,585.08 as of NOVEMBER 2014.



There were a total of **183** traffic citations issued within the City of North College Hill in NOVEMBER 2014.

**67** of the citations were for moving offenses (Speeding, Fail to stop at a Stop Sign, etc.)

**29** of the citations were for non-moving offenses (Expired license plates, not wearing a seatbelt, etc.)

**33** of the citations were for parking related offenses (Parked where prohibited by signs, etc.)

**54** of the citations were written warnings (the person cited was not required to pay a fine or appear in court).



# VEHICLES TOWED OR IMPOUNDED IN NOVEMBER 2014

There were a total of 11 vehicles either towed or impounded within the City of North College Hill in NOVEMBER 2014.



# FALSE ALARMS RECEIVED IN NOVEMBER 2014

There were a total of 23 false alarms received that required a response by the North College Hill Police Department in NOVEMBER 2014.

8 of these false alarms were to businesses.



15 of these false alarms were to residences.

350 Total false alarms have been received in 2014.



The following narratives are a small sampling of the various calls for service the North College Hill Police Department routinely receives.

## CALLS FOR SERVICE

### Possession of Drugs (2925.11)

Officers were dispatched to West Galbraith Rd. When they showed up to the scene, they found a juvenile sitting on the couch, a juvenile laying on the dining room floor on the left hand side going in and out of unconsciousness, and a juvenile passed out on the kitchen floor by the fridge. PO Wilbur began trying to get the juvenile in the kitchen to regain consciousness. He awoke and was confused at first. PO Wilbur then calmed him down and had him stay sitting on the ground for his safety.

That is when he noticed the juvenile reaching down to his sock on his left foot. When he reached down, PO Wilbur could see a bulge coming from his sock. The juvenile then pulled down his pant leg to try and hide the bulge. PO Wilbur then reached down and felt the bulge. When he felt the bulge, the juvenile tried to reach down and hinder him from touching it any further by trying to push his hand away. PO Wilbur then told the juvenile to keep his hands away. The bulge was a gray plastic baggy containing a white substance. That is when the juvenile made unprovoked statements that he was only holding it for his friends. He also stated that he did not know what



it was, but that it was not his. All of the juveniles were transported to the hospital by various EMS personnel.

defendant was charged with criminal trespassing (ORC 2911.21) and attempt-theft (2913.02).

## **Attempted Theft** **(2913.02)**

On November 1st 2014, Officer Elston was called to Betts Ave for a possible theft of a bicycle out of a back yard. Upon arrival at the house, the resident stated that she was taking the garbage out when she saw the suspect trying to take a bicycle from her fenced in yard. When the suspect saw her, he ran and jumped over the fence into the alley. Once in the alley the suspect walked to Sterling Ave.

Once at this intersection Lt. Schrand saw him and was able to match him to the description given. Lt. Schrand stopped to talk to the suspect, who willingly admitted to being in the backyard of that house trying to steal a bicycle. He told PO Elston that he was trying to steal the bike because someone had just stolen his and he was upset due to his long walk home. The suspect was taken into custody and transported to NCHPD. Once at NCHPD the



## **Aggravated Robbery** **(2911.01)**

On 11/1/2014 at approximately 2100 hours officers were dispatched to an Aggravated Robbery that had just occurred outside of Fifth Third Bank. Officers were also informed that the victim in the robbery will be in the lot of Penn Station. Upon his arrival, PO Buchanan located the victim. She advised that she had just returned to her vehicle after removing forty dollars from the ATM. She further advised that a male black in a red hooded sweat shirt approached her driver door and attempted to open it. The victim was able to lock the door before he could open it. She said an additional male black in an all-black hooded sweat shirt and black bandana over his mouth, opened her passenger side door. The victim advised that after he opened the door he pulled out a small black pistol and demanded all her money.


After further investigation, the victim found that her white Motorola cell phone with a purple case was taken. She also advised forty dollars and her debit card was also stolen.

Officers requested a perimeter and a K-9 unit to respond. The Green Township K-9 Unit tracked from Fifth Third Bank, Save-A-lot and ended at the old Racket Club. Officers and K-9 unit were unable to locate the suspects in question.

too far. He also stated that there was a unique rose sticker on the driver side window approximately 5 inches in diameter.

While inside speaking with the complainant and his wife about how the truck may have been stolen, his wife stated she had a set of his truck keys in their other rental vehicle. After checking the rental vehicle it was found to be unlocked and the truck keys were missing. That vehicle was processed for fingerprints but no prints were able to be lifted by Officer Miller. The owner of the vehicle stated he was going to go drive around and try to locate it. The vehicle information was passed on to dispatch for a broadcast.

## **Auto Theft** **(2913.02)**



On 11/8/2014, Officers Miller and Jones were dispatched to Meis Av for an auto theft report. Upon arrival, PO Jones met with the owner of the stolen truck. He stated that his truck was parked near the rear of the house in the driveway and was locked with no keys inside the vehicle. His mother-in-law went outside to smoke at approximately 0330hrs and noticed the vehicle was still in the driveway. At approximately 0600hrs, when leaving for work, the complainant noticed his truck was missing. He stated that his truck had almost no gas in it so it shouldn't have made it

At approximately 0725hrs, officers received a call that the owner of the vehicle had located it in the area of Hamilton Av and Sundale Av. Officer Miller then canceled the stolen vehicle and responded to meet with the owner. Officer Miller then processed the vehicle and found no prints that were able to be lifted. Officer Miller described the prints found to be consistent with someone wearing gloves. The owner reported

that the only item missing out of the truck was a 1st generation Ipod.

## **Burglary (2911.12)**

### **Assault on a Teacher** **(2903.13)**

A teacher at the North College Hill Jr/Sr High School was on hallway duty at the beginning of the school day. She saw the juvenile defendant with another student at the lockers and she advised the defendant she needed to go to class. The student replied "Shut the fuck up!" and "Get the fuck out of my face!" The teacher told the student she needed to come to the office, but she refused. The teacher again stated she needed to come to the office and at that time, the student used both hands and shoved the teacher in the chest/shoulders, pushing her into the locker bank.

When PO's Henn and Lasonczyk arrived at the school, the defendant was in the office. She was placed in custody and transported to the North College Hill PD, where she was processed for Assault on a Teacher and Disorderly Conduct. She was then transported to 2020 Auburn by PO Henn.

Officers were dispatched to respond to Catalpa Ave. for a report of a burglary in progress. Seconds later, they were updated and being advised that the suspect is now heading east on Catalpa Ave. Suspect was described as a light skinned male black, wearing a black jacket with no hood and carrying a blue bag. As other police units were searching the area, PO Brown responded to the scene, to get more information. One of the neighbor kids, happened



to be on the sidewalk in the 1800 block of Catalpa and noticed the victim's son's bicycle being rode by a light skinned male black, who was not the owner of the bike. He said at the same time, a car drove by and the suspect stopped and dropped the bicycle on the sidewalk and ran east on Catalpa and the north on Savannah. He said he has seen the

suspect before, but is not sure who he is.

Around the same time, the homeowner returned home and found that her son's window was unsecured and the front door was not locked. The homeowner advised that she has her kids' bicycles in the house so they will not get stolen. The homeowner stated that she did not see the suspect. The homeowner seems to believe that the suspect lives on Catalpa Ave. or is one of the kids that trespass through her yard from Cordova Ave. to "cut through". No suspects are known and there was nothing else reported missing at that time.

those transactions totaling \$7094.00. The financial institution has made attempts to contact the suspect, and to have him make the transactions good, to no avail. The reportee states the bank does wish to pursue criminal charges against the suspect for the bad checks and fraudulent withdrawals.

The reportee was advised a report would be on file with our department, and the Hamilton County Prosecutor's Office will be contacted in an effort to obtain a direct indictment against the suspect for the criminal charges.

## **Passing Bad Checks** **(2913.11)**

The reportee came to the North College Hill PD to report a known subject that opened an account with the Greater Cincinnati Credit Union, and subsequently made several fraudulent transactions involving checks and ATM withdrawals against that account between 10 October 2014, and 27 October 2014,




## **Robbery (2911.02)**

Officers responded to Emerson Ave. for a report of a robbery. Officers met with the victim, who was visibly upset and appeared to be out of breath. He was shaking and crying. Officers observed several red marks on his face and neck. His clothes were disheveled and he grabbed at his groin several times, as if in pain. The victim refused treatment for these injuries. According to the victim he had arrived home and was carrying in several items from his car. As he approached his house he was

accosted by the suspect, who followed him inside. The victim put his items down and the suspect began demanding money. The suspect allegedly stole several items from the victim and his wife, at some point, and then pawned them. The suspect stated she would hand over the pawn tickets for a large amount of cash. The victim, who reportedly has given a great deal of money to the suspect over the years, adamantly refused this demand. The two began arguing over the money, when the suspect dashed toward the rear of the home.

She then started to "toss" the room and pull out all of the items in the drawers. Officers could see the rear door wide open and a computer lying near the door. Officers went to the rear of the residence where two bedrooms are located. One bedroom has been converted into an office. In the office, Officers located items were all over the floor. The drawers were half open and clothes appeared to be pulled out as if someone was desperately looking for something. The victim stated the suspect furiously started "looking for money" throwing things



around. The suspect then located an envelope with approximately \$700-800 in cash. The suspect grabbed the money and shoved it in her pants. The victim attempted to physically remove the money from the suspect's pants. The two were arguing. The suspect then struck and scratched the victim while attempting to leave with the money. The victim continued to try to stop the suspect from leaving with his money. At one point the suspect threw a computer that was near the rear door, at the victim so that she may escape with the money. She also threw several items downstairs in an attempt to divert the victim's attention. The victim said the suspect fought him the entire way out the door.

According to the victim, as they made it out the door, the suspect dove under the railing. The victim had to let go at this point to avoid further injury. The suspect then ran toward the front of the house, got into a car and left the scene.

Several minutes later, Officer Henn, who was currently on station advised over radio the suspect, had arrived at NCHPD. After

photographing the scene officers responded to the Police Department to speak with the suspect. The suspect had already been Mirandized by PO Henn in the presence of PO Smith.

The suspect initially said she had gone over to the victim's house to discuss giving him pawn tickets. She stated she gave him the tickets and demanded money. When the victim said he did not have the money she demanded, she ripped the tickets away from the victim. The two then began to fight. The suspect went on to say, the victim had choked her. The victim did not appear to actually be upset. Her hair was order and her clothes were relatively neat. There was no redness to her face or her neck. The only time the suspect became flustered was when officers requested to search her vehicle. Officers requested permission to search the suspects' vehicle to locate any evidence. The suspect at first denied this request saying "well, it's not my car so..." She continued to fill out her written, statement. She was also advised that without her permission, her vehicle (vehicle she was currently in possession of) was subject to being impounded so that a



search warrant could be obtained. She was also advised the reason for this was, officers believed evidence of a crime existed in that vehicle.

Due to the evidence at the scene and the victim's injuries, the suspect was placed under arrest for Robbery. Officers again explained their request to search the vehicle involved in the incident. The suspect agreed and signed a "Consent to Search Form" giving Officers permission to search the vehicle. Officers proceeded to the vehicle, which was unlocked. As Officers conducted a search of the vehicle, they located drug paraphernalia. These items were taken and logged into evidence. Additional charges of Drug Paraphernalia were added to the arrest paperwork. Additionally, a female officer was requested to respond to the PD, to search the suspect. Once the suspect was searched by the female CPD Officer, she was transported to CJC.

## **Burglary (2911.12)**

PO Wilbur responded to Dallas Avenue for a burglary report. When

he arrived he made contact with the victim. The victim stated that she left her house at 1400 hours and arrived back home around 1745 hours. She stated that when she came home she walked in the front door and noticed her TV and blue ray player were missing. She stated that she turned on all the lights cleared the house, and noticed her back door was cracked open. PO Wilbur asked her if she left the doors unlocked she stated she did not. When PO Wilbur observed the rear door he noticed no signs of tool marks or forced entry. The victim stated that she does not know how they got in. PO Wilbur checked the windows and all windows were secure also. He looked at the table the TV was on and the door where they supposedly came in. The victim stated that she had the serial number for the TV. PO Wilbur took all the info and told her to call him if she discovered any other items were missing.



On 11/27/2014, officers were requested for a possible criminal damaging report. Upon PO Ryan's arrival, the complainant made contact with him in his driveway. The complainant advised that he arrived home on 11/26/2014 at approximately 1900 hours and saw nothing wrong with his vehicle. He advised that he came out the next morning at approximately 0745 hours to find a large dent on the passenger side of his extended cab truck.

After further investigation no additional damage was found to his truck or other property in the area. The

complainant advised that his son is having relationship issues. He also advised that the female involved is aware that his son is staying with him. The complainant gave PO Ryan the name of the female that may be involved.

The complainant was advised that a report will be made about this incident. He was also advised if he found any additional information proving the female caused the damage to contact the police.
