ARRESTS MADE IN FEBRUARY 2015

There were a total of 94 arrests made within the City of North College Hill in FEBRUARY 2015.

62 of the arrests were recite arrests (the person arrested was not physically taken into custody but issued a citation and told to appear in court).

32 of the arrests were physical arrests (the person was physically taken into custody).

Of the total arrests made within the month of FEBRUARY 2015, 56 were residents of North College Hill and 38 were non-residents.

IN FEBRUARY 2015


There were a total of **48** auto accidents within the City of North College Hill in FEBRUARY 2015.

1 - of these crashes involved injuries.

30 - of the auto accidents were on the public roadways.

8 - of the auto accidents were on private property.

10 - of the auto accidents were Hit/Skip related.



TRAFFIC CITATIONS ISSUED

IN FEBRUARY 2015

The North College Hill Mayor's Court had year-to-date receipts totaling \$31,737.00 as of FEBRUARY 2015.



There were a total of **93** traffic citations issued within the City of North College Hill in FEBRUARY 2015.

34 of the citations were for moving offenses (Speeding, Fail to stop at a Stop Sign, etc.)

11 of the citations were for non-moving offenses (Expired license plates, not wearing a seatbelt, etc.)

20 of the citations were for parking related offenses (Parked where prohibited by signs, etc.)

28 of the citations were written warnings (the person cited was not required to pay a fine or appear in court).



VEHICLES TOWED OR IMPOUNDED IN FEBRUARY 2015

There were a total of 6 vehicles either towed or impounded within the City of North College Hill in FEBRUARY 2015. (These vehicles were towed or impounded at the request of the police department)



FALSE ALARMS RECEIVED IN FEBRUARY 2015

There were a total of 31 false alarms received that required a response by the North College Hill Police Department in FEBRUARY 2015.

13 of these false alarms were to businesses.



18 of these false alarms were to residences.

63 Total false alarms have been received in 2015.



The following narratives are a small sampling of the various calls for service the North College Hill Police Department routinely receives.

CALLS FOR SERVICE

Theft (2913.02)

On 2/2/15 at approximately 3:15 PM, PO Smith was dispatched to Kroger, 7132 Hamilton Ave, to investigate a theft of alcohol. Upon arrival, he made contact with a cashier for Kroger. The cashier stated that he observed a white male with a cart full of beer exit the store through the west door with a cart full of beer. The cashier then stated that he walked out to the parking lot and saw the suspect enter the a red Pontiac.

After speaking with the cashier, the manager viewed the surveillance footage of the incident in the Management Office. At 2:44 PM, a white male

matching the suspect was seen exiting the store with a cart of beer. Per Kroger, the suspect fled the store with 9, 24 packs of Miller Lite, total value of \$172.84.

Breaking & Entering (2911.13)

PO Brown responded to Cordova Ave. for a report of a B&E to a vacant home. Upon arrival, he spoke with the reporter, who stated that person(s) unknown, entered the home through the rear door. There was no damage to either the door or the frame and the lock had been changed



after the previous tenants vacated the home. There was nothing reported missing, nor was any damage to the property reported. The rear door had been touched by the property maintenance person since the incident.

A witness, who lives across the street, observed a male black with dread locked hair, standing in the front of the property at around 2000 hours on 02/02/15. She also observed the same male walk to the rear of the property, but did not see anyone go inside the door or see anyone inside the home. She was advised to call "911", when she observes suspicious activity such as that.

Assault (2903.13)

PO Shumate responded to Betts Ave. for the report of a juvenile that was assaulted by two other juveniles. Upon making contact with the victim, he states while walking home with his girlfriend, they stopped at JK3 and were approached by the two suspects who asked if the victim wanted to fight.



The victim stated no and told them to leave him alone. While walking through the alleys towards the home on Sterling Ave., the two male blacks approached the victim and began striking him in the face. The victim and his girlfriend proceeded to the Sterling address and contacted our department.

PO Shumate later spoke to the staff of the High School and found that the victim had contacted them, and Ms. Johnson will be looking into this event as it started at the high school to see if she may be able to mediate this issue. The parents will be in touch if they wish to proceed with charges.

Robbery (2911.02)

Officers were dispatched for a street robbery in progress in the area of Good Brothas Bar. When officers arrived in the area they were updated that the suspect had left. PO Miller was unable to locate the victim and had dispatch inquire to the caller's location. Dispatch reported that the caller is circling the block and refused to come back to the scene, but would meet officers at the PD. It

was also determined that the caller was a witness, not the victim.

Officers checked both Good Brothas and Grown Folk bars for a possible victim. PO Miller talked to the Grown Folks bouncer that was standing outside when he arrived on scene. He reported that he was only outside for a couple minutes and during that time he didn't see or hear anybody fighting or being assaulted.

PO Miller responded to the police department and made contact with the witness, who stated that he was driving north on Savannah Ave. when he observed a male black lying on the ground (Victim) and another male black (Suspect) hovering over top of him pushing/shaking him. The witness thought there may be a medical emergency occurring and stopped to see if any help was needed. He said he stopped his car and asked if everything was ok. He said the suspect responded saying everything is fine "this dude owes me some cheese." The witness then proceeded to drive away slowly and continued to watch. He said that's when the suspect punched the victim, who was now standing, knocking him to the ground. The suspect then reached down and



removed the victim's wallet. The victim stood back up, only to be punched two more times by the suspect, knocking him back to the ground. The suspect then dropped the victim's wallet and walked south on Savannah Ave.

The witness described the victim as an older male black, bald, wearing a tan coat. The Suspect was a younger male black, short (5'6"), thin build, wearing black. The witness stated he might be able to identify the suspect if captured. Officers canvassed the area trying to locate a victim, but were unable to locate either. The police received no other calls reference the incident.

Theft from an Auto **(2913.02)**

The victim stated while her vehicle was parked in the lot of Rose's an unknown person(s) removed her iPhone 5. Her vehicle was unlocked and there was no sign of forced entry. The victim stated Apple would not help her unless she had a police report filed. I asked the victim if she had the phones serial number so it could be entered into LEADS but at the time

she did not. I advised her to try and find the phone box and get it to me as soon as possible. I also was advised that she did not have any tracking applications downloaded onto her phone and that why apple was unable to assist her in its location. I attempted to call the stolen phone but it went to voicemail. The victim was given a business card and told to call if she had any further information.

Possession of Drug Abuse Instrument **(2925.12)**

On 2/16/15 at 4:05 PM, officers were dispatched to McDonald's to investigate possible drug activity in progress. Upon arrival, employees on scene stated that the defendant was currently in the Men's Restroom using drugs. After entering the restroom, officers made contact with the defendant, who was standing at the restroom stall. PO Wilber asked the defendant if he had any drugs or weapons on his person, and he stated that he had two "riggs" in his pocket. During the



search of the defendant, two hypodermic syringes were located in his front, left pants pocket. A spoon was located in the defendant's right, front, pants pocket. The defendant also stated that he had just finished shooting heroin just prior to Officers entering the restroom.

Breaking & Entering **(2911.13)**

PO Henn was called to W. Galbraith Rd. for a vacant residence found open. Upon arrival, he was met by the reporter, who is a contractor performing work on the residence for the property owner. The reporter stated an unknown person or persons entered the residence and removed a new stove and refrigerator without the knowledge or consent of the property owner. The subject(s) appear to have gained access by forcing open the basement door, breaking the door frame. Once inside, the subject(s) appear to have exited from the first floor side door with the listed items.

The reporter was advised a report would be on file with our department to document the incident as well as the procedure to follow for obtaining a copy of that report.

Disorderly Conduct **(2917.11)**

Officers were dispatched to Fricker's to investigate trouble with a customer yelling and arguing with staff then refusing to leave. Upon arrival, the customer was found to be a passenger in a car in the parking lot. The complainant reports that the customer entered the bar intoxicated and became upset when he was refused alcohol. He became loud, verbally abusive and caused a disturbance within the crowded bar. The complainant ordered the customer to leave the bar and he refused to do so. He eventually left the bar when police were called. The customer was cited for Disorderly Conduct and released from the scene.



PO Jones arrived on scene to observe a male smoking outside of the apartment complex on Hamilton Av. He stated that he allowed a friend to move in with him a few weeks ago to help her out. He then stated that tonight she arrived home late in the morning and they began to argue. During that argument she allegedly punched him in his right eye. As he was explaining, PO Jones observed no injury or swelling to his eye. He was also light skinned and no bruising was observed. PO Jones asked the complainant what police action he wished for and he stated he wanted her arrested and taken out of his apartment. He also stated he didn't want her back in his apartment ever again. He was advised of Ohio's residence laws and what the limits of police were. He was given information on how to file for an eviction and a temporary restraining order.

Assault (2903.13)

Officer Buchanan was contacted by Mt. Healthy Police Sgt. Michaels in reference to a male who came to their station wishing to file assault charges. The male was advised to meet officers at his home in North College

PO Jones went inside the apartment and woke the suspect. She was escorted out of the apartment and into the hallway so he could get her side of the story while Officer Buchanan remained inside with the victim. The suspect stated that she

has been in bed since 10pm. She stated that the complainant has been home all night as well but has been drinking and harassing her. She also advised PO Jones that he has become very obsessed with her recently. This has caused problems with her at work due to him following her around and spying on her. This has all come about because she refuses to have sexual relations with him. When asked if she had struck him in the face she stated she never touched him and that he never hit her.

During PO Jones' interview of the suspect, Officer Buchanan advised him the complainant stated that he may not want to press charges now. The suspect was advised that it still may be a good idea to leave for the night. She agreed and wanted officers to transport her to her White Castles in Mt. Healthy. She was escorted back inside to retrieve a small amount of property.

While back inside, the complainant stated he was going to continue with charges. Officer Buchanan had him fill out a sworn affidavit while PO Jones cited the suspect into Mayors court for assault. After finishing needed paperwork she was transported to White Castles.

Robbery (2911.01)

On 16 Feb, 2015, North College Hill Police received a call from University Hospital advising they had a gunshot victim, who was reportedly shot in the left hand in a robbery attempt that occurred at the corner of Waltham and Simpson. PO Manning proceeded to University Hospital and spoke to the victim's boyfriend, who stated that they were coming home from a bar in Forest Park, when they stopped at the stop sign at Waltham @ Simpson and were accosted by 2 men. One of the individuals pulled a gun, pointed it at the victim, who immediately began to fight the individual and the gun went off striking her in the left hand.



Upon interviewing the victim, she stated that they were in Forest Park at the bar, and they proceeded on 275, down Colerain Ave. to Thornton Gas at the corner of North Bend and Colerain, got gas and then went to Simpson enroute to her friend's house. When they pulled to the stop sign at Waltham @ Simpson, small black car (maybe a Hyundai) stopped next to them with 2 m/b individuals

inside. One pulled open the passenger door and stuck a gun in her face, telling her to "give me everything." She immediately began to fight with the individual over the gun, whereby it went off striking her in

the left hand. The injury was a through injury. They personally transported to University Hospital for treatment, and UC and Cincinnati PD called NCHPD to report the incident.
