ARRESTS MADE IN MARCH 2015

There were a total of 112 arrests made within the City of North College Hill in MARCH 2015.

64 of the arrests were recite arrests (the person arrested was not physically taken into custody but issued a citation and told to appear in court).

48 of the arrests were physical arrests (the person was physically taken into custody).

Of the total arrests made within the month of MARCH 2015, 68 were residents of North College Hill and 44 were non-residents.

VEHICLE CRASHES REPORTED IN MARCH 2015


There were a total of 49 auto accidents within the City of North College Hill in MARCH 2015.

4 - of these crashes involved injuries.

31 - of the auto accidents were on public roadways.

6 - of the auto accidents were on private property.

8 - of the auto accidents were Hit/Skip related.



TRAFFIC CITATIONS ISSUED

IN MARCH 2015

The North College Hill Mayor's Court had year-to-date receipts totaling \$48,881.00 as of MARCH 2015.



There were a total of **125** traffic citations issued within the City of North College Hill in MARCH 2015.

59 of the citations were for moving offenses (Speeding, Fail to stop at a Stop Sign, etc.)

12 of the citations were for non-moving offenses (Expired license plates, not wearing a seatbelt, etc.)

24 of the citations were for parking related offenses (Parked where prohibited by signs, etc.)

30 of the citations were written warnings (the person cited was not required to pay a fine or appear in court).



VEHICLES TOWED OR IMPOUNDED IN MARCH 2015

There were a total of 11 vehicles either towed or impounded within the City of North College Hill in MARCH 2015. (These vehicles were towed or impounded at the request of the police department)



FALSE ALARMS RECEIVED

IN MARCH 2015

There were a total of 41 false alarms received that required a response by the North College Hill Police Department in MARCH 2015.

9 of these false alarms were to businesses.



32 of these false alarms were to residences.

104 Total false alarms have been received in 2015.




The following narratives are a small sampling of the various calls for service the North College Hill Police Department routinely receives.

CALLS FOR SERVICE

Theft of an Auto (2913.02)

Officers were dispatched to Betts Ave. for a vehicle theft that had just occurred. While enroute, officers were given the update that the vehicle was just seen travelling east on Goodman Ave approaching Hamilton Ave. PO Henn was at Parrish Ave and Goodman Ave at the time of this update, and did not observe any vehicle matching the description given. He responded to the scene as PO Lasonczyk patrolled the surrounding area. Upon arrival, PO Henn was met by the victim, who stated an unknown person or persons took her teal colored 2007 Chevrolet

Equinox from her driveway without her knowledge or consent. The victim stated she had left the vehicle running to warm up, and when she came back outside, she found the vehicle missing. After calling the police, the victim stated she then saw the vehicle on Goodman Ave and Betts Ave, traveling east. The victim has no idea who may have taken the vehicle.



The victim was advised a report would be on file with our department to document the incident as well as the procedure to follow for obtaining a copy of that report. She was further advised the vehicle will be entered as stolen, and should she recover the

vehicle on her own, she will need to contact our department so the entry can be canceled.

The vehicle was entered into RCIC/LEADS/NCIC as stolen, and an All County Broadcast was issued via HCCC for the wanted vehicle.

Disorderly Conduct **(2917.11)**

On 3/1/15 at approximately 9 PM, PO Smith was dispatched to the parking lot of Auto Zone to meet a complainant

Upon arrival, PO Smith made contact with the complainant. The complainant stated that he was driving westbound on W. Galbraith Rd. and was being followed closely by the defendant. The complainant then stated that when he turned into the parking lot of Auto Zone, the defendant cut him off near the entrance; started screaming at him, then threw an energy drink can at his vehicle. The complainant was able to provide a license plate number for the defendant. The complainant advised PO Smith that he did not locate any damage to his vehicle.

After speaking with the complainant, PO Smith attempted to make contact with the defendant by his listed phone number on RCIC. PO Smith left a voice message for the defendant.

At approximately 9:30 PM, he made contact with the defendant by phone. The defendant admitted to throwing the can, and agreed to report to NCHPD to provide a statement.

At 9:55 PM, the defendant reported to NCHPD. The defendant stated that he was at the intersection of W. Galbraith Rd and Daly Rd,

traveling westbound. The defendant then stated that he was in the far right lane, and the complainant was next to him in the middle lane. The defendant then stated that as the two lanes merged into one lane, the complainant, who was attempting to merge into the right lane, cut him off, nearly striking his vehicle. The defendant stated the complainant was driving erratically up W. Galbraith Rd. The defendant then stated that they both turned left onto Goodman Ave, and the complainant slowed down, and he drove in front of the complainant. The defendant then stated that they met in the parking lot

of Auto Zone, and they exchanged words. The defendant then stated that he then threw a can of NOS energy drink at the complainant's vehicle. The defendant was cited for Disorderly Conduct.

Criminal Mischief **(2909.07)**

A complainant advised that a customer purchased a cell phone from Wireless A on 03/09/15, and came in on 03/10/15 at around 1140, to exchange the phone as she was not happy with it. The complainant exchanged the phone along with a few extra items at no additional charge, and then left the store.

The customer came back about an hour later wanting to exchange the phone another time. The complainant explained to the customer that he cannot exchange the phone again per the store's policy. She argued for a bit with the complainant and was not satisfied. She became upset and as she was leaving the store she proceeded to knock items off the counter and kick over a cardboard floor display.

At around 1420 hours, a female, differently dressed, but appeared to be the same female, came into the store with a cup and poured liquid on

the ends of each of the two glass display cases and quickly left. The complainant also stated that sometime overnight, someone placed fecal matter on the outside door handle of the front door at the front of the store. The female's phone is on another subject's account. After searching the account name and information, PO Brown could not find the name listed or anything else regarding the name.

Aggravated Robbery **(2911.01)**

On 03/11/2015 @ 1801 hours, officers were dispatched to the Fifth Third Bank (5/3rd Bank) for an Aggravated Robbery that had just occurred. Upon arrival, officers were advised by the employees that two (2) male blacks, both armed with firearms and wearing gloves and masks over their faces, had entered the financial institution demanding that the bank tellers give them all of the money from the teller's money drawers.

One suspect was described as wearing a red hooded jacket, dark colored ski mask and was



brandishing a black colored firearm (described by employees as a possible Tech 9). The other suspect was described as wearing a dark colored (blue or black) jacket with a fur lining around the hood. This suspect was reported to have a silver colored firearm (possibly a .380).

After collecting an undetermined amount of U.S currency, the suspects fled out the main entrance and were last seen running east through the parking lot towards the Family Dollar store.

Assault (2903.13)

A complainant and her daughter came to the police station to report that her daughter had been assaulted. The complainant reports that she received a call from her daughter at approximately 8:40PM stating that she had just been assaulted. She states she returned home and was driving her daughter to the hospital when she observed three girls that her daughter stated had assaulted her. The girls were walking south on Hamilton Ave near Goodman Ave at the time. She states that she called police to report this at that time. Officers did get dispatched at that time and located the girls and obtained their information.

At the police station the complainant's daughter stated that she was sitting on her porch with her little sister watching movies on tablets. She stated that three girls ran up on her porch and began hitting her. She then stated that a group of unknown boys then threw her down and began kicking her.

The daughter's left eye was swollen and she had a small cut over her right eye, her left cheek appeared to be swollen. When Lt. Petrocelli asked who had hit her in the eye, she stated that she did not know who had hit her in the eye.



He then asked her if she had been alone on the porch with her sister, she stated that yes she was. He then advised her that this was not true, since he arrived at work this evening at 6:00 PM, he had observed between 5-8 people on her porch each time he drove by or left the police station. (The house is situated directly across the street from the police station). She again stated that she was alone with her sister the whole time.

Lt. Petrocelli then advised her of the story of the three girls who he had stopped earlier, and she stated that

they were lying, that they ran up on the porch and started hitting her.

The victim was then asked to write down what had happened. She then provided a written statement with her mother present. In this statement, she indicates that she was on the porch with another girl when the girls ran up and started to hit and kick her. Then two separate groups of boys began to kick her, and throw her across the porch.

The complainant then stated that she wanted these three girls arrested and charged with assault. Lt. Petrocelli advised her that it appears at this time that based on the conflicting stories of the three girls, and her daughter, and the fact that her daughter was unable to determine who had struck her in the face, it appears that the only thing that we could prove was that all the parties were engaged in a fight and therefore possibly subject to disorderly conduct charges. Lt. Petrocelli further advised her that it sounds as if the group of unknown boys had injured the victim, the most by throwing her down and kicking her.

The complainant was not happy with this resolution and left the station stating that she

was going to call the media because this department was not doing anything and this was not right.

Lt. Petrocelli went to the three girl's residences to obtain further information and written statements of the events. These three statements were relatively consistent except they all mentioned that the victim ran back into the house and came out with her gun. And then the police arrived and everyone ran away.

Lt. Petrocelli contacted the complainant and advised her that the three girl's stories remained relatively the same and that he would be forwarding all the information obtained to the juvenile prosecutor's office for a determination of charges once the investigation is complete.

Theft (2913.02)

The reporter called the NCHPD to report that a subject had run out of Roses and set the security off the alarm. This person was in the store approximately 2 weeks ago and the same thing had happened. The Assistant Manager tried to run after the suspect, but he got into a grayish



green Santa Fe type vehicle and left the scene. The suspect is described as a M/B subject that was wearing a blue jacket. The driver of the vehicle was described as a F/B subject with a white hat or wrap on her head, and carrying a purple jacket. The vehicle was last seen going westbound on W. Galbraith Rd. from Goodman Ave. The vehicle was not located at that time. The complainant is going to have the Manager check the cameras and see if they can determine what, if anything was taken. If the camera shows anything, they will make a copy and forward same to me. PO Lasonczyk advised the complainant to call the PD immediately should the subjects return.

Murder (2903.02)

On 03/20/2015 at approximately 2316 hours officers were dispatched to a person shot outside of Good Brothers Bar. Upon PO Buchanan's arrival, subjects advised the person shot is further south. He located the victim lying on the sidewalk on Savannah Ave., near H-Alley. He advised dispatch of the location change and proceeded check on the victims' wellbeing. He found the victim to



be unresponsive and bleeding profusely from the back of the head. PO Buchanan started chest compressions and spoke with the victims' friend. PO Buchanan continued chest compressions until the arrival of the life squad, but he was unable to get any response from the victim. As the squad continued to care for the victim, PO Buchanan began taking pictures of the scene while assisting with the perimeter. He also assisted with locating potential evidence on scene.

Discharge Firearm on Prohibited Premise (2923.162)

Officers were dispatched to the complainant's address on Cordova Ave, for a report of a neighbor firing several shots at the complainant's dog. Upon arrival, PO Henn was met by the complainant who states her pit bull had gotten out of her fenced yard, and the neighbor two doors to the west of her address had fired several shots at the dog. The complainant states the suspect then left the area in a blue or green pick-up truck with racks in the bed. According to the complainant's son, he was in his back yard playing basketball when he heard the

shots. He stated he observed his dog running from the suspect toward another neighbor's yard with the suspect firing shots at the dog. Approximately five shots were fired. The complainant came out of her residence when she heard the shots and confronted the suspect, telling him that she had called police. The suspect then left in the aforementioned vehicle. The complainant's dog was not injured by the shots, and a search of the suspect's back yard found no shell casings or other evidence that shots had been fired in that area. Officers knocked on the door of the suspect's residence and received no answer at the door, however, an entry was found in PAMET for that address. A female was contacted by phone, and that female stated she resides there with her husband who does drive a blue pick-up truck. That female provided information for her husband. An RCIC check for that subject returned with nothing in file matching the date of birth. She was advised to have her husband contact our department to discuss the incident further.

The complainant was advised a report would be on file with our department to document the incident,

and our second shift officers will attempt to make contact with the suspect this evening to obtain his information and his side of the story. She was further advised all information pertaining to the investigation will be forwarded to our prosecutor to determine if criminal charges will be filed in this matter.

Domestic Violence **(2919.25)**



Officers responded for a report of a physical domestic. Upon arrival, the husband stated he was asleep and his wife went crazy. He stated she pulled the bed covers off him and apparently struck him in the back of the head with an unknown object. He was not injured and didn't wish for charges.

Officer Miller spoke to the wife, who stated the husband was out all night at another woman's house drinking and smoking weed. The marriage is failing and they began to argue. She stated she didn't hit him with anything and if something hit his head it could have been her elbow when she pulled off his blankets.

Both continued to argue about infidelity and marijuana usage. Officers advised them that it would probably be best for one person to leave. At this point, the husband stated his wife said she was going to kill him. He was asked if there was anywhere we would take him or if he had somewhere else to go. He stated he wasn't going anywhere and that he shouldn't have to. He was advised that if he was seriously in fear for his life why wouldn't he want to go to another family member's house. He still stated he wasn't leaving.

The officers asked both parties if either of them wanted to leave to which they both said no. We then asked them if they both felt comfortable that everything would be ok if police left. The husband stated yes but the wife stated she didn't know. She was advised that we would take her somewhere if she wasn't comfortable. She refused and stated she wasn't leaving she had too much money into the house. Both parties were advised that if they couldn't solve their issues and were called again one or both could be arrested if necessary.



Burglary (2911.12)

On 03/26/2015, officers were dispatched a burglary in progress. While enroute, officers were advised the suspects, 3 male black juveniles were exiting the residence carrying televisions. Officers were advised one juvenile was wearing a red hoodie, another was wearing a brown shirt or jacket around his neck and the juveniles were entering a wooded area, stashing the televisions in the bushes.

PO Maus arrived on scene with Officer Palmisano and confirmed there was an offense. Officer Palmisano made contact with the next door neighbor who had called 911. Officer Palmisano advised the juveniles were last observed by the witness crossing the street and entering the wooded area going toward Parrish Ave. PO Maus advised the Hamilton County Helicopter (9H10) the last direction of travel of the juveniles were observed. PO Maus was looking in the direction of travel the juveniles were last observed when 9H10 flew over. He observed a male black wearing a red jacket running down the middle of

Parrish Ave heading towards Emerson Ave (south). He was then advised by 9H10 there were several juveniles running down Parrish Ave towards Emerson Ave. He then headed to Parrish Ave when he observed PO Brown and a Mt. Healthy unit taking two suspects into custody. The suspects were wearing a red jacket, and a black hoodie. PO Maus then continued on towards Emerson Ave, where 9H10 was still following subjects running on foot. PO Maus was advised by 9H10 the suspects were now running in between houses in all directions. He was advised by 9H10 the subjects were standing in the front yard of a blue residence on Emerson Ave at Savannah Ave. He continued to 1803 Emerson Ave when 9H10 advised me the suspects were headed to the rear yard. PO Maus was on Savannah Ave at Emerson Ave when he observed one

subject run across the street from the side yard on Emerson Ave wearing a brown jacket. PO Maus then continued south on Savannah Ave and he observed two subjects turn and run towards the front of the blue residence. Officer Elston arrived and began a foot pursuit of the subjects running towards the front of the blue residence. Officer Elston was able to order one of the subjects to the ground in the Alley directly behind the blue residence on Emerson Ave. PO Maus responded to Officer Elston's location and placed the subject into custody. Officer Brown and Mt. Healthy responded to Emerson Ave and was able to obtain the other two subjects standing in the front yard of a house on Emerson Ave. The suspects were all transported to the North College Hill Police Department where they were interviewed by LT. Ferguson.
