ARRESTS MADE IN JULY 2015

There were a total of **105** arrests made within the City of North College Hill in JULY 2015.

56 of the arrests were recite arrests (the person arrested was not physically taken into custody but issued a citation and told to appear in court).

49 of the arrests were physical arrests (the person was physically taken into custody).

Of the total arrests made within the month of JULY 2015, **65** were residents of North College Hill and **40** were non-residents.

VEHICLE CRASHES REPORTED IN JULY 2015


There were a total of 26 auto accidents within the City of North College Hill in JULY 2015.

1 - of these crashes involved injuries.

17 - of the auto accidents were on public roadways.

4 - of the auto accidents were on private property.

4 - of the auto accidents were Hit/Skip related.



TRAFFIC CITATIONS ISSUED

IN JULY 2015

The North College Hill Mayor's Court had year-to-date receipts totaling \$88,366.00 as of JULY 2015.



There were a total of **108** traffic citations issued within the City of North College Hill in JULY 2015.

36 of the citations were for moving offenses (OVI, Speeding, Fail to Obey a Stop Sign, etc.)

16 of the citations were for non-moving offenses (Expired license plates, not wearing a seatbelt, etc.)

11 of the citations were for parking related offenses (Parked where prohibited by signs, etc.)

45 of the citations were written warnings (the person cited was not required to pay a fine or appear in court).



VEHICLES TOWED OR IMPOUNDED IN JULY 2015

There were a total of 14 vehicles either towed or impounded within the City of North College Hill in JULY 2015. (These vehicles were towed or impounded at the request of the police department)



FALSE ALARMS RECEIVED

IN JULY 2015

There were a total of 23 false alarms received that required a response by the North College Hill Police Department in JULY 2015.

10 of these false alarms were to businesses.



113 of these false alarms were to residences.

230 Total false alarms have been received in 2015.



The following narratives are a small sampling of the various calls for service the North College Hill Police Department routinely receives.

CALLS FOR SERVICE

Assault (2903.13)

Lt. Petrocelli received a phone call from the Frickers manager, stating that a male subject there was fighting his girlfriend in his truck. The manager also stated that he thought the male may have his girlfriend in some sort of headlock. Lt. Petrocelli and Officer Cole responded to the scene.

PO Jones heard Officer Cole report the call over the county radio and he responded as well. Upon his arrival, Lt. Petrocelli had the male subject detained by his truck and Officer Cole was walking inside of Frickers. PO Jones went inside Frickers as well to assist Officer Cole



in speaking with the victim and witness. The victim stated she and the male subject got into an argument inside his truck. She said she wanted her cell phone back but he began to choke her with his hands. She stated she got out of the truck and he struck her with his vehicle in an unknown manner.

The female victim had multiple injuries all over her body. There was redness, swelling, cuts and what looked like road rashes on her arms, legs, right hip, hands and neck. She stated these were all caused by the male during the fight outside Frickers. Medics were requested to evaluate

the victim due to her injuries. The medics stated she was going to be transported to the hospital due to swelling near her trachea. PO Jones went outside and informed Lt. Petrocelli that he would be placing the male under arrest.

PO Jones asked the male what happened tonight. He replied "what do you want to know". PO Jones told him I wanted his story of the events that occurred outside Frickers. He stated "just ask me what you want to know". At that point, PO Jones advised the male of the information he was given by the victim and witness and told him he was placing him under arrest. The male subject stated "ok". PO Jones advised him to turn around and place his hands behind his back. He turned around and put his hands behind his back as requested. As PO Jones pulled out his handcuffs he said "no", and stepped away from him.

The male subject turned and faced the officers on scene and stated " I didn't do anything wrong and I'm not going to jail". PO Jones advised him that the police didn't want any trouble and that if he wants to fight that he can fight the case in court. Officers tried to reason with him more but the

male subject still wouldn't comply with their request. He was told numerous times that he was under arrest and that he just needed to put his hands behind his back so we could get this over with. He stated " I'm not going to the CJC and you're gonna have to take me to the hospital first". PO Jones advised him that if he fought us and injured an officer that he would face more charges. He stated " I don't care, I didn't do anything wrong". He then clenched his fist and stood in a fighting stance.



PO Jones called for additional officers from Mt. Healthy to respond in hopes the male subject would see he was overwhelmingly outnumbered and comply with police. The subject was still in a fighting stance as Mt.

Healthy officers arrived. During this entire time Lt. Petrocelli was trying to calm the subject down by talking to him. After around 10 minutes of negotiating, he allowed Lt. Petrocelli to place him in handcuffs.

Officers, at the subject's request spoke to the manager of Frickers to see if he could keep his truck in their lot rather than police tow it. The manager stated that he could leave it there for tonight. The male subject was transported back to our station

while paperwork was completed. He was charged with assault and resisting arrest and subsequently taken to the justice center. This was the second call in 3 days involving these two individuals fighting at Fricker's.

Robbery (2911.02)

On 07/08/2015 @ 2223 hours, officers were dispatched to the Shell Gas Station (6840 Hamilton Ave) to see a complainant regarding a male black who had assaulted him while trying to "carjack him" / steal his vehicle. The victim told officers that he had parked his vehicle at a gas pump and then entered the business to pay for his fuel. While returning to his vehicle, the victim observed a male black sitting in the driver seat. The victim stated that he ran up to his vehicle and began yelling at the suspect to get out of his vehicle. The suspect, while still inside the vehicle, began wrestling with the victim in an attempt to flee the scene. During the scuffle, the suspect was able to exit the vehicle by pushing the victim backwards, where he pinned him against the gas pump. At one point, the victim stated that the suspect pushed him to the ground and then



advanced towards him where the victim had to push him away so he could regain his footing. After pushing the suspect away from him, the victim fled the scene and was last seen running away on foot east on Galbraith Rd. He was described as wearing a black hoodie, blue jeans and brown work boots.

Officers were searching the area for the suspects and after a few minutes, Lt. Petrocelli observed a male subject matching his description behind the Shell Gas Station. Lt. Petrocelli stopped the suspect and could immediately observe that the subject he had stopped was the suspect involved, due to his clothing matching the exact description given by the victim. The suspect was also observed to be extremely nervous, his heart was racing and he was sweating profusely. Lt. Petrocelli advised him that he wanted him to have a seat in his cruiser while officers investigated the incident. While walking the suspect to his cruiser, Lt. Petrocelli stated that he could feel him tighten up his muscles and immediately begin to look around. It was at that moment that the suspect began to struggle with Lt. Petrocelli in an effort to get away from him. While actively struggling, the suspect was

able to break away from Lt. Petrocelli's grasp and he immediately started running through the parking lot of the Shell Gas Station.

Just as the suspect began running away from Lt. Petrocelli, PO Kodish entered into the parking lot with his cruiser and he observed the suspect actively running across the parking lot.

PO Kodish immediately started chasing the suspect and he was apprehended in the parking lot near the Subway Restaurant.

The suspect was advised of his Miranda Rights and he told officers that he had walked to the Shell Gas Station with his "cousin, Dante" when they noticed the victim's vehicle parked at the gas pump. He continued by telling officers that he thought the vehicle belonged to his "white cousin, Eddie" so he thought it would be a funny prank to climb into the vehicle when "Eddie" returned to it from the store. It was only when the victim ran up to his vehicle that the suspect knew that the vehicle didn't belong to his cousin. The suspect stated that he had no intention of stealing the vehicle or anything else in it and that it was all just a prank he was trying to pull off. The suspect was charged with Robbery,

transported to the police department for processing and then subsequently transported to 2020 without further incident.

Robbery (2911.02)

The victim came to the police station and reported that he was just robbed at gunpoint on Betts Ave. He states that he went to his friend's house on Betts Ave to pick him up and go to the casino with him. He

states that his friend has been friends with him and his family for approximately six

years.

The victim states that after picking his friend up at his house on Betts Ave. they drove one block south and stopped at a sign. Upon stopping at the stop sign his "friend" pulled a black semi-automatic hand gun, pointed it at him and demanded all his money and his cell phone, a white Samsung S5. The victim gave him his money and his cell phone after which, the suspect got out of the car and ran back to his house and went inside.

The victim then responded to the police station to report the incident. Officers from North College Hill and Mount Healthy responded to the residence on Betts Ave. The

residence was surrounded and attempts were made to contact the suspect. There was no response at the door and no phone number attached to the residence for the suspect. A warrant for Robbery was entered on the suspect.

Theft (2913.02)

Officers were called to Walgreens for a theft in progress. Officers were also advised that the theft suspect was a male white approximately 6ft tall wearing a black hooded sweatshirt with a white X on the front of it. Officers were also advised that the suspect left in a silver vehicle in an unknown direction.

Upon PO Buchanan's arrival, he spoke with the store manager, who advised that the suspect in question brought the items up to the register to pay for them. He stated that after the cashier rang the items up and bagged them, the subject grabbed the bags and ran. After further investigation, the manager was able to provide a receipt for the items stolen. He was also able



to show surveillance footage of the subject in question. The manager was advised to contact the PD when and if he was able to make a copy of the footage in question. The total value of the items that was taken was \$144.79.

Criminal Simulation/Carrying Concealed Weapon (2913.32/2913.12)

Officers were dispatched to 1555 W. Galbraith Rd. (Burger King) for a hold up alarm. On the officers arrival, the manager of Burger King was waiting outside and stated a subject in a white SUV at the drive through was attempting to pass a fraudulent \$100.00 bill. Officers pulled up behind the SUV in a traffic stop formation. PO Cole walked up to the driver side and noticed an open container of silver Patron. He did not see the .22 Cal. round at the time because the rear passenger was blocking my site. PO Cole stated to the driver that he used a fraudulent \$100.00 bill to pay for their order. The front seat passenger said they did not know it was fraudulent. PO Cole collected all of the occupant's information and had the vehicle moved away from the drive through.

It was found that the two occupants in the rear seat had warrants. PO Cole approached on the driver side of the vehicle to return their ID's and get the two occupants sitting in the rear passenger seats of the vehicle out to take care of their warrants. As he approached, he noticed a .22 Cal. bullet lying on the rear center seat. PO Cole then drew his weapon, keeping it next to my side. He ordered each occupant out of the vehicle, one at a time and detained them. Officers located the .22 Jennings pistol in a chicken wing box on the rear center seat. Officers also located 3 more fraudulent hundred dollar bills next to the .22 Cal. bullet.



PO Cole asked the four occupants whose gun and fraudulent money it was and none of them would tell him. Officers did find 1 Fraudulent hundred dollar bill in the driver's pocket. The driver and 2 of the passengers were charged with 2923.12 CCW and 2913.32 Criminal Simulation of the Ohio revised code and transported them to Hamilton County Jail. The driver was charged separately for the open container. The 4th occupant was released at the scene as he did

not have easy reach of the weapon or Fraud money.

Criminal Damaging **(2909.06)**

On 7/24/15 at 6:25 AM, PO Smith was dispatched to 6605 Betts Ave to investigate criminal damaging to a motor vehicle. Upon arrival, he made contact with the complainant, who stated that she had parked her 2006 Dodge Charger in front of her residence at approximately 8:30 PM on 7/23/15. She then stated that she walked out to her vehicle at approximately 6:10 AM on 7/24/15 and discovered the damage to the windshield.

A large, 5" diameter crack was present on the windshield. Glass fragments, both outside on the hood, as well as inside the vehicle on the dashboard were also observed. The doors to the vehicle were locked. The complainant advised that none of the property in the vehicle appeared to be missing. No objects(s) consistent with the damage could be located near the vehicle.

Theft (2913.02)

The victim came to our station to report an unknown person or persons entered her unlocked vehicle and removed the listed cell phone without her knowledge or consent. The victim states the ashtray was also removed from the vehicle, as it contained a small amount of coin. The victim has no idea who may be responsible for the incident, and nothing else in the vehicle appears to have been disturbed. The victim states she did not have the GPS locating app activated on the phone, and she has already contacted her cell carrier to have the phone deactivated.

The victim was advised a report would be on file with our department to document the incident as well as the procedure to follow for obtaining a copy of that report.

Theft (2913.02)

Officers were dispatched to Roses for a report of a theft that had just occurred involving a male, black subject in tan pants, white shirt, and black Atlanta hat. The suspect was last seen walking from Roses toward

Family Dollar. Lt. Petrocelli observed a subject matching the description given, walking into Save-A-Lot. PO Lasonczyk also responded and with Lt. Petrocelli, entered Save-A-Lot. Lt. Petrocelli remained by the front door while PO Lasonczyk checked the store for the suspect. PO Lasonczyk located the suspect at the back of the store. It appeared he had several items shoved down the pants. We placed him in custody and walked him to the office, where several items that



were stuck into the pants were removed. The suspect had approximately 9

packages of steaks (taken from Save-A-Lot,) 4 pairs of pants and 1 dress (taken from Roses,) and 3 packages condoms, one of which was still in a plastic case (taken from an unknown store.) The suspect was charged with 2 counts of theft and he was advised he could not return to Roses or Save-A-Lot. The suspect was cited to a court date in the Hamilton County Municipal Court for today's offenses. He was also wanted for theft and OOB out of Springfield Township, who picked him up and transported him to the Justice Center.
