ARRESTS MADE IN NOVEMBER 2015

There were a total of 95 arrests made within the City of North College Hill in NOVEMBER 2015.

54 of the arrests were recite arrests (the person arrested was not physically taken into custody but issued a citation and told to appear in court).

41 of the arrests were physical arrests (the person was physically taken into custody).

Of the total arrests made within the month of NOVEMBER 2015, 51 were residents of North College Hill and 44 were non-residents.


There were a total of **40** auto accidents within the City of North College Hill in NOVEMBER 2015.

2 - of these crashes involved injuries.

33 - of the auto accidents were on public roadways.

3 - of the auto accidents were on private property.

4 - of the auto accidents were Hit/Skip related.



TRAFFIC CITATIONS ISSUED

IN NOVEMBER 2015

The North College Hill Mayor's Court had year-to-date receipts totaling \$126,608.00 as of NOVEMBER 2015.



There were a total of **109** traffic citations issued within the City of North College Hill in NOVEMBER 2015.

52 of the citations were for moving offenses (OVI, Speeding, Fail to Obey a Stop Sign, etc.)

10 of the citations were for non-moving offenses (Expired license plates, not wearing a seatbelt, etc.)

9 of the citations were for parking related offenses (Parked where prohibited by signs, etc.)

38 of the citations were written warnings (the person cited was not required to pay a fine or appear in court).



VEHICLES TOWED OR IMPOUNDED IN NOVEMBER 2015

There were a total of 6 vehicles either towed or impounded within the City of North College Hill in NOVEMBER 2015. (These vehicles were towed or impounded at the request of the police department)



FALSE ALARMS RECEIVED IN NOVEMBER 2015

There were a total of 21 false alarms received that required a response by the North College Hill Police Department in NOVEMBER 2015.

9 of these false alarms were to businesses.



12 of these false alarms were to residences.

349 Total false alarms have been received in 2015.



The following narratives are a small sampling of the various calls for service the North College Hill Police Department routinely receives.

CALLS FOR SERVICE

Aggravated Menacing **(2903.21)**

Officer Six responded to Bobolink Avenue for a report of a person with a gun. Upon arrival, he met with the victim. The victim advised his ex-girlfriend had shown up at his residence in her mother's vehicle and displayed a firearm. He stated she had just been arrested for a Domestic Violence charge and was apparently upset over the incident. Officer Six verified the arrest using the RCIC, in car computer. This also showed a release date of 11-2-2015 or the date of report. According to the victim, after being released, the suspect then



came to his house and started an argument with him. She then said "Oh you locked me up, so now I'm gonna kill you!" As the two continued to argue, she then retrieved a "chrome, .38 revolver" from her motor vehicle. The victim said he then started yelling at her and telling her to leave before he had to defend himself. He then went inside the house, locked the door and called police.

Aggravated **Robbery (2911.01)**

At approximately 1854 hours on 11/2/2015, officers were called to Meis Ave. for an Armed Robbery that had just occurred.

Officers were informed that two black males, wearing Halloween masks, had just committed a robbery at the residence in question and were then last seen running on foot, south bound on Meis Ave. Upon arriving on scene, officers located the victim, who at the time was working on the house.

The victim stated that he is a contractor and that he has been rehabbing the house where this incident occurred. He also advised he was working in the kitchen doing construction work when he was approached from behind by two black males. When he turned around, he immediately saw the 2 suspects walk up to him and that one of them was holding a black colored handgun. One male black was wearing a blue Nike brand jump suit and a Halloween mask, and was approximately six feet tall.

The second male black subject was wearing a black hoodie, black pants, a Halloween mask and was approximately five foot five inches tall. This suspect was reported to be the one who was holding a black handgun, possibly a 9mm or 40 caliber. The suspect wearing all black clothing asked the victim for all of his money but he told the suspect he had no money on him. That suspect, while still aiming the

handgun sideways at the victim, told him to pull out his wallet and open it.

After pulling his wallet out, the suspect then told the victim to pull out the money in his wallet and then demanded him to throw it on the ground between them. The suspect without a firearm reached down and grabbed the money off of the floor. The suspects then fled out the front door of the residence and were last seen running south bound on Meis Ave. The suspects took approximately \$48.00 in U.S. Currency. The area was searched by officers but the suspects were unable to be located.

Burglary (2911.12)



The complainant advised that sometime between 11/07/15 at 2200 hrs and 11/08/15 at 0900 hrs, person(s) unknown, entered her home and removed property without her permission. The complainant left the house on 11/07/15 and when she returned home, she found that her rear window was open and the rear door to the back porch was also open.

Upon looking around the house, she discovered that two tablet PC's,

two flat screen TV's and a Nintendo Wii System was missing. The complainant stated that she has no idea of who would've done this due to the fact that she keeps to herself and does not have much company over. PO Brown also asked if she had renter's insurance and she said that she did not. She did not have any model or serial numbers for the items taken.

PO Brown looked at the rear window from the outside and located what appeared to be latent prints that had been left behind. He lifted the prints and was able to pull two full hand prints from the window. He also looked at the door and did not see anything that would be useable. He advised her that a report would be generated and the prints would be submitted to AFIS and he would contact her as soon as we get anything from the prints. She was also advised to call us if she received any new information or if she finds anything else missing.

Criminal Damaging **(2909.06)**

The complainant advised she had gotten into a verbal argument with her brother while they were at the

McDonald's on Winton Rd. and he threatened her with bodily harm. PO Lasonczyk advised this occurred in Springfield Township and she would need to report that with them. She further explained that he got in her car and refused to get out. She drove to her apartment complex on Daly Rd. and he tried to follow her into her apartment. He again threatened to "beat her ass," and their mother was able to get him out of the building. At that time, he walked out to the complainant's car, kicked the vehicle, got inside and broke several CD's and a pair of sunglasses. He then left in a silver Chevrolet Malibu, which was last seen on Compton Rd.

Theft (2913.02)

On 11/16/2015 @ 1510 hours, a complainant responded to the police department to file a theft report. More specifically, the complainant stated that she was shopping at Rose's Department



Store when someone stole her wallet, which was in the shopping cart she was using. She stated that she had entered the paper products aisle when an older male black walked past her and said hello. She advised that she knew the male subject, only

by the name of Tony and that she has seen him around town before. The complainant stated that she believes that Tony walks around various stores looking for unsuspecting people that he can steal from. It was reported that they only exchanged pleasantries for a brief moment and that Tony continued to walk by her.

It wasn't until the complainant walked up to the checkout counter that she noticed that her wallet was no longer in her shopping cart. She believes Tony was the subject who stole her wallet but since she didn't actually see him steal it, she knows it would be hard to prove it. It was further stated by the complainant that she became increasingly concerned with her wallet being stolen, due to her personal information being inside it at the time of the incident. She stated that she has already contacted her financial institution to have her debit card cancelled.

Burglary (2911.12)

The complainant reported that approximately 0800 hours; she left

her house to take her children to school. She stated when she arrived back home, she unlocked the front door to her house. She stated as she entered the living room she saw her TV set on the floor by the door. She stated she went back out the door, locked the door, and crossed the street. She stated once across the street she called for police to respond.

Upon arrival, Officer Morris went to the west side of the house and found the side door open. He also went to the rear (north) of the house and found an upside down trash can under a window located at the northeast corner of the house. The window was pushed up to allow entry into the house. Officer Morris responded back to the open side door to observe if anyone was going to leave the house.

PO Palmisano made entry into the house to search for any suspects on the first floor. None were found. He notified Officer Morris to come in the side door to search the basement while I searched the upstairs. No one was found in either location.



Officer Morris called and requested a K-9 Unit respond for a track of the suspect. A Cheviot K-9 Officer arrived and started a track. The track left from the side door to the corner of Lois and W. Galbraith where it was lost. The suspect(s) may have left in a parked vehicle.



occurred. When he arrived he talked to an employee of the store. The employee stated that a M/B, who is a minor, wearing a gray hoodie jumped over the counter and took a 1 liter bottle of Remy Martin VSOP alcohol worth \$54.65. Ms. Simpson stated that the M/B ran out into a white 2010 type model Chevrolet Impala that had faded license plates so she was unable to get a plate number.

The complainant stated the TV that was on the floor was the TV that was upstairs in her bedroom. The TV set that was stolen was a 47 to 50 inch LG TV that was sitting on a TV stand in the living room. She stated she did not have the receipt, the TV box, or any other information that contained the serial number of the TV. She also stated as far as she can tell that is the only thing that was taken.

Officer Henn dusted the TV set and the bedroom window for any fingerprints. He did find a couple of smudges that looked fresh; however there were no fingerprint ridges within the smudges to obtain a clear fingerprint.

Theft (2913.02)

PO Wilber was dispatched to Toms Drive Thru for a theft that just

Attempted Breaking & Entering (2911.13)

Complainant advised he was sleeping this morning and sometime about 0430 this morning he was woken by the sound of his dog inside his home barking. He advised he went to look outside and observed two male white people running from his garage. He advised he heard a thump coming from his garage and turned his light on before he looked out the window and saw the two running. He came to the police station and wanted to report the incident to the police for the record. Complainant advised he did not see any attempt forced entry to his garage or his vehicle (that was parked in his driveway). Complainant also advised he did not know of anything missing.

Domestic Violence (2919.25)

On November 22nd, 2015 Officers were called to Save A Lot at 6700 Hamilton Ave. for a Physical Domestic inside the store. Upon arrival, officers came in contact with the victim, who said her daughter's father had hit her and threatened to kill her.

The complainant stated earlier that morning, the suspect was threatening her, saying "He will kill her." She then left the residence at 6525 Betts Ave. and walked to Save A Lot to get away from him. He then followed her to the store. While both were inside the store, the suspect attempted to get the complainant to leave the store. When she refused, he proceeded to hit her in the back of the head multiple times and threatened to kill her again. When she tried to run away again from him, she fell and he chased after her, and tried to pick her up from the floor. At this time store employees noticed what was going on and called Police. The suspect then ran from the store on foot towards Hamilton Ave. and up Sundale. He was then caught nearby by officers.



The victim was checked out by medics for her injuries. She also wanted to pursue charges against the suspect. She was then transported back to her residence.

Menacing (2903.22)

On 11/23/2015 @ 1710 hours, PO Kodish responded to 1924 Knollridge Ln. for a menacing report. Upon arrival, he was met by the complainant's and they advised that they were being harassed and threatened by the female's adult son. More specifically, she stated that her son has a drug addiction (Heroin) and suffers from Bi-Polar. She also stated that he refuses to take any medication for his mental illness. It was reported that the suspect has been battling a drug addiction problem for the last several years and that he only reaches out to his mother when he wants money. The complainant stated that she is a teacher and is unable to answer her phone during the day while she is at work. When she gets off work and checks her phone, there can be numerous missed calls and text messages from her son. He becomes more and more agitated as each phone call or text occurs, as if she is refusing to answer his messages.

The husband, who is the step-father of the suspect, stated that he has received threatening messages as well and that he is the one that the suspect blames when he is unable to reach his mother. It was also reported that the suspect has responded to their residence in the past and has damaged some of their property when they refuse to give him money.

Both complainants requested information on how to file a protection order against the suspect. The necessary information was provided to them and a report was generated for documentation purposes.
