ARRESTS MADE IN JANUARY 2016

There were a total of 104 arrests made within the City of North College Hill in JANUARY 2016.

64 of the arrests were recite arrests (the person arrested was not physically taken into custody but issued a citation and told to appear in court).

40 of the arrests were physical arrests (the person was physically taken into custody).

Of the total arrests made within the month of JANUARY 2016, 42 were residents of North College Hill and 62 were non-residents.

VEHICLE CRASHES REPORTED IN JANUARY 2016


There were a total of 34 auto accidents within the City of North College Hill in JANUARY 2016.

1 - of these crashes involved injuries.

23 - of the auto accidents were on public roadways.

6 - of the auto accidents were on private property.

5 - of the auto accidents were Hit/Skip related.



TRAFFIC CITATIONS ISSUED

IN JANUARY 2016

The North College Hill Mayor's Court had year-to-date receipts totaling \$8,665.00 as of JANUARY 2016.



There were a total of 111 traffic citations issued within the City of North College Hill in JANUARY 2016.

37 of the citations were for moving offenses (OVI, Speeding, Fail to Obey a Stop Sign, etc.)

22 of the citations were for non-moving offenses (Expired license plates, not wearing a seatbelt, etc.)

14 of the citations were for parking related offenses (Parked where prohibited by signs, etc.)

38 of the citations were written warnings (the person cited was not required to pay a fine or appear in court).



VEHICLES TOWED OR IMPOUNDED IN JANUARY 2016

There were a total of 10 vehicles either towed or impounded within the City of North College Hill in JANUARY 2016. (These vehicles were towed or impounded at the request of the police department)



FALSE ALARMS RECEIVED

IN JANUARY 2016

There were a total of 33 false alarms received that required a response by the North College Hill Police Department in JANUARY 2016.

10 of these false alarms were to businesses.



33 of these false alarms were to residences.

33 Total false alarms have been received in 2015.



The following narratives are a small sampling of the various calls for service the North College Hill Police Department routinely receives.

CALLS FOR SERVICE

Burglary (2911.12)

On 1/1/16 at 2:13 AM, PO Smith was dispatched to Bobolink Dr. to meet with a Complainant reference a burglary report. Upon arrival, PO Smith made contact with the Complainant. The Complainant stated that she and her family left the residence at approximately 9:00 PM on 12/31/15, and upon returning home at 2:00 AM on 1/1/16, found the side window to her son's bedroom open. The frame to the inside of the door frame was also damaged.

The Complainant stated that items were removed from the residence. The

items taken were: clothing items, as well as headphones, were removed from her son's room. A computer tablet was removed from a table located in the dining area across from the kitchen. The Complainant stated that all of the doors to the residence were secured prior to leaving on 12/31/15.



The bedroom window, dining area table, and broken door frame were examined for latent finger prints. The perimeter of the property was also inspected, and no signs of entry other than the bedroom window were observed.

Theft (2903.02)

On 01/05/2016, Lt. Maus was called to the North College Hill High School for a theft report. He responded to the main office and was met by the complainant. The complainant reports her daughter, who is a student of the North College Hill High School, was in gym class and an unknown person removed her daughter's cell phone from the student locker room without her permission. The complainant states her daughter's cell phone was underneath her school uniform in the female locker room when the item was taken.

The complainant's older daughter had used the Apple Locate Application to locate the missing cell phone. The cell phone was located to the inner perimeter of the North College Hill High School building. The cell phone was not recovered at the time of the report. The North College Hill Staff made attempts to locate the stolen cell phone with negative result.

On 01/12/2016 at 0925 hours, Lt. Maus was contacted by the North College Hill High School. They advised the stolen cell phone was recovered in the suspects locker, inside a coat pocket. They advised

the victim's parents were at the office and were going to respond to the Police Department after everything was handled at the school.

Burglary (2911.12)

PO Shumate responded to Cordova for the report of a possible burglary. Upon arrival spoke with the complainant, who advised that a M/B juvenile entered his home via the rear kitchen window. When questioned how he knew this information, he indicated he had installed cameras in and around the residence due to ongoing thefts, and break-ins.




The complainant reviewed the video with PO Shumate present, in which at or about 0913 hrs., a subject can be seen at the back door of the residence. A few moments later, the subject pushed up the kitchen window, and crawl through it, into the kitchen. The subject who appeared to be a juvenile, was dressed in dark pants, dark hooded sweat shirt with the number three (3) on the right shoulder, and dark gloves, the subject then proceeds to the basement whereby he removes items prior to returning to the first floor, looking around, then exiting the kitchen area though the back door.

Further investigation revealed that the kitchen window did not appear to be locked at the time of this offense however the screen had been cut and or torn. This house has been burglarized on a number of occasions, and it is not clear if the damage was old or new.

Robbery (2911.02)

On 1/14/16 at 11:47 PM, North College Hill Officers were dispatched to W. Galbraith Rd to investigate a robbery that occurred approximately 10 minutes prior to dispatch. The dispatched narrative stated that the victim was robbed in a parking lot by three males who fled the scene in a silver Dodge Durango.

While enroute to the scene, an additional dispatched narrative advised that the victim, a Domino's Pizza delivery driver, had returned back to the Domino's Pizza on Winton Rd. PO Smith arrived at that location at approximately 11:53 PM, and made contact with the victim. The victim reported the following:



At approximately 11:30 PM, he left Domino's Pizza, enroute W. Galbraith

Rd to deliver an order that was called in at approximately 10:55 PM.

At approximately 11:35 PM, he arrived and attempted to make contact with the customer by phone. A male answered the phone, and the sound of loud music, and several other male voices was heard in the background. The victim called the customer back a second time, and a female answered the phone. No music was playing in the background, and the sounds of other voices were not present.

At approximately 11:40 PM, a young male, black came to the entrance of the building, and gave him approximately \$18 in cash for the pizza. As he attempted to unlock his vehicle, a male, black approached him from the front, right side of the vehicle near a dumpster, and stated, "Give me your money or I'll kill you!". The victim took the \$18 from the recent delivery, placed it on the hood of his car, lowered his head, and rested both of his hands on the hood of the vehicle. The male, black, and two other male suspects ran towards a silver Dodge Durango, which was parked approximately three parking spots north of his vehicle, and fled the parking lot in an unknown direction

Aggravated Menacing **(2903.21)**

A Complainant came to the police station and advised her daughter has been getting threatening text from two other girls from her school (Mt. Healthy Preparatory and Fitness Academy.) The Complainant advised her daughter stated yesterday the text she was getting on her phone were from the two suspects and stated the next time she came to school she would not leave school alive, and they were going to beat her up. The two girls in question advised this was going to happen on Monday if she returned to school then. The complainant advised she does not know what started this threatening behavior. Complainant advised there may be others involved in calling and texting the victim. She advised the others involved may be siblings of the suspects. PO K. Ryan advised the complainant to contact the school on Monday morning to make them aware of the incident and the threats. Complainant also advised she has had contact with the Mt. Healthy Police Department and had spoken to Officer Paul Scott today about the incident.



Criminal Damaging **(2909.06)**

A complainant stated that a subject came to her apartment looking to fight the complainant's daughter. The suspect allegedly had a Taser when she was at the complainant's apartment. The suspect's boyfriend came and got her away from the complainant's apartment and took her back towards her residence. Approximately 30 minutes later, when the complainant went outside, she found that the windshield of her vehicle was shattered. She believes the suspect may have been the subject that broke the window, but she did not see who actually broke the window. I called the complex management company to see if they could view video to see who broke the window. The complainant stated she would like to prosecute whoever is guilty.

Theft of an Auto (2913.02)

Officers were dispatched for a stolen auto report. Upon arrival, PO Miller was greeted by the vehicle owner, who stated that she had left

her vehicle running in front of her house. She stated that she started her car around 0615 hrs., checked on her car 15 minutes later and the vehicle was still present. When she went to leave she noticed that her vehicle was gone. The complainant stated that she is current on her payments and only the driver's mirror has minor damage. An ACB was done by dispatch and the vehicle was entered.

At approximately 1020 hours, PO Palmisano was notified to respond to the area of Witherby Ave., as reported by OnStar, that the vehicle was at this location. OnStar reported that they had locked the engine from being started and/or running. PO Palmisano arrived at the location and did find the stolen vehicle parked on the street. Looking at the vehicle, he saw that there was no exterior damage and the front and rear license plates were missing.

At approximately 1050 hours the owner of the vehicle arrived. She stated the 2nd set of keys to the vehicle was in her storage bin, but she could not get to them. The owner contacted OnStar to have them unlock the doors to gain entry. Once inside the car, PO Palmisano could

tell that it was not gone through by the suspect. He found money and credit cards in the center counsel, a check book in a compartment adjacent to the steering wheel and CD's in the doors and other areas inside the car. The victim stated that nothing in the car was disturbed. She checked the trunk and all items were still inside.

PO Palmisano checked the car for the car keys, which were not located. He also checked the area in the event the license plates and keys were tossed away. They were not located. He also checked areas to see if fingerprints could be obtained. The chrome part of the gear shift was smooth and looked clean. Other areas, such as the steering wheel and door frame were of rough texture and unable to fingerprint.

The victim contacted OnStar to have roadside assistance come by to tow the vehicle to her house. The victim was also advised to stop at the PD to get a copy of the report to take to DMV to be issued license plates.



Disorderly Conduct (2917.11)

Officers were dispatched to investigate for an assault which had just occurred on the lot of Kroger's. Upon arrival, Lt. Petrocelli found the victim sitting in a parked mini-van at the eastern stop sign in the main lane of travel in front of the store. He stated that he was driving up to the stop sign when he heard someone yelling at him about "Almost running me over". He looked around and observed a male white subject with gray hair walking up next to the driver's side of his van. While walking next to the van, the victim states that the subject began slapping his hand on the windows and continued yelling at him.

The victim states that he came to a stop and got out of the car to see what the subject wanted. He stated that as he approached the subject, that the subject "slapped the shit out of me". Lt. Petrocelli asked him what he meant by that and he stated that, "He smacked in the head right here". He indicated that he was struck on the upper left forehead area near his hairline. The subject then walked away and entered the store.



While on scene, several independent witnesses approached officers to describe what happened. They all stated that a white male with gray hair approached the mini-van yelling at the driver and slapping the windows. They stated that the driver stopped quickly, exited the van and approached the subject. As he did so the witnesses stated that the subject knocked the driver's hat off his head, then departed and entered the store.

While speaking to the witnesses a white male subject with salt and pepper colored hair approached officers and stated that he was involved in the incident that officers were probably investigating. When asked what happened, the subject stated that he was walking in the parking lot

when the driver of the mini-van narrowly missed hitting him with the vehicle. He states that he yelled at the driver, and was just ignored. He stated that he then approached the vehicle and started to knock on the windows to get the drivers attention. He states that as he did so the driver stopped quickly, jumped out of the van and quickly approached him in an aggressive manner. He stated that as the driver approached him he reached out and knocked his hat off, which startled the driver and he stopped his approach. He states that

he yelled at the driver and entered the store.

The subject stated that he conducted his business in the store and was leaving the parking lot. He states that when he saw the police cars in the lot, he believed they were investigating the incident he was involved in and returned to the scene to impart his side of the story.

The victim was adamant that he wanted the suspect arrested immediately for assault. Based on the stories of the involved parties and the

independent witnesses who all stated that the suspect knocked the driver's hat off his head, (they did not say that the suspect struck the driver in head when knocking his hat off,) Lt. Petrocelli was unable to verify that an assault had occurred. The suspect was issued a Disorderly Conduct Citation and released from the scene.
