ARRESTS MADE IN APRIL 2016

There were a total of 73 arrests made within the City of North College Hill in APRIL 2016.

31 of the arrests were recite arrests (the person arrested was not physically taken into custody but issued a citation and told to appear in court).

42 of the arrests were physical arrests (the person was physically taken into custody).

Of the total arrests made within the month of APRIL 2016, 33 were residents of North College Hill and 40 were non-residents.

VEHICLE CRASHES REPORTED IN APRIL 2016


There were a total of 29 auto accidents within the City of North College Hill in APRIL 2016.

5 - of these crashes involved injuries.

22 - of the auto accidents were on public roadways.

2 - of the auto accidents were on private property.

5 - of the auto accidents were Hit/Skip related.



TRAFFIC CITATIONS ISSUED

IN APRIL 2016

The North College Hill Mayor's Court had year-to-date receipts totaling \$50,898.00 as of APRIL 2016.



There were a total of **97** traffic citations issued within the City of North College Hill in APRIL 2016.

32 of the citations were for moving offenses (OVI, Speeding, Fail to Obey a Stop Sign, etc.)

18 of the citations were for non-moving offenses (Expired license plates, not wearing a seatbelt, etc.)

14 of the citations were for parking related offenses (Parked where prohibited by signs, etc.)

33 of the citations were written warnings (the person cited was not required to pay a fine or appear in court).



VEHICLES TOWED OR IMPOUNDED

IN APRIL 2016

There were a total of 6 vehicles either towed or impounded within the City of North College Hill in APRIL 2016. (These vehicles were towed or impounded at the request of the police department)



FALSE ALARMS RECEIVED

IN APRIL 2016

There were a total of 28 false alarms received that required a response by the North College Hill Police Department in APRIL 2016.

3 of these false alarms were to businesses.



25 of these false alarms were to residences.

114 Total false alarms have been received in 2016.



The following narratives are a small sampling of the various calls for service the North College Hill Police Department routinely receives.

CALLS FOR SERVICE

Aggravated Menacing **(2903.21)**

Officer Six walked into the PD and noticed a woman standing at the front window. The woman identified herself and stated she needed to report being harassed. The victim stated she tried to rent a room of her apartment to an unknown party and is now receiving threatening messages. The victim stated she had placed an ad on Craigslist for a roommate. The victim was contacted by the unknown party and met with her later that day. The victim then stated she had the person's number but could not remember the

girl's name. She described as a heavy set f/b. The victim provided the suspects phone number. When Officer Six called the suspect's number, it went to voice mail. The voice mail stated to leave a message, but no message was left.

The victim's phone was running low on battery, however, Officer Six did observe several threatening message on the phone. The messages were very descriptive and stated they would kill the victim. There were a large amount of text messages on the phone. The victim did not have a charging cord so officers could not access the phone to download the

text messages. The victim was informed to call police if the action continued or if the suspect returned to the residence. The victim stated she would not stay at her residence tonight, as the messages said the suspect would come there tonight and kill her.

Theft (2913.02)

On 04/06/2016, a complainant responded to the police department to file a theft report. More specifically, the complainant stated that on 04/03/2016 around 1620 hours, he was at Kroger (7132 Hamilton Ave) at one of the self-checkout terminals.

He stated that after he had purchased his grocery items, he exited the store and headed home. It wasn't until he arrived at his residence that he discovered that he had possibly lost his wallet. The complainant stated that he retraced his steps that day in hopes of locating his wallet. After a while, he concluded that he must have left it at the Kroger store in NCH.

The complainant stated that he contacted Kroger to see if they had found his brown leather wallet which contained \$900.00 in US Currency, as well as multiple credit and debit

bank cards. The employees checked their lost and found section but the wallet was not there. The complainant advised that he was put in touch with one of the store managers. The manager checked the surveillance cameras on the date and time given by the complainant.

After reviewing the surveillance footage, the complainant was advised by the manager that the camera footage depicted the complainant accidentally leaving his wallet at the self-checkout terminal. It also

showed that when he walked away towards the exit, a female in a red outfit, immediately walked up to the checkout terminal and grabbed the complainant's wallet and placed it in her purse.

After placing the wallet in her purse, the female subject concluded her transaction at that checkout terminal and then exited the store.

The manager continued to advise the complainant that he watched the female suspect on the camera exit the store and then climb into a vehicle, which was parked in the parking lot of Kroger. The manager also stated that the license plate on the suspect's vehicle was unreadable from the cameras but that he would check to see if he could find the exact



time the suspect arrived at the store, before the theft offense.

Assault (2903.13)

Officer Six responded to NCHPD for an assault victim who was now on station. The 12 year old victim was accompanied by his mother, stated he has an ongoing issue with a school mate, who is also 12 years old. On today 4-8-16, the suspect confronted the victim at lunch and tried to engage him in a fight. The suspect then confronted the victim outside after school as he exited near the old gym. This action was interrupted by a teacher. The victim and suspect separated with the suspect heading toward the buses and the victim heading toward Bising Avenue.

Once the victim was in the area of Bising and Hamilton he saw the suspect reemerge behind him. After the suspect spotted the victim, the suspect started to run toward the victim. The victim and his brother saw the suspect advancing and attempted to run away. The victim and his brother became separated shortly after. The victim then crosses Hamilton Avenue, continuing east toward his residence. The suspect continued to pursue and



caught up with the victim. The suspect then started yelling repeatedly "You wanna fight?!" The victim stated he did not want to fight asked the suspect "what did I do to you?" The suspect continued to yell "You wanna fight?! You wann fight?!", at the victim.

The suspect then punched the victim in the chest. The victim stated he did not react to this as he wanted to leave and feared getting into trouble. The victim then described being blocked or surrounded by four other suspects. The victim stated he felt as though he could not leave freely. The victim went on to say he felt as though the group may jump him and believed he needed to engage in a physical confrontation in order to leave. The victim then struck the suspect in the face. At this point the two began to actively fight. During the process the victim finds himself on the ground. The suspect is stands over the victim

then jumps on top of him and continues to punch the victim. The victim attempted to defend himself by blocking and striking the suspect. At some point, the victim wound up on top of the suspect. The victim chose not strike the suspect and instead, just holds the suspect's arms down so

he could not be hurt. While on top of the suspect, an additional suspect struck the victim in the nose. A passing bystander saw this activity and attempted to intervene. The bystander was eventually able to break up the fight. The victim then walked home, spoke with his mother, who took him to NCHPD to file the report.

Breaking & Entering **(2911.13)**

Officers were dispatched to Lake Nina Restaurant for an intrusion alarm with interior motion. Upon arrival the side glass door was found broken out. The building was searched and a piece of concrete was located inside near the door that was broken. A perimeter was established using outside agencies and a police K9 was called to the scene. The dog tracked through from the business over to the area of Lincoln and Eiler.

While the dog was tracking the business owner arrived and was able to review the video cameras. Based on the footage, the suspect is a male white, wearing a dark colored hoodie and jeans. He was seen breaking the side door window with the located



piece of concrete. He then entered the restaurant and removed change from the open register and 3 bottles of Triple Sec from underneath the counter before exiting back out the door.

The K9 tracked to 2143 Garfield where it located the suspect's black hoodie in the grass area across from that address. The hoodie that was located matched to the hoodie that the suspect was wearing during the offense according to the surveillance video. The hoodie was photographed and collected to be submitted for possible DNA.

The K9 called the track in the woods in the rear of Lincoln Ave near Eiler.

Disorderly **Conduct/Resisting** **Arrest** **(2917.11/2921.33)**

While working on-site at the North College Hill City Schools as a school resource officer, PO Manning was called to the office for a fight in progress. Upon arrival, he found Mr. Mahaffey, Ms. Brinkley, and Ms. Johnson attempting to restrain a student. The student was screaming, hollering, cursing and physically trying to get away from the three school

staff members. They were repeatedly telling him to calm down, and reminding him of the college option he was letting slip away, and to stop his actions. He verbally and physically refused by pushing and swinging his arms around. PO Manning then told him multiple times to calm down and stop his behavior, whereby he replied "fuck you" and not to "touch me."

After another short verbal attempt to get him to calm down, he did not comply. PO Manning then placed him into an escort hold and told him he was under arrest, he

immediately pulled away from me and attempted to turn into PO Manning. His interpretation of the suspect's response was that he was going to strike me. PO Manning transitioned to an arm bar and placed the student against the filing cabinets in order to gain control of him. PO Manning was able to get the right handcuff on his wrist. He continued to pull away, not giving him his left hand. PO Manning manipulated his right ulnar nerve, and with an assist from Mr. Mahaffey was finally able to get the handcuff onto his left hand.

He continued to be combative by pulling away and pushing us, he continued to rise up, push against PO

Manning, scream and refused all requests to stop his behavior. PO Manning placed him on the ground in a seated position in order to gain some control of him. PO Manning held him on the ground by applying pressure to his shoulder in the brachial plexus origin area. PO Manning was continually telling him to calm down and stop his behavior. After a short amount of time PO

Manning allowed him to get up and had to physically escort him out to his vehicle, with him both passively and actively resisting the whole way out to the car. He was placed into

a police vehicle, transported to the station where he continued to be verbally abusive. He was transported to 2020 with no further issue.



Discharge Firearm into Habitation (2923.161)

Officers were dispatched for shots fired. Upon arrival Lt. Maus was met in the front yard by the victim. The victim stated he and some friends and family were sitting on the front porch when unknown person(s) fired shots at them. The victim stated a black motor vehicle with heavy tinted windows, possibly a Dodge Charger or Magnum pulled down the street

and into the circle east of his residence. The victim stated the motor vehicle turned in the circle and then drove west past his residence when the front passenger began to fire multiple shots out the window at his residence. The victim stated everyone on the porch laid on the porch behind the brick walls to seek protection from the gun fire. The victim stated he was not able to obtain a license plate or more of a description of the motor vehicle. The victim believes the suspect may have been his old neighbor as he had problems with them in the past, causing him to move to this residence in North College Hill.

The scene was searched and no rounds appeared to have struck the residence as there was no physical evidence observed on the residence. There were 14 spent .40 caliber shell casings located in the street in front of the victim's residence. The rounds were located in the middle of the street and close to the north curb area. It is believed the suspect(s) fired the rounds in the air as there

were no markings in the residence indicating the structure to have been struck. The spent shell casings were collected and submitted to the property room as evidence.

Burglary (2911.12)

A resident arrived home, just prior to calling the police, and found the residence had been broken in to. She advised this has happened in the past and she arrived home, just as she did this time, after not spending the night there, to find the home was broken in to. Complainant advised she believes the break-ins are from friends of her son who have knowledge of the residence and know when someone is home and when they are gone. She believes the person or people are

possibly looking for something in the residence but she advised she did not know of anything there that is of value. She

advised she made entry into the

residence and found the door to the basement kicked open and broken. She stated she went back outside and called the police.



When PO K. Ryan arrived on scene and met with the complainant, they searched the residence and found clothing thrown on the floor and a mess made of the property in the residence. They also found the kitchen with broken glasses from the cabinet thrown on the floor and the refrigerator door open. They also found property in the basement that was messed up and thrown on the floor including furniture and clothing.

Complainant advised she is working on moving out and plans to be out of the residence within the next thirty days. She also advised she believes her son is involved due to him having charges on him pending for assault or domestic violence on her other sons, for shooting them both in the face with a BB gun. At this time she advised she is not planning on staying at the residence and asked for police to check on it if possible.

Soliciting Contributions From Vehicle Occupant (4511.51)

Officer K. Ryan observed a subject standing in the area of the ramp from East bound Ronald Regan Hwy. to



Hamilton Ave. with a sign that read "Sober veteran needs help. I have no family; laid off from work. Please help if you can. Anything helps! Bless you". PO Ryan has advised the defendant several times in the past to stop panhandling. PO Ryan stopped him on Hamilton Ave and found he had warrants for what he explained to be for panhandling from Colerain Township. He was transported to the North College Hill Police

Station and served a ticket for Panhandling and recited for the open warrants. He was released from the NCHL police station and advised not to continue panhandling.

Criminal Mischief (2909.07)

On 4/26/16 at 6:49 am, PO Smith was dispatched to Parrish Ave to investigate damage to a motor vehicle. Upon arrival, he made contact with the complainant. The complainant stated that she parked her company vehicle, a 2004 Crown Victoria taxi in front of her residence on 4/25/16 at approximately 8:00 PM. The complainant then stated that she walked outside on 4/26/16 at approximately 6:45 am and discovered the vehicle had been covered with a white, liquid

substance. A bottle of hand lotion was observed in the grass near the curb where the vehicle was parked. The liquid was present on the roof, front windshield, and left side of the vehicle.

The complainant stated that a possible suspect was female, approximately 24 years of age, who resides in Northside. The complainant stated that the suspect made threats of physical violence towards her recently while in Alabama. The complainant also stated that the suspect has been sending messages on Face book stated that something was going to happen to her.



Later in the day, the vehicle was observed by officers from the Springfield Township Police Department in the area of North Bend and Edwood Ave. Officers went to stop the vehicle and the vehicle fled to the area of North Bend Rd. near the library, near Lantana Ave. The suspect driving the vehicle fled from the vehicle and was apprehended a short distance from the stopped vehicle. The vehicle then rolled, driverless, to a stop on the other side of North Bend Rd. the vehicle did not strike anything. The vehicle was released to the owner and then removed from the computer.

Theft of an Auto (2913.02)

A complainant reported that her boyfriend's 2001 Lexus ES300, black in color, was taken from her driveway, as it was unlocked and running. She states that she saw it drive away in an eastbound direction on DeArmand Ave. and was being operated by possibly a male white wearing a red shirt. The vehicle will be entered into RCIC and a report will be generated.

A short time later the owner of the vehicle called PO Ryan back and advised the vehicle transmission was not operating correctly and wanted the information for the suspect arrested by Springfield Township Police. PO Ryan advised him the report with the information would be available at a later time and to contact the NCHL police. PO Ryan also advised him the Springfield Township Police would be in contact with him about court for the unauthorized use of the vehicle.
