ARRESTS MADE IN JUNE 2016

There were a total of **105** arrests made within the City of North College Hill in JUNE 2016.

43 of the arrests were recite arrests (the person arrested was not physically taken into custody but issued a citation and told to appear in court).

62 of the arrests were physical arrests (the person was physically taken into custody).

Of the total arrests made within the month of JUNE 2016, **48** were residents of North College Hill and **57** were non-residents.

IN JUNE 2016


There were a total of 39 auto accidents within the City of North College Hill in JUNE 2016.

7 - of these crashes involved injuries.

25 - of the auto accidents were on public roadways.

8 - of the auto accidents were on private property.

6 - of the auto accidents were Hit/Skip related.



TRAFFIC CITATIONS ISSUED

IN JUNE 2016

The North College Hill Mayor's Court had year-to-date receipts totaling \$70,357.00 as of JUNE 2016.



There were a total of 157 traffic citations issued within the City of North College Hill in JUNE 2016.

80 of the citations were for moving offenses (OVI, Speeding, Fail to Obey a Stop Sign, etc.)

26 of the citations were for non-moving offenses (Expired license plates, not wearing a seatbelt, etc.)

14 of the citations were for parking related offenses (Parked where prohibited by signs, etc.)

37 of the citations were written warnings (the person cited was not required to pay a fine or appear in court).



VEHICLES TOWED OR IMPOUNDED

IN JUNE 2016

There were a total of 3 vehicles either towed or impounded within the City of North College Hill in JUNE 2016. (These vehicles were towed or impounded at the request of the police department)



FALSE ALARMS RECEIVED

IN JUNE 2016

There were a total of 27 false alarms received that required a response by the North College Hill Police Department in JUNE 2016.

13 of these false alarms were to businesses.



14 of these false alarms were to residences.

163 Total false alarms have been received in 2016.



The following narratives are a small sampling of the various calls for service the North College Hill Police Department routinely receives.

CALLS FOR SERVICE

Theft (2913.02)

On June 6, 2016, PO Kilgore was called to the lot of Kroger, 7132 Hamilton Ave., to meet a complainant reference her purse being stolen the previous Saturday. When he arrived, he met with the complainant, who stated around 11:30AM on June 4th, she was placing groceries in her vehicle. When she looked back she noticed her purse was missing.

The complainant believes her purse was taken when she was placing her groceries in her vehicle. The purse is described as a tan and black Coach purse. The purse



contained her wallet that had her social security card, debit card, and \$394.00 in cash. She also stated she had a broken gold watch in the purse (Unknown value). PO Kilgore did advise the complainant to contact her bank to block her bank cards.

Criminal Damaging **(2909.06)**

On 06/09/2016 @ 1912 hours, officers were dispatched to the Autozone (6750 Hamilton Ave) for a fight in progress involving two (2) older male blacks. As officers were responding to the scene, they were updated that one of the male subjects involved had

brandished a knife and had just left in a blue colored minivan. PO Elston spotted the minivan in question heading west bound on Goodman Ave and he initiated a traffic stop with that vehicle at the intersection of Goodman Ave & Savannah Ave. The male subject in the vehicle was identified and PO Elston located the alleged knife involved in the altercation, inside the vehicle and it was taken for safekeeping while officers sorted out what had occurred at Autozone.

The male subject in the van advised officers that he, his girlfriend, and a couple of kids had responded to Autozone for a quick moment. As they entered the store, it was reported that another male black subject had made a comment about the girlfriend's hair and how nice it was. After the male subject made that particular comment, the suspect and that male subject began arguing with each other. The suspect stated that the altercation was only verbal in nature and that it did not become physical nor did he ever brandish his knife. He stated that the knife remained in his pocket the entire time.

The female agreed with the suspect's story of what had occurred.

Other officers responded to Autozone and were unable to locate the other male subject involved in the altercation. Officers were however, flagged down by a female in the parking lot who stated to officers that the other male subject involved was a friend of hers and that he had already left the area by jumping on a Metro bus. The witness was unable to recall her "friend's" name and stated that she has only known him for a short time. She continued by advising officers that she had entered the store with her male friend and that he did in fact make a comment / compliment about the other female's

hair and how nice it was. The witness continued by stating that after her friend made the comment

she noticed that suspect was becoming increasingly agitated. She stated that when they started to leave the store, her friend tried to shake suspect's hand but the suspect refused to do so, which caused both male subjects to get into each other's faces. An employee of Autozone attempted to diffuse the situation by telling both male subjects to stop arguing and for them to leave the store.

The situation escalated with both male subjects engaging in a physical altercation that carried outside of the



store and into the parking lot. The witness stated that the suspect kept trying to fight her friend and that was when the fight started. He immediately brandished his knife and stated that he would cut her friend's neck. She further stated that while the male subjects were fighting, it carried over towards where her vehicle was parked. She stated that as the fight continued and was next to her vehicle, she observed suspect punch / strike the passenger side mirror of her vehicle which immediately broke.



Unauthorized Use of a Vehicle (2913.03)

The complainant reported that a known subject had completed some work on his car and he was testing the car. The complainant stated the other subject took the car out at approximately 1700 hours, 6-9-16, and had not returned the car. He also stated he tried calling him several times and the subject had not returned his call.

The complainant stated he wanted to file an auto theft report. PO Palmisano explained to him that since he let the other subject use the car, he had 48 hours to return the car

before it can be filed as a stolen car. PO Palmisano advised him he could take an Unauthorized Use report, and that if the car is not returned by 1700 hours, on 6-11-16, it can be entered in as an auto theft.

While PO Palmisano was obtaining information from the complainant, the other subject called the complainant on his cell phone. The complainant told him he wanted his car back and that he was talking to the Police. PO Palmisano asked to speak to the subject. He informed the subject that he was here taking a report on the car. The subject stated he was on the way to drop the car off. PO Palmisano advised the subject that he needs to have the car back by 1400 hours. He stated he was going to call the complainant back to let him know where they can meet to drop the car off.

Possession of Drug Paraphernalia (2925.14)

Officers received a phone call that a F/W, wearing a black tank top, pink shorts, and carrying a orange bag, was walking south on Hamilton Ave. The caller stated she had open


warrants out on her and she had drugs in her possession.

The suspect was located at 7000 Hamilton across from St. Paul's Church. She was stopped and asked her name, and she identified herself. When asked if she had any ID she stated "No." She was asked if she knew if she had warrants out for her arrest. She stated "Yes." She was asked if she had anything in her possession that she should not have. She stated she had needles in her bag that was given to her by the guy she was with. PO Palmisano informed her that since she had the drug instruments in her possession she would be charged. He transported her to the station.

At the station warrants were confirmed through Hamilton County and Butler County. She was recited on the Hamilton County warrants and advised to turn herself into Butler County. She was also issued a court date for the possession of the drug instruments.

Robbery (2911.02)

PO Manning was dispatched to North Bend Rd. @ Sunridge for an individual that was reporting a robbery that had occurred in NCH. Upon arrival, PO Manning found the victim, who stated that he was making a drug deal of marijuana to an individual wearing red pants, black t-shirt, carrying a white bag with money, weed and a red Nintendo DS system. The victim knew the suspect and



picked him up at our McShell, 6840 Hamilton Av. and drove him to the end of Shamrock Av. When they reached Shamrock, the suspect pulled a gun on the victim and stated to him to "Give me everything." He left with the victim's vehicle, marijuana and \$200.00. The victim's phone was left in the vehicle, and it was subsequently tracked to 4655 Hamilton Av. where Cincinnati Police found the vehicle.

PO Manning went to Sunridge @ North Bend and picked up the victim and transported him to 4655 Hamilton Av. to recover the vehicle. During the investigation, the suspect walked by PO Manning's police vehicle and was

identified by the victim as the offender. The suspect was detained, and on his person was a white bag containing a Nintendo DS, \$7.00 US currency, 2 baggies of weed, a scale and other miscellaneous items. He stated that he and the victim were "boys" and that he was the one selling weed and the victim got mad during the deal.

Burglary (2911.12)

On June 26, 2016 officers were called to Acorn Dr. for a burglary that had occurred. When PO Kilgore arrived, he came in contact with the victim. She stated she left her house that morning to go to church and returned home around 2:00 PM. She said she walked into her kitchen and noticed the window over her sink, facing the rear of the residence had been opened. She then went back outside and called 911.

PO Kilgore did check the residence and did not locate anyone. He did see the window over the sink in the kitchen was open about an inch. The complainant did walk through the house to gather an inventory of her belongings, after PO Kilgore had cleared it. Upon search we did find

a basement window had been broken out where the suspect(s) had gotten through and also may exited.

After searching through the residence with the complainant, the only items that were missing were 3 sterling silver rings with costume jewelry worth approximately \$150.00. Also missing was a gold neckless with a saying "Child of God," worth approximately \$100.00. These items were last seen on her dresser in her bedroom towards the south east of the house. The complainant was advised if she finds anything else missing or any more information to call the department. PO Kilgore also advised her he will follow up with her in the next week or two.

SCAM ALERT

Theft/2913.02

A complainant stated he received a phone call from a person who stated they worked for Government Grants. They were calling people in our area to apply for an \$8,000 Government Grant with a low interest rate. He stated they called from phone number 360-746-3304. The caller instructed the victim to go to Walgreens and put



\$250 on an iTunes card to pay for the fees to obtain the \$8,000. The caller stated once they receive the \$250 dollars, he will be given a phone number to PNC Bank to call and obtain a PIN number to get the \$8,000.

The victim stated he followed the instructions. He stated he was given a phone number, to PNC Bank, 646-535-5997, ext 250. He stated after he hung up, he called the phone number several times. He stated he never talked to anyone. An answering machine came on each time stating leave a message for Sam.

PO Palmisano advised the victim that this is a telephone scam that is used to obtain money from unsuspected people. He informed him so that he can go on line to obtain information of scam artist. PO Palmisano advised him on what precautions he can take so that this does not occur again. PO Palmisano also advised him that a notice will be sent out on NCH Facebook warning others of the telephone scam.

Vandalism (2909.05)

On 062816, PO Brown responded to Lifespring Church for a report of mail tampering and damage done to a card reader. The complainant stated that they found 3 pieces of mail ripped in half and a door access card reader had been pulled from its mounting.

The complainant advised that this occurred on Sunday, 06/26/16 at around 1818 hrs. The complainant states that a small female juvenile was seen on camera coming from the area of the mail box, then seen minutes later, accompanied by another female juvenile and male juvenile.



At the time the three juveniles were observed, it appeared that they were trying to get in the building and trying to call for someone inside. It was at that time that the female juvenile pulled on the card reader from the mount. She was also seen pushing the call button and looking in the doors. The complainant advised that he will follow up with the USPS and continue to monitor the area, hoping it was an isolated incident. For now, the complainant is not wishing to pursue this matter criminally.
