ARRESTS MADE IN OCTOBER 2016

There were a total of 65 arrests made within the City of North College Hill in OCTOBER 2016.

40 of the arrests were recite arrests (the person arrested was not physically taken into custody but issued a citation and told to appear in court).

25 of the arrests were physical arrests (the person was physically taken into custody).

Of the total arrests made within the month of OCTOBER 2016, 27 were residents of North College Hill and 38 were non-residents.


There were a total of 34 auto accidents within the City of North College Hill in OCTOBER 2016.

3 - of these crashes involved injuries.

22 - of the auto accidents were on public roadways.

6 - of the auto accidents were on private property.

6 - of the auto accidents were Hit/Skip related.



TRAFFIC CITATIONS ISSUED

IN OCTOBER 2016

The North College Hill Mayor's Court had year-to-date receipts totaling \$103,902.00 as of OCTOBER 2016.



There were a total of 96 traffic citations issued within the City of North College Hill in OCTOBER 2016.

39 of the citations were for moving offenses (OVI, Speeding, Fail to Obey a Stop Sign, etc.)

16 of the citations were for non-moving offenses (Expired license plates, not wearing a seatbelt, etc.)

12 of the citations were for parking related offenses (Parked where prohibited by signs, etc.)

29 of the citations were written warnings (the person cited was not required to pay a fine or appear in court).



VEHICLES TOWED OR IMPOUNDED IN OCTOBER 2016

There were a total of 1 vehicles either towed or impounded within the City of North College Hill in OCTOBER 2016. (These vehicles were towed or impounded at the request of the police department)



FALSE ALARMS RECEIVED IN OCTOBER 2016

There were a total of 30 false alarms received that required a response by the North College Hill Police Department in OCTOBER 2016.

10 of these false alarms were to businesses.



20 of these false alarms were to residences.

275 Total false alarms have been received in 2016.



The following narratives are a small sampling of the various calls for service the North College Hill Police Department routinely receives.

CALLS FOR SERVICE

Obstructing Official Business (2921.31)

Officers were dispatched to Walgreens for a report of a male black, wearing a black hoodie, black sweat pants and a black ball cap, who was running on foot towards Fricker's, after being approached by the manager. It was advised that the subject was last seen with a purple box that was selected from the shelf in the store.

After speaking with the manager, it is unknown what he took, but it was something purple, that he did not have when he came in. The manager advised that he would review the



camera footage to find out what it was. Officer Ryan was able to locate the subject on Hamilton Ave. @ Teakwood Dr. The subject was transported back to Walgreens and was positively identified by the manager. Although the item believed to have been taken was not found, nor identified, the subject was found to have given false information to officers by giving the name and social security number of his brother. Once his real identity was discovered, he was found to have been trespassed from Walgreens in 2011.

In addition to the Criminal trespass and the Obstructing Official Business, a silver

pipe with chore boy and a digital scale was found in his left and right front pockets. Subsequently, the subject was charged with OOB, Criminal Trespass, Drug Paraphernalia and drug Instrument possession and transported to CJC.

Criminal Damaging **(2909.06)**

The victim stated that he had recently purchased new tires for his 1999 Chevrolet Tahoe. He stated that the vehicle was legally parked and all the tires were observed to be inflated on Friday morning at 0300 when he returned from work. Upon checking the vehicle later that day at approximately noon, he found the right side rear tire to be flat.

On 10/8/16, at approximately 1000 hours he attempted to repair the tire and found the tire to be vandalized. The tire had sustained a puncture approximately 3/4 of an inch wide in the sidewall of the tire. It appears that a knife or other sharp object was plunged into the sidewall of the tire.

The victim recently had an anonymous complaint lodged against him for having too many vehicles parked on the street. The complaint

presumably came from a neighbor. At the time of this report it is unknown if this complaint is related to the damage caused.

Theft (2913.02)

On 10/19/16 at around 1030 hrs, PO Brown was dispatched to Dollar General for a theft that had just occurred. The suspect, a male black, heavy set, wearing grey sweat pants, orange shirt and a black hooded jacket, left the store with several items including laundry detergent. It was advised that the male drove away in a blue Hyundai vehicle and travelled north on Hamilton Ave. After running a query on that plate, it was found to come back on a 1978 GMC Pickup Truck out of Columbus, Ohio.

Upon arrival at the store, PO Brown spoke with the acting manager, who advised that the suspect was seen by his employee, walking out the front door with a cart of items not paid for. The manager quickly reviewed the surveillance footage and found that the subject selected 3 boxes of "Gain" dryer sheets at \$2.00 each, 6 containers of "Gain" laundry detergent at \$14.95



each and 2 containers of "Tide with Downy" laundry detergent at \$9.95, placed it in a cart and walked out of the front door when there were no employees at the register. The total cost of the items taken was \$123.69.

The manager supplied the correct license plate of the suspect vehicle. That plate when queried came back to an address on in Harrison, Ohio. Whitewater Twp. units were given that information by the communications center to BOLO for that vehicle, driven by that described suspect.

Assault (2903.13)

On October 12, 2016, PO Kilgore responded to W. Galbraith for an assault that occurred. When he arrived, he came in contact with the victim, who stated she had been assaulted by a known subject that lives in the apartment.


The victim stated she had left the apartment complex earlier when her neighbor told her she would fight her and made other verbal threats. When the victim returned a short time later, the suspect went outside and struck victim in the face and then continued to attempt to fight the victim. That is when the victim called police. The victim's brother was

with her at the time of incident and recorded the incident involving her sister and the suspect on his cell phone. The video does show the suspect approaching the victim and striking her in the face.

PO Kilgore did speak to the suspect and she did admit to him that she had struck the victim. The suspect stated she struck the victim due to past encounters she has had with the victim and her son when they pulled a gun on her. The suspect was then arrested and charged with Assault.

Aggravated Robbery(2911.01)

On October 14, 2016, PO Kilgore was called to the North College Hill Police Station for a robbery that had occurred earlier that day. He spoke to



the juvenile victim and the victim's mother. The mother stated her son was robbed of \$40 U.S. dollars by an unknown suspect that was armed with a hand gun. When PO

Kilgore questioned the victim he stated the subject was unknown to him and had showed him a silver hand gun by lifting his shirt.

The victim stated he was walking south bound on Meis Ave. going home from the Dollar General on Hamilton Ave, when the two friends with him saw a person in a gold Chevy that drove past them. The victim looked at the suspect thinking it was someone he may know and with whom he has had problems. At that time, the gold vehicle stopped and the suspect got out and began to yell at the Juveniles. He showed them an ID in his wallet and said "I have a license to kill!" The unknown suspect then pulled a silver handgun out of his waist band and showed it to the victim and his 2 friends, saying "I feel staring at me is a threat". The suspect then began feeling the victim's pockets looking for something when the victim said officers pulled up. Lt. Petrocelli and PO Kilgore did speak to the victim and the suspect. The suspect in question stated to officers everything was fine and they were all family. The victim then said he did not tell officers that the suspect had pulled a gun on him and also stated the suspect told him to "play it cool or I will tell them you tried to rob me". The victim then got into the gold vehicle with the suspect, the suspects child, and the suspects child's mother who

was operating the vehicle. They then drove down the road where the suspect told him he would need something for giving him problems. That is when the suspect took the \$40 dollars and let the victim go.

Officers did receive a BOLO call for a gold colored Chevy Malibu driving south on Savannah Ave. with a male black, short, dark colored jacket armed with two hand guns. PO Kilgore was able to get a plate number of the suspect's vehicle.

Shots Fired

On 10/15/16 at approximately 1:31 am, while parked in rear lot of Lifesprings Church, PO Smith heard several gunshots near the area of W.



Galbraith Rd and Clovernook Ave. He alerted dispatch and advised he would be checking in that area, due to recent shots fired details nearby. Officer S. Miller also responded to the scene.

At approximately 1:34 am, a dispatched update was received advising that a caller witnessed the shots being fired. The caller stated to dispatch that the shots were fired

from a tan Chevy Impala with dark tinted windows at the intersection of W. Galbraith Rd and Clovernook Ave. The caller also advised that the intended target of the shots were three male blacks standing next to a parked white Chevy Cobalt on Clovernook Ave.

After searching the area, PO Smith made contact with the witness via their cell phone number. Ms. Brown stated the following:



While on duty for Uber, the witness dropped a customer off at their residence on Clovernook Ave. She made a left turn back onto Clovernook Ave heading south towards W. Galbraith Rd. While stationary at the red light, she observed a tan Chevy Impala pull behind her at the light. Shortly after, gunshots came from the tan Impala, which were targeted at the white Chevy Cobalt. After discharging approximately 5 to 7 rounds, the Impala sped around her and through the red light, turned right, then sped off westbound on W. Galbraith Rd. She followed behind the Impala, and then observed it make a right turn into the lot of what appeared to be an apartment complex. The witness described two of the males standing

by the Cobalt as being young, wearing all black clothing. The third male subject was also a younger male black wearing a white jacket and dark pants. PO's Smith and Miller searched both North Creek Apartments and the Condominiums across from Rose's, and could not locate the Chevy Impala.

At approximately 2:00 am, PO Smith received a public service from the witness reference follow-up information in regards to the incident. She stated that the tan Impala turned left on W. Galbraith heading east, then turned right onto Bobolink Dr. She advised that her vehicle, and not the Impala, turned into an apartment complex, which she advised was Four Worlds. The witness stated that she traced the streets on Google Maps upon returning to her residence. She also stated that the white Cobalt was parked on Clovernook Ave on the right side of the street if traveling north. After speaking with the Ms. Brown, PO Smith drove to the area of Bobolink Dr. attempting to locate the Impala, but was unable to locate the vehicle. He also drove to Clovernook and was unable to locate a white Cobalt in the area.

Domestic Violence (2919.25)

On 10/22/16 at 3:11 am, PO Smith was dispatched to Simpson Ave to investigate for a female subject sprayed in the face with a chemical agent during a physical altercation. Upon arrival, contact was made with the victim. The victim was in her bedroom, and was complaining of trouble breathing, and swelling/burning to the face.

At approximately 3:20 am, Colerain Township EMS arrived on scene and rendered aid to the victim. While being treated by medics, the victim stated the following in regards to the incident:

In the early hours of 10/22/16, her former spouse arrived at her residence. The ex-husband advised her that he had damaged her vehicle in an auto accident. While in her bedroom, they began to verbally argue. After several minutes of arguing, he threw her on the floor and struck her in the head. He grabbed her pepper spray, and then ran towards the front door. She got up and ran after him, attempting to retrieve her pepper spray. While near the front door, he sprayed her with the pepper spray, and then fled the

residence heading northbound on Simpson Ave towards W. Galbraith Rd.

After speaking to the victim, PO Smith made contact with her son, who stated the following:

He was upstairs in the residence and could hear the sounds of his mother and the suspect arguing. He proceeded downstairs to check on her. When he reached the bedroom, he saw the suspect punch his mother, then throw her to the floor. After grabbing the pepper spray, he sprayed his mother in the face, and then attempted to run out of the house. His mother grabbed the suspect, and then the suspect threw her against the couch. The suspect then ran out of the house and headed northbound down Simpson Ave.

The victim was treated for burning and swelling to the face, and released by EMS at the scene. The chemical spray used by the suspect on the victim was Guard Dog Pepper Spray, 18% oleoresin capsicum.



Burglary (2911.12)

On the 10/24/2016, officers responded to a report of a burglary reported by the complainant. He stated that when he came home from football practice he noticed that it was cold in his residence. He then found the security bar on the sliding glass door was popped off and the door was open about 8 inches. The complainant stated that he found his money jar was missing, along with 2 bracelets. The complainant's son was also missing



his Sony PS4 system and six PS4 games. The complainant stated that they had left the house at 0730am and did not return home until around 6:30pm. Officers looked for possible

finger prints on the sliding glass, but they could not see any areas on the door to print. The complainant stated that the house did not look like someone had gone through the house or

draws in the bedrooms. Officers advised the complainant to go through their residence to make sure that nothing else of value was missing.
