ARRESTS MADE IN DECEMBER 2017

There were a total of **50** arrests made within the City of North College Hill in DECEMBER 2017.

31 of the arrests were recite arrests (the person arrested was not physically taken into custody but issued a citation and told to appear in court).

19 of the arrests were physical arrests (the person was physically taken into custody).

Of the total arrests made within the month of DECEMBER 2017, **15** were residents of North College Hill and **35** were non-residents.

VEHICLE CRASHES REPORTED IN DECEMBER 2017


There were a total of 44 auto accidents within the City of North College Hill in DECEMBER 2017.

2 - of these crashes involved injuries.

22 - of the auto accidents were on public roadways.

12 - of the auto accidents were on private property.

8 - of the auto accidents were Hit/Skip related.



TRAFFIC CITATIONS ISSUED

IN DECEMBER 2017

The North College Hill Mayor's Court had year-to-date receipts totaling \$123,102.16 as of DECEMBER 2017.



There were a total of **105** traffic citations issued within the City of North College Hill in DECEMBER 2017.

34 of the citations were for moving offenses (OVI, Speeding, Fail to Obey a Stop Sign, etc.)

17 of the citations were for non-moving offenses (Expired license plates, not wearing a seatbelt, etc.)

40 of the citations were for parking related offenses (Parked where prohibited by signs, etc.)

14 of the citations were written warnings (the person cited was not required to pay a fine or appear in court).



VEHICLES TOWED OR IMPOUNDED IN DECEMBER 2017

There were a total of 11 vehicles either towed or impounded within the City of North College Hill in DECEMBER 2017. (These vehicles were towed or impounded at the request of the police department)



FALSE ALARMS RECEIVED IN DECEMBER 2017

There were a total of 27 false alarms received that required a response by the North College Hill Police Department in DECEMBER 2017.

11 of these false alarms were to businesses.



16 of these false alarms were to residences.

316 Total false alarms have been received in 2017.



The following narratives are a small sampling of the various calls for service the North College Hill Police Department routinely receives.

CALLS FOR SERVICE

Criminal Damaging **(2909.06)**

A complainant stated she was returning from the cell phone store when her ex-boyfriend started calling and texting her. She had gone to the store with a male friend and apparently the ex-boyfriend had seen this in the area of North Bend. The complainant stated her ex-boyfriend made a U-turn and started following her. She made several attempts to get away and ended up on West Galbraith near Long John Silver's, heading west.



The complainant was caught in traffic and the suspect approached her vehicle and started banging on, and kicking her car. He then pulled at her door handle attempting to gain entry and broke the passenger side, front door handle. In the process, the suspect damaged the passenger side, rear fender. Fearing for her and her children's safety, she proceeded to NCH Police Department to seek an Officers help.

Although the suspect did not persist once she was here, charges will be filed on her behalf. The complainant recorded as much as she could on her cell phone which was sent to

Officers to assist or be used as evidence.

Auto Theft (2913.02)

On 12/3/2017, PO Kilgore spoke to a complainant, who advised he had given a ride to an unknown juvenile from an apartment building on Mulberry St. in North College Hill. He then pulled into the parking lot of Ameristop when the juvenile asked him to get a cigar for him. When the complainant got out of the vehicle, the unknown juvenile advised him he was cold. The complainant then left the vehicle running and proceeded into the store. That is when the unknown juvenile took off in the vehicle. The complainant did not know what direction the vehicle went from the parking lot. He said he stayed at the store for a moment then walked to the Police Department. When PO Kilgore asked the complainant why he did not call 911, he stated he thought the juvenile would bring the vehicle back.

The complainant could not provide a plate number; however, the vehicle belonged to his wife. PO Kilgore was able to look her up and located a 2005 Chevy Malibu registered to her. He spoke to the registered owner via

the phone for a brief moment. She advised she was in Dayton at a Christmas party and the complainant was her husband and that she would try to make it down to file a report. She did confirm the complainant was operating her vehicle.

The vehicle was entered as stolen and an ACB was put out for the vehicle.

Burglary (2911.12)

PO Brown responded to Bising Ave. for a report of a possible burglary in progress and the complainant is waiting outside for us to arrive. Upon arrival, Officers Morris and Brown met the complainant who advised that she came home at around 0730 hrs., to find that her 39"



Samsung flat screen TV was missing from a table in the living room. She added that the rear patio door was open.

Officers cleared the apartment and while doing so, PO Brown noticed that the rear kitchen window, right sliding pane was broken out. At first, it appeared that may have been an entry point, however, he did notice that the security bar was still in the

track, preventing the window from sliding. After doing a walk through with the complainant, it was discovered that a 32" Roku flat screen TV was taken from her bedroom table on the second floor. The complainant later observed that \$200 in US currency was taken from the same bedroom table that the 32" TV was taken from. This incident, per the complainant, occurred between 12/07/17 at 1750 hrs. and 12/08/17 at 0730 hrs.

PO Brown asked her if she knew anyone who would have done this. She said she didn't know, but later said maybe a guy she used to work with at Kellogg, who drives a white Ford Fusion, may have done it. PO Brown asked why she would think that. She said he was at her apartment a few days ago and was telling her that he needs to find ways to make quick money. She said that she became uncomfortable and asked him to leave. She hadn't heard from him since then.

PO Brown searched the area for and latent prints left behind and was able to find some possible latent prints. The latent was lifted and will be submitted to CPD CIS for analysis. He advised the complainant to

contact us if she had any further questions or concerns.

Felonious Assault (2903.11)

Officers were dispatched to the area of Simpson Ave. for a report of a subject injured in an assault. On arrival, they spoke to the victim, who stated that her boyfriend came home and became angry with her after she told him she wanted to go out to the

club. The victim stated that suspect attacked her when she asked for money and he told her "No." She told him she would get the money from someone else. The victim stated

the suspect started to choke her, and pushed her up against the wall. The suspect then grabbed a knife and put it up to her throat. The victim then grabbed the knife, attempting to pull it away from her throat, which caused a deep laceration to her right thumb. The suspect dropped the knife onto the floor, and then left the residence before officers arrived. He could not be located in the area.

Auto Theft (2913.02)

PO Henn was called to Four Worlds Dr. for a vehicle theft report. Upon arrival, he was met by the

victim, who stated she had started her vehicle this morning to warm up. When she came back out of her residence the vehicle was missing. The victim stated she did not see anyone near the vehicle and has no idea who may have taken the vehicle.

The victim was advised the vehicle will be entered as stolen, and should she recover the vehicle on her own, she would need to contact our department to have the entry canceled. She was further advised a report would be on file with our department to document the incident as well as the procedure to follow for obtaining a copy of that report.

Aggravated Robbery **(2911.01)**

Officers were dispatched to W. Galbraith Rd. for a report of a robbery that had just occurred. Upon arrival, they were met by 2 victims, who stated they were both just robbed at gunpoint. The two suspects were described as both black males in their 20's, one wearing a black bubble coat, a red winter hat, and was approximately 5'6"-5'8" and heavysset, and the other wearing a gray hoodie with a mustache, approximately 5'9"-5'11"



and average build, and brandishing a silver and black handgun. Both stated that the males ordered them to lay face down on the floor at gunpoint before taking a black iPhone 7 plus and wallet from one victim, and a ring, a wallet containing \$1280.00 cash, and an iPhone from the other victim. Both suspects left in an unknown direction. Neither victim knew whether the suspects left the building on foot or got into a vehicle.

P.O. Kilgore then went to the room where the incident took place, and returned stating the room was flooded with approximately one inch of water. Both victims stated they were ordered to lay face-down on the floor, however neither one appeared to be wet.

Originally, officers were dispatched to a different address on W Galbraith Rd, and when requested to confirm the address, they were given two more incorrect addresses before finally being given the correct address. Because of this, significant time had passed from the time the robbery occurred, and the time officers arrived on scene.

Both victims were advised that a report would be on file,

and that it would be turned over to our detectives for further investigation.

Vehicle Tampering

PO Shepherd was dispatched to the PD for a complainant on station. Upon arrival, she was met by a complainant, who stated an unknown person had gone through her vehicle overnight. The complainant stated that sometime between 1700 hrs. on 12/17/2017 and 0500 hrs. on 12/18/2017; an unknown subject gained entry to her vehicle via the unlocked doors and went through her center console and glove box. The complainant stated that nothing had been taken, and there was no damage to the vehicle. PO Shepherd advised the complainant that a report would be on file and to call back if she discovers anything to be missing.

Burglary (2911.12)

PO Shepherd was dispatched to Catalpa Ave. for a burglary report. Upon arrival, she was met by the victim, who stated an unknown person had entered her home and stolen items while she was out of town. The victim stated she left home

on Friday 12/29/2017 at approximately 0800 hrs., and returned home 12/31/2017 at approximately 1830 hrs. Sometime while the victim was out of town, an unknown person entered her home by a rear unlocked window and stole approximately \$105.00 in change, and a blue safe that contained McKnight's wedding ring, and a Hi-Point 9mm handgun. The victim stated that a chair had been taken from her back patio and the pushed to



the window to gain entry into the residence.

There was also damage to the victim's bedroom door from the unknown subject kicking in the locked bedroom door.

PO Shepherd checked the rear of the residence and saw the chair that was still against the house underneath the window. She noticed that there were a few inches of untouched snow in the chair, so she believes this had taken place sometime on the 29th before the recent snowstorm.
