# ARRESTS MADE IN NOVEMBER 2017

There were a total of 63 arrests made within the City of North College Hill in NOVEMBER 2017.

35 of the arrests were recite arrests (the person arrested was not physically taken into custody but issued a citation and told to appear in court).

28 of the arrests were physical arrests (the person was physically taken into custody).

Of the total arrests made within the month of NOVEMBER 2017, 25 were residents of North College Hill and 38 were non-residents.

# VEHICLE CRASHES REPORTED IN NOVEMBER 2017

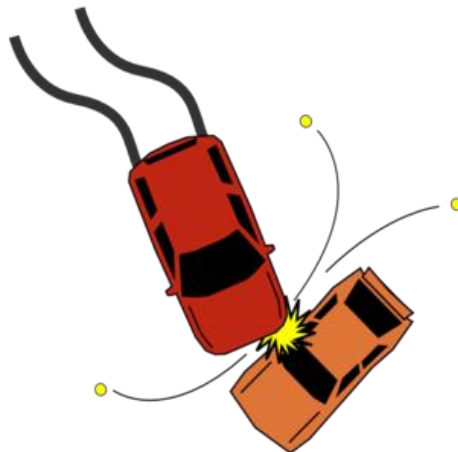
There were a total of 29 auto accidents within the City of North College Hill in NOVEMBER 2017.

2 - of these crashes involved injuries.

14 - of the auto accidents were on public roadways.

4 - of the auto accidents were on private property.

9 - of the auto accidents were Hit/Skip related.



# TRAFFIC CITATIONS ISSUED IN NOVEMBER 2017

The North College Hill Mayor's Court had year-to-date receipts totaling \$114,527.16 as of NOVEMBER 2017.



There were a total of 118 traffic citations issued within the City of North College Hill in NOVEMBER 2017.

53 of the citations were for moving offenses (OVI, Speeding, Fail to Obey a Stop Sign, etc.)

25 of the citations were for non-moving offenses (Expired license plates, not wearing a seatbelt, etc.)

15 of the citations were for parking related offenses (Parked where prohibited by signs, etc.)

25 of the citations were written warnings (the person cited was not required to pay a fine or appear in court).





# VEHICLES TOWED OR IMPOUNDED IN NOVEMBER 2017

There were a total of 11 vehicles either towed or impounded within the City of North College Hill in OCTOBER 2017. (These vehicles were towed or impounded at the request of the police department)





# FALSE ALARMS RECEIVED IN NOVEMBER 2017

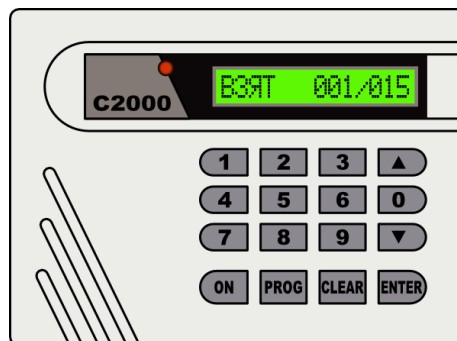
There were a total of 24 false alarms received that required a response by the North College Hill Police Department in NOVEMBER 2017.

9 of these false alarms were to businesses.



15 of these false alarms were to residences.

289 Total false alarms have been received in 2017.



The following narratives are a small sampling of the various calls for service the North College Hill Police Department routinely receives.

## CALLS FOR SERVICE

### Criminal Damaging (2909.06)

A complainant responded to the North College Hill PD to report that a known subject had purposely hit her vehicle while she was on Goodman Ave., in front of the Boot Camp Cincinnati. She stated the person who struck her vehicle is an ex-girlfriend of her current boyfriend.

The incident began when both subjects saw each other at Kroger, 7132 Hamilton Ave. They "exchanged words" and when the complainant left the store, she noticed a vehicle was



following her. She drove into College Hill and turned on Lantana Ave. The vehicle continued to follow her, so she did not go to her house. She drove back to North College Hill and turned on Goodman Ave. She stopped her car in the roadway, while on Goodman Ave., got out of her car and yelled at the car following her to "Stop following me!" Per the complainant, the suspect then yelled that she was going to hit the complainant with her car. The complainant said "Go ahead! I'll call the police and you will go to jail!" With that the suspect struck the complainant's car in the

open driver's side door. The suspect also almost hit the complainant, but did not. The door to complainant's car no longer closes. With almost being struck, and with the door not being secure, this created a risk of physical harm to the complainant.

### **Theft (2913.02)**

PO Henn was dispatched to Perkin's for a theft report. Upon arrival, he was met by the reporter who states an unknown person or persons removed a utility trailer containing construction tools, from their job site sometime overnight. The trailer is described as a white, enclosed utility trailer. The reporter states they left the job site at approximately 1900 yesterday's date, and upon returning to work today's date, the trailer was missing. The reporter states he has no idea who may have taken the trailer.

The reporter was advised a report would be on file with our department to document the incident. He was further advised the trailer will be entered as stolen, and should he recover the trailer on his own, he

should contact our department to have the entry canceled.

### **Burglary (2911.12)**

PO Shepherd was dispatched for a burglary report. Upon arrival, she was met by the complainant, who stated that an unknown person burglarized her home sometime overnight, and left the rear door to the residence open. The complainant stated that she was gone from approximately 0030 hrs to 0900 hrs, and during this time an unknown



person gained entry to her home through the back door, and stole several items from the home. The items taken included a LG brand HDTV, a Vizio brand SmartTV, a pair of

Cazal sunglasses, an Xbox One, and a Playstation 4. She did not know the value of these items, but was able to provide serial numbers for both game consoles. There was no sign of forced entry, but the complainant stated she locked all doors before she left for the night.

PO Shepherd advised the complainant that a report would be on file, and to contact her renter's insurance company. I also advised her to call back if she discovers

anything else missing, or can provide the serial numbers of the other missing items. The Playstation 4 and Xbox One were entered into RCIC as stolen property.

## **Criminal Damaging** **(2909.06)**

PO Frick responded to Sundale Ave to investigate damage to the complainant's property. The window in the side door of his house was clearly busted in. Most of the glass from the window was inside of the house.

The complainant had stated that he and his former girlfriend had been arguing and he wanted her

to leave. He also stated that after she exited the house she started banging on the doors because she wanted her hat from inside. The complainant said that he told her to go to the back door to get it from him. He stated that she stopped at the side door and busted out the window. The complainant handed her hat and then called police to report it. At this time the complainant declines criminal prosecution.



## **Breaking & Entering** **(2911.13)**

A complainant entered the PD and stated an unknown person had broken into his store, DTJ's Quickstop, sometime overnight. PO Shepherd responded to the store with the complainant to take the report. Upon arrival, the complainant showed PO Shepherd where an unknown person had taken a rock and broken the window of the front door of the store to gain entry. The complainant

then stated to PO Shepherd that this person had taken approximately \$200 in various tobacco products, the store cash register valued at approximately \$150, with approximately \$65 worth of change inside, and a TV monitor that was used for the store security system, valued at approximately \$100. The complainant stated that the security system itself was not taken, and that he could probably obtain video when he gets a new monitor. The time frame that the complainant stated this would've taken place was between 2300 hrs on 11/23/2017 and 0830 hrs today's date.

The complainant did have information on two individuals he said may have broken into his store. He stated that at approximately 0000 hrs today's date, he was in Walgreen's at the corner of W Galbraith Rd and Hamilton Ave, and saw two frequent customers from his store. He described the individuals as two male blacks, one approximately 15 years of age and the other approximately 18 years of age with a mustache and glasses. He witnessed the two boys bringing a large amount of change into the Walgreen's store and tried to exchange the change for cash. The complainant is very familiar with these boys but did not know their names, only that they come in his store almost daily.

PO Shepherd advised the complainant that she would take down the information and that a report would be on file and turned over to our detectives for further investigation. The complainant was also instructed to call back to the PD if he discovers anything else to be missing, and when he is able to view his video from the store.



## **Domestic** **Violence/Aggravated** **Menacing (2919.25/2903.21)**

Officers were dispatched to Catalpa Ave. for a domestic incident, female having trouble with her brother. While enroute, they were updated by HCCC that the male half had threatened the female complainant's boyfriend with a knife. Upon arrival, they were met by the boyfriend, who stated his girlfriend's brother, the defendant, had assaulted his girlfriend, and when he intervened, the defendant produced a knife and chased him down the street. This victim denied any injury.

Officers were also able to speak with the female victim. According to her, she was assaulted by her brother, the defendant, and she did have apparent minor injuries to her arms. The victim declined EMS response. The defendant had left the scene prior to police arrival.

Both victims stated they did wish to pursue criminal charges against the arrested.

As officers were obtaining information from the victims, the



defendant returned to the resident and was taken into custody. He stated he had been assaulted by his sister; however he did not have any visible injury, and did not complain of any injury. No knife was found on the person of the arrested; however, he did have a portable power/charging unit on his person. The defendant was transported to our station for processing, and then transported to HCJC.

## **Making False Alarms** **(2917.32)**

Officers were dispatched and responded to Dallas Ave for a report of a person armed with a gun, holding his girlfriend against her will. The information was third party just like the first call. The complainant was the mother female inside the residence. Officers had previously responded to the address just over an hour before for a similar call. Officers had made contact with the female resident, who stated that she was fine and wanted to stay at the residence with her boyfriend.

While responding to the second call we were updated by dispatch that they now have the female resident on

the phone who is stating that she is home alone. PO Miller advised dispatch to have her come outside. She walked outside and greeted officers and stated everything was fine. She stated that she called 911 and told them that we were not needed. She stated that her mom is freaking out because she stopped taking her calls. When asked about her boyfriend having a gun and holding her against her will she initially denied making those statements.

Lt. Petrocelli contacted the female's mother by phone. The mother stated that she was receiving text messages from her daughter stating that her boyfriend had a gun, she was scared to leave, and she lied to the police because he threatened to kill her and he was listening the whole time. The mother sent those text messages to the police.

After being confronted with actually text messages, the female resident did admit that she sent the messages only to scare her mother into coming to pick her up. She didn't think she would call the police. The female resident was arrested for making false alarms and transported to CJC.
