# ARRESTS MADE IN FEBRUARY 2014

There were a total of 69 arrests made within the City of North College Hill in FEBRUARY 2014.

37 of the arrests were recite arrests (the person arrested was not physically taken into custody but issued a citation and told to appear in court).

32 of the arrests were physical arrests (the person was physically taken into custody).

Of the total arrests made within the month of FEBRUARY 2014, 29 were residents of North College Hill and 40 were non-residents.


# VEHICLE CRASHES REPORTED IN FEBRUARY 2014

There were a total of 27 auto accidents within the City of North College Hill in FEBRUARY 2014.

1 of these crashes involved injuries.

26 of the auto accidents were on the public roadways.

1 of the auto accidents were on private property.



# TRAFFIC CITATIONS ISSUED

## IN FEBRUARY 2014

The North College Hill Mayor's Court had year-to-date receipts totaling \$33,741.08 as of FEBRUARY 2014.



There were a total of 141 traffic citations issued within the City of North College Hill in FEBRUARY 2014.

66 of the citations were for moving offenses (Speeding, Fail to stop at a Stop Sign, etc.)

16 of the citations were for non-moving offenses (Expired license plates, not wearing a seatbelt, etc.)

24 of the citations were for parking related offenses (Parked where prohibited by signs, etc.)

34 of the citations were written warnings (the person cited was not required to pay a fine or appear in court).



# VEHICLES TOWED OR IMPOUNDED IN FEBRUARY 2014

There were a total of 7 vehicles either towed or impounded within the City of North College Hill in FEBRUARY 2014.



# FALSE ALARMS RECEIVED IN FEBRUARY 2014

There were a total of 31 false alarms received that required a response by the North College Hill Police Department in FEBRUARY 2014.

6 of these false alarms were to businesses.



25 of these false alarms were to residences.

71 Total false alarms have been received in 2014.



The following narratives are a small sampling of the various calls for service the North College Hill Police Department routinely receives.

## CALLS FOR SERVICE

### Identity Theft (2913.49)

PO Henn was dispatched to Four Worlds Dr. for a theft report involving the complainant's bank account. Upon arrival, he was met by the victim, who stated she had been notified by her financial institution, Key Bank, of at least two possibly fraudulent transactions made against her account by an unknown person or persons. One transaction was made at an unknown Best Buy location, in the amount of \$811.43, and a second transaction was attempted at an unknown Apple Store. The first transaction has been reversed by her



financial institution and the second transaction was declined at the point of sale. The victim states the subject(s) appear to have gained access to her debit card number, as the card itself is still in her possession. The victim does not know how her debit card information may have been compromised.

The victim was advised a report would be on file with our department to document the incident as well as the procedure to follow for obtaining a copy of that report.

## **Criminal Damaging** **(2909.06)**

PO Shumate was dispatched to Prospect Pl. for the report of juvenile(s) shooting a BB gun at the house. On arrival, he was advised by the home owner that while sitting in her home, she heard what she believed was something striking the house and window. Upon further investigation she observed the suspect standing on the porch next door holding and pointing a dark color weapon believed to be a gun shooting towards the house. When she confronted him, he took off running towards his home.

PO Shumate made contact with the juvenile and he denied owning or having a BB gun. The complainant positively ID the subject, along with the other juveniles. The complaint indicated she just wished her window fixed, and will discuss with her husband if she will proceed with charges.

## **Domestic Violence** **(2919.25)**

Officers were dispatched to Betts Ave. for a male subject who was intoxicated punching and attacking his pregnant girlfriend. Upon arrival,

officers heard screaming and crying coming from inside the residence, and observed a fight going on inside the living room. Officers ran into the house and found several people trying to push the intoxicated male away from a pregnant female who was on the floor in the living room. The male was yelling and screaming "This is my fucking family and I'll do what I want!" After several commands for him to stop yelling and to calm down, he still refused and was trying to fight. He was then detained and placed in handcuffs. While attempting to detain him, his son got in between him and Sgt. Schrand. The juvenile began yelling "That is my dad and you will have to arrest me too and I will fight!" He was then arrest for obstructing official business. Both male subjects were escorted to police cars outside.

After further investigation it was discovered that a fight broke out between the male and female in the bedroom. She ran out of the bedroom screaming trying to get away from him. Several of her family



members were playing a board game in the living room, when she came running out toward them. They

watched as the male grabbed her and pushed her into the wall. He punched her in the stomach (she is 8-9 months pregnant with his child) repeatedly. Her son observed this and tried to push the male off of his mom and get him to stop hitting her. That is when the male grabbed her son by the throat and pushed him up against the wall and punched him in the head. The victim, her mother, and others tried then to intervene and get the defendant to stop. He then pushed the victim's mother into the wall several times while she was trying to get him to stop his violent actions. He then turned his rage on the kitchen table and chairs, breaking them and threatening to go after the pregnant victim again. That is when police arrived.

The defendant was charged with two counts of domestic violence and pregnant victim went to the hospital for her injuries and potential complications with the pregnancy.

## **Theft (2913.02)**

The victim reported that while she was at the cash register counter inside Shell Service Station, she set her purse on the counter top to count her money. She stated she had \$100 in a U.S. Bank envelope. She placed the money back in the envelope and

walked behind the counter toward the cash register. She stated she was only away from her purse for a few minutes.

The victim stated when she came back to her purse it was not like it was when she left it. She stated she checked in her purse and found that the envelope was missing. She stated she went back to review the

video cameras to see if anyone got into her purse. She stated she saw a M/W subject get into her purse. She stated she knows the suspect by sight because he comes into Shell three to four times a day.

PO Palmisano also reviewed the video cameras. It does show a M/W walk over to the purse and get into the purse. He asked the victim to obtain a copy of the video and provide it to the PD. He also informed her that if the suspect comes into the store to contact the police. The area was checked and the suspect was not located.

## Assault (2903.13)

On 2-12-14, at approximately 1910 hours, the complainant responded to the PD to report that her son was assaulted on 2-7-14 by a group of M/B's while at McDonalds/Shell after a NCH basketball game. The complainant stated she allowed her son to attend a basketball game with a few of his friends. She stated she formally lived in NCH but recently moved to Fairfield.

The victim stated when her son arrived at home from the basketball game, he at first did not say anything and kept from looking at her. When he finally looked at her, she saw that his lips were swollen and there were bruises all over his body. He told his mother that he was jumped by a group of 17 people while at McDonalds/Shell.

PO Palmisano talked to the victim, who stated that after the basketball game, he and his three (3) friends walked over to McDonalds. One of his friends that went with them was a female. While inside McDonalds there was a small group of people, most notable was a light skin M/B, who began talking about the female he was with. Once the female left, the group started talking louder about

the female. The light skin M/B, along with the other people with him, asked the victim to step outside. He stated he and his friends did go outside. He stated that is when he saw about 17 people all around him.



After a few words exchanged between the victim and the group of 17, he turned to go back inside McDonalds. As he turned he was struck in the face by an unknown person. He

stated as he was being punched, he fell to the ground and he was kicked in the face. The victim stated the Manager from either Shell or McDonalds was able to open the door, pull him inside, close the door, and tell the group that she was calling the police. The victim stated he stayed inside McDonalds/Shell until he was picked up by his friend's mom.

PO Palmisano asked the victim if he could identify the suspect that assaulted him. He stated he most likely could identify them. PO Palmisano asked if knew any of the suspect by name or nick names. He stated he did not know any of their names.


The complainant stated on 2-12-14, at approximately 0900 hours, she

took her son to the Dentist. The Dentist informed her that all of his teeth have been damaged because of the assault. He stated the braces that he had just removed may have to be replaced.

PO Palmisano informed the victim if he finds out the names of the suspects please let the PD know. He also informed the complainant that McDonalds/Shell will be contacted to obtain a copy of the video tape.

## **Vandalism (2909.05)**

On 2/14/14 at 12:49 PM, officers were dispatched to Ameristop on 2001 W. Galbraith Rd to investigate an intrusion alarm. While en route to the scene, additional information was sent to the MDC advising that an altercation involving two customers



was in progress. Upon arrival on scene, officers made contact with the store clerk/complainant. The complainant stated that two, male blacks, approximately thirty years of age, wearing dark clothing, walked into the store while involved in a

verbal altercation. The complainant then stated that the suspects purchased some items, then shortly after, entered into a physical altercation, resulting in a several cases of Bush Light beer being damaged. The complainant then stated that one of the suspects picked up a can of soda pop, and threw it towards the entrance of the store, causing damage to the hydraulic unit of the front door. The complainant then stated that the suspects left the store together, but was unsure of their direction of travel. The complainant also stated that he would provide NCH Police with a copy of the surveillance video once it becomes available.

## **Theft (2913.02)**

Victim, who is visually impaired, called stating she believed her I-phone was stolen. Victim was working as the receptionist at Clovernook Blind Center on today's date when an unknown male entered the business. Suspect entered at or around the same time as the "Happy's Pizza" delivery driver near 11:16 am. It is unknown if the driver is the suspect. Victim also stated she did not buzz anyone else in after the pizza delivery driver. Victim stated the suspect identified himself as "John" and asked to see Donna, the manager. Victim

asked if the man had an appointment and "John" said he did and did not provide a time. Victim asked which Donna the suspect was there to see. Suspect did not know Donna's last name. Victim stated the only Donna she could think of and the suspect agreed by saying "Yeah that's her I think." Victim turned to page Donna on the overhead. Donna quickly returned the call and stated she only had an appointment with a "Jason" and did not expect a "John". Victim turned back to ask the man additional questions with no response. She asked several more times and did not get an answer.

Victim was able to "track" her phone with an app to the address on W. Northbend Road. CPD was requested to respond and ATL. CPD advised the address was a vacant house located in front of several apartments and could not locate the exact address. Victim was called and notified of this.

## **Disorderly Subjects**

The police and life squad were called by the female who advised she was assaulted by her boyfriend and he had taken her phone. Upon arrival to the dispatched scene on Goodman Ave.,

police were not able to locate any trouble or the complainant. Police inquired with the residents that were at the address and they advised the female and her boyfriend were on scene before police arrived but they must have left towards Simpson Ave. Police obtained a brief description of their clothing and started towards Simpson Ave. At the same time the dispatcher updated police there were persons matching the clothing description in the area of Simpson Ave. and Galbraith Rd. Police were able to locate the female and then the male a short distance west on Galbraith Rd. from Simpson Ave.

Police were advised by the female, who they learned later was a Juvenile and wanted by Juvenile Court, there was a verbal and small physical altercation, but, all she wanted was to get her phone back. The female also advised she did not need the life squad to respond to look at her. The male was found to have open warrants out of Central Warrants and was recited for them. The male was then released from the scene.

The female was found to have open Juvenile Warrants and was transported to NCHL PD for

some papers then transported to Juvenile detention (2020 Auburn Ave.). The parents of the juvenile complainant did arrive on scene during the interaction, in the area of Galbraith and Mar Bev Ave., and were advised of the status of their daughter and her being transported to Juvenile detention.

## **Theft (2913.02)**

While engaged in a traffic stop on north bound Hamilton Ave, PO Ryan was approached by a cab driver that had stopped across the street. The cab driver stated that his passenger



had fled the cab without paying the \$26.00 fare. The cab driver stated that his passenger had exited the cab and fled south bound Hamilton Ave without paying the fare. The passenger was a male white in his thirties wearing a sport coat and jeans.

Sgt. Petrocelli searched the area and was unable to locate the passenger. Approximately 30 minutes later, the passenger was observed by

PO Ryan. He was seen crossing Hamilton Ave. at Centerridge. PO Ryan stopped the subject and detained him until the cab driver could return to the scene for identification purposes. The cab driver returned and identified the passenger. The passenger offered to pay the cab driver his original fare plus additional money to cover the cab driver's time. The cab driver accepted this offer and declined prosecution.

The passenger was issued a citation for disorderly conduct. The cab driver then departed the scene with the passenger on board.

## **Criminal Damaging (2909.06)**

Officers were dispatched to Parrish Ave. for a report of damage done to the complainant's property. The complainant reported that the front bay window to her home was damaged by a BB. The BB was lodged in between the two glass panes her bay window.

The complainant stated she did not see the person who shot the BB at her window. However, she does know that the juvenile who lives across the street has used a BB gun before. She also knows there have

been other incidents of damage done to property involving a BB that has come from the area of the suspect's house.

PO Palmisano responded over to talk to the suspect and his Grandmother. The suspect stated he was shooting his BB gun, but it was in the backyard. He stated he did not shoot the BB gun in front of the house, or at her window. He also stated that his cousin had just left before we arrived.



PO Kodish found an Air-Soft pistol in the front yard of the suspect's house. He told the grandmother that he was going to take the Air-Soft pistol in for processing. The suspect stated that pistol the officers located was broken.
