## **ARRESTS MADE IN APRIL 2014**

There were a total of 85 arrests made within the City of North College Hill in APRIL 2014.

44 of the arrests were recite arrests (the person arrested was not physically taken into custody but issued a citation and told to appear in court).

41 of the arrests were physical arrests (the person was physically taken into custody).

Of the total arrests made within the month of APRIL 2014, 47 were residents of North College Hill and 38 were non-residents.

# **VEHICLE CRASHES REPORTED**


## **IN APRIL 2014**

There were a total of **40** auto accidents within the City of North College Hill in APRIL 2014.

**5** of these crashes involved injuries.

**32** of the auto accidents were on the public roadways.

**8** of the auto accidents were on private property.



# **TRAFFIC CITATIONS ISSUED**

## **IN APRIL 2014**

The North College Hill Mayor's Court had year-to-date receipts totaling \$74,012.08 as of APRIL 2014.



There were a total of **169** traffic citations issued within the City of North College Hill in APRIL 2014.

**84** of the citations were for moving offenses (Speeding, Fail to stop at a Stop Sign, etc.)

**11** of the citations were for non-moving offenses (Expired license plates, not wearing a seatbelt, etc.)

**25** of the citations were for parking related offenses  
(Parked where prohibited by signs, etc.)

**49** of the citations were written warnings (the person cited was not required to pay a fine or appear in court).

## **IN APRIL 2014**


There were a total of **30** false alarms received that required a response by the North College Hill Police Department in APRIL 2014.

**10** of these false alarms were to businesses.



**20** of these false alarms were to residences.

**134** Total false alarms have been received in 2014.



The following narratives are a small sampling of the various calls for service the North College Hill Police Department routinely receives.

## **CALLS FOR SERVICE**

### **Theft of Identity (2913.49)**

The victim is a college student at Western Kentucky University in Bowling Green, Kentucky and the reporting person is her mother who lives in NCH. While home for Christmas Break, the victim went shopping at Northgate Mall in Colerain Township on 12/22/2013.



While shopping, her wallet containing her driver's license, social security card, and various other personal items such as credit / debit cards, etc.

In January of 2014, the victim noticed on her credit report, that several credit accounts had been created in her name that she did not apply for (Target, Best Buy, Pay Pal, Sams, Walmart, and TJ Max.).

Victim has begun the process of contacting the businesses in which fraudulent accounts were created in the victim's name.


### **Aggravated Robbery (2911.01)**

On 04/01/2014 @ 2245 hours, officers were dispatched to Long John Silver's Restaurant (1716 W. Galbraith Rd.) for a Robbery that had just occurred.

While responding to the scene, Sgt. Schrand observed a male subject walking west bound on W. Galbraith Rd. in front of the NCH Bakery, wearing a dark grey hoodie, black pants and dark colored shoes. Due to the close proximity of where the robbery had just occurred and that fact that the subject was walking away from that area, Sgt. Schrand utilized the spotlight on his cruiser to illuminate the subject while he approached him in his vehicle. As soon as the male subject was "spotlighted" by Sgt. Schrand, he immediately took off running from the scene in an attempt to elude officers. The suspect ran behind the NCH Tailors building and onto "B" Alley. When Sgt. Schrand drove around the building, he observed the suspect running east on "B" Alley and then south on 4th Alley. Sgt. Schrand exited his cruiser and began chasing the suspect only to lose sight of him somewhere on 4th Alley.

Multiple agencies responded to the area to assist with a high visibility perimeter and NCH officers were advised that a K-9 unit was en route as well (SPTP K-9). PO Kodish responded to Long John Silver's and was met by the reportee, who advised

that he was the manager on duty at Long John Silver's when the robbery occurred. He stated that he and two (2) female employees had been working this evening without incident. When the 2 female employees were ready to leave, he walked them to the door of the business, unlocked it from the inside and allowed the employees to leave. He then advised that he did not re-lock the door after the 2 other employees left because he thought he would only be just a couple minutes behind them.



Officers were advised by the reportee that after he let the other employees out, he turned around and walked over to the safe. While he was bent down in front of the safe, he stated that he felt as if someone was standing immediately to his right. Before he could look in that direction, he observed a dark colored pant leg to his right and then a black colored firearm, possibly a revolver, in his face. He advised officers that the suspect ordered him to the ground and to look away from him. Due to the suspect surprising the reportee and telling him to get on the ground and face away from him, he was unable to look at the suspect's face or give an accurate description of what the suspect was wearing. He stated that he only saw the suspect

wearing dark colored pants and dark colored shoes.

The suspect reached into the safe with one hand and used his other hand to hold the firearm against the back of the reportee's leg. After taking the money, the suspect fled the scene in an unknown direction.

When the K-9 unit arrived on scene, Sgt. Schrand "shadowed" while the dog attempted to track. The track was performed but the suspect was not located.

## **Theft (2913.02)**

On 04/02/2014, the victim responded to the North College Hill Police Department to report a theft from his property. The victim states he was notified by a neighbor on the morning of 04/01/2014, the A/C unit was missing. The victim states a neighbor heard a noise at approximately midnight on 04/01/2014 and didn't think anything of it. The victim states the next door neighbor checked around his property and noticed the A/C unit was missing. The victim states the neighbor was talking to the victim this morning when a blue Chevrolet pickup truck



passed the house. The victim states the neighbor said "that's the guy that took the A/C unit".

The victim states the neighbor advised him he spoke to another neighbor across the street and was advised they observed a blue Chevrolet Pickup near the house. The victim states the neighbor advised him he observed a male white, dark hair walking down the alley next to the residence carrying bolt cutters on 04/01/14 sometime between 11:00 am and 3:00 pm.

## **Telecommunications Harassment (2917.21)**

The complainant received two telephone calls on her mobile phone. On the first call, the unidentified caller asked "Are you Amos' mother?" The reporting person answered she was and the phone call was disconnected. A few moments later, the complainant's phone rang again and when she answered it, the unidentified caller called the complainant by her first name and told her that he knew that her son was the person who stole his gun. He continued to say that he sees her son all the time and he will was going to

"blow his brains out" and then hung up.

The complainant described the voice as male voice possibly in his 30's. She could hear other voices in the background, possibly children's voices.

Complainant is concerned about the calls. A follow-up will be made to the Springdale PD about this incident.

The complainant was given information on telecommunications harassment and procedure to contact her cellular provider for assistance as well as precautionary measures if she sees people following her, coming to her home, etc.

## **Attempted Burglary** **(2911.12)**

Officers were dispatched for a possible attempted burglary that had just occurred. Upon arrival, PO Henn was met by the caller who stated an unknown male black attempted to gain access to the residence by prying a window in the rear of that residence. The suspect is described as a male black, 15-20yoa, wearing a brown "caramel" colored hoodie, black sweat pants, and carrying a black gym bag. The caller states she

was working in the rear of the residence when she heard a noise at the window. The blinds were shut on that window, and when she opened the blinds, she observed the aforementioned suspect attempting to pry the screen out of the window frame. When the suspect saw the caller, he immediately ran. The caller did not see which way the suspect ran.

Upon entering the back yard, PO Henn noted the gate to the yard was closed, and there was nothing on the ground in front of the window that the suspect may have used to stand on. He dusted the window and frame for possible latent fingerprints, and found none. The caller and the victim, who is the home owner, were advised a report would be on file with our department to document the incident. They were also advised officers will be in the area attempting to locate a possible suspect.



## **Disorderly Conduct (2917.11)**

Officers were dispatched for an assault that had just occurred. Upon arrival, officers were met by several parties. One of these parties advised she was jumped by several other people who fled on foot. She did not have any injury and refused a squad. She went on, stating that her child's father had another child with another girl. Apparently these two have an ongoing issue with one another. The complainant's story was that the other female had just showed up at her residence with several other girls and "jumped" her. Later she states that she and the suspect were messaging each other and they set up a time and place to fight. She caught herself, and then told another story about the other female jumping her.

A witness stated the two had arranged to fight and during the encounter she was also struck. The witness stated that she was simply a spectator when another girl who was also a spectator with the "suspect" decided to punch her. This portion of the investigation is ongoing.

The "suspect" was located attempting to exit the area. She stated she was simply going to the store when the complainant yelled at

here asking to fight. She stated she was trying to avoid the whole thing, however not long after officers detained the "suspect," the "complainant" requested officers review a video on her phone. The video shows both girls attempting to engage in a mutual fight. With this information, both parties were arrested and charged with



Disorderly Conduct - Fighting. The "complainant" was cooperative and unlocked her phone, allowing officers to retrieve the video. Once at the station, both girls finally admitted to the fight being set up and mutual. They also advised most of this started over messages on Facebook.

## **Burglary (2911.12)**

PO Henn was called for a possible burglary report. Upon arrival, he was met by the listed victim who stated an unknown person or persons appears to have entered her residence sometime over night and removed the listed property without her knowledge or consent. The victim states she locked the front door prior to going to

bed last night. When she woke this morning and went to her computer she found the computer missing. Upon looking around the residence she found her camera and the Wii Video Game System along with two controllers and a nunchuk attachment were also missing. Nothing else in the residence appears to have been disturbed. The victim has no idea how the subject(s) may have entered the residence as there was no sign of forced entry to any windows or doors. The front window just off the front porch was found unlocked and partially open, however the shades/curtains inside were not disturbed, nor was a shelf mounted to the inside window frame for the victim's cat to lie on. The victim states she heard something/someone in the middle of the night, however she believed it to be one of her children, listed on the report. The victim's son states he was upstairs with his young daughter and denies having any visitors in the residence, and the victim's daughter was at a friend's house overnight.

The front door knob/handle and front window frame were dusted for possible latent finger prints, however none were found. The victim was advised a report would be on file with our department to document the incident as well as the procedure to follow for obtaining a copy of that

report. The victim stated she may have the serial numbers for the computer and camera, however she does not have a serial number for the Wii. She was advised to contact our department should she locate the serial numbers. She was further advised to check local pawn/resale shops to see if any of her items can be located.



## **Criminal Damaging (2909.06)**

The victim is an employee of AMT Group, a home health & care provider. She has several clients around Hamilton County and visits them on a regular basis. On Sundays, she has a client in North College Hill that she attends to from 9:00 am - 3:00 pm.

Just after she arrived at the client's residence, she observed the suspect running towards her as she was walking to the house. She ran into her client's home and secured the door. She then observed the suspect leave and return shortly with a rock/piece of pavement. The suspect threw the blunt object into the driver's side of

her vehicle which was parked on the street across from her client's home. The blunt object shattered her driver's side window and dented the frame around the window.

The victim stated the suspect is her ex-boyfriend and had previously assaulted and robbed her while she was visiting another client site in Springdale (Springdale Police Report #2014-003470) on April 13th.

A search of the area did not reveal the suspect or his vehicle (gray Chevrolet Impala).

While at the scene, the victim's cell phone rang and she advised it was the suspect (her ex-boyfriend). She answered the phone, activated the speaker and a male's voice could be heard laughing and saying "That's what you get!" and then he hung up.

The victim was only interested in filing a report. She was also given information on how to obtain a protection order and was advised to speak to her home police agency about possibly filing Menacing by Stalking Charges.

A phone call was made to the suspect's mobile phone and a man answered who identified himself as the suspect. He was advised to stop having contact with the victim, warrants were issued for his arrest



and she was advised to seek a protection order and file menacing by stalking charges against him. He was also advised to turn himself in. He stated he was only doing to her what she had done to him and then hung up.

A copy of this report will be sent to Springdale PD for their case jacket.
