### **ARRESTS MADE IN AUGUST 2015**

There were a total of <u>76</u> arrests made within the City of North College Hill in AUGUST 2015.

<u>48</u> of the arrests were recite arrests (the person arrested was not physically taken into custody but issued a citation and told to appear in court).

**28** of the arrests were physical arrests (the person was physically taken into custody).

Of the total arrests made within the month of AUGUST 2015, 44 were residents of North College Hill and 32 were nonresidents.



## VEHICLE CRASHES REPORTED IN AUGUST 2015

There were a total of <u>23</u> auto accidents within the City of North College Hill in AUGUST 2015.

- <u>3</u> of these crashes involved injuries.
- 11 of the auto accidents were on public roadways.
- **<u>6</u>** of the auto accidents were on private property.
- 3 of the auto accidents were Hit/Skip related.



## TRAFFIC CITATIONS ISSUED IN AUGUST 2015

The North College Hill Mayor's Court had year-to-date receipts totaling \$94,840.00 as of AUGUST 2015.



There were a total of <a href="#">77</a> traffic citations issued within the City of North College Hill in AUGUST 2015.

19 of the citations were for moving offenses (OVI, Speeding, Fail to Obey a Stop Sign, etc.)

**9** of the citations were for non-moving offenses (Expired license plates, not wearing a seatbelt, etc.)

12 of the citations were for parking related offenses (Parked where prohibited by signs, etc.)

37 of the citations were written warnings (the person cited was not required to pay a fine or appear in court).

There were a total of <u>5</u> vehicles either towed or impounded within the City of North College Hill in AUGUST 2015. (These vehicles were towed or impounded at the request of the police department)




## FALSE ALARMS RECEIVED IN AUGUST 2015

The following narratives are a small sampling of the various calls for service the North College Hill Police Department routinely receives.

### **CALLS FOR SERVICE**

### **Vandalism (2909.05)**

On 08/04/2015 @ 2255 hours, PO Kodish responded to the intersection of Hamilton Ave & Centerridge Ave (bus stop# 409) for a vandalism incident that had just occurred. A passerby called the police department and advised that an adult black male, wearing a teal colored shirt, had just used an unknown object to

smash/shatter the large piece protective glass of that covers the advertisement poster at the bus stop. Upon the arrival of PO Kodish, the male black suspect was no longer on scene but the broken glass readily was apparent and scattered all

around the bus stop's location.

took photographs of the damage and I notified Metro about the incident and the police report that had been generated.

#### **Burglary (2911.12)**

PO Wilber was dispatched for a Burglary report. When he arrived, he made contact with one of the homeowners. She stated that she

came home and noticed the back window's screen was taken off and her Samsung Galaxy tablet was missing. She also noticed that their

noticed that their security camera was unplugged also. The male homeowner showed up

also and stated that the security camera was unplugged at 1827 hours. PO Wilber then went around back and saw the screen to the rear window taken down. He also took a fingerprint lift off of the window.

### <u>Disorderly</u> <u>Conduct/Criminal Damaging</u> (2911.17/2909.06)

Officers were dispatched for a subject refusing to leave. Upon arrival, PO Miller observed a red vehicle in the driveway with a shattered rear window and 2 subjects on the front porch of the residence. The complainant stated that she was awoken by the sound of a person

banging on the front door and yelling. When she came to the door she observed a female black banging on the front door yelling for "Chewy" to give her phone back.

The complainant told the female several times that "Chewy" didn't live there and that they didn't know of his whereabouts. She stated that the female left and then returned a short time later banging on the front door before leaving again.

The complainant stated that she was worried about her damaging her

property. PO Miller then mentioned/pointed out the broken rear window of a car in the driveway. The complainant was unaware of the damage. She stated that the vehicle belonged to her daughter, who was inside sleeping.

Upon further inspection of the car it was found that an unknown person(s) through a rock into the window.

While gathering information for the report a female black walked toward the house and was identified by the complainant as the female banging on her door. The female was stopped and identified. She was highly intoxicated and very belligerent. She stated that "Chewy" took her phone

and went into the residence. When asked about the car window, she denied breaking the window, though she knew who did it, but refused to say.

The suspect was arrested for DCI and transported to College Hill. It is believed that the suspect broke the window but at this time there is not enough evidence to charge her. She was also told to stay away from complainant's residence.

### Theft (2913.02)

PO Six was dispatched to see a complainant who left who wallet at the Dragon City. When she returned, several minutes later, all of her money was missing. The complainant stated she thought one of the employees may have been involved. Further review of the camera system showed an unknown male subject approached the counter and place an order. This suspect grabs the wallet during his wait and appears to remove items from it. Dragon City Management stated they would bring over a disc, containing the video so that police may identify the suspect. Taken in the offense was \$60.00 in cash and a Huntington Debit Card.

### **Burglary (2911.12)**

On 8/20/15 at 3:17 AM, Officers were dispatched to North College Hill Bakery to see a complainant reference possible attempted a burglary. arrival, Upon contact was made with the caller, who stated that he left the building at approximately 5:00 PM on 8/19/20, and upon returning at 3:15 AM on discovered 8/20/15. the window on the side door was broken.

Upon checking the area around the damaged door, finger prints were observed on two of the west side windows facing the alley. Officer S. Miller dusted the windows and lifted a print to submit for evidence. It is undetermined if the suspect(s) were able to gain entry into the building.

At the time of reporting, the complainant advised that no property appears to be missing.

### Aggravated Burglary (2911.11)

Officers were dispatched for a report of a male who broke in to the caller's house and was armed with a knife. Dispatch also advised that the caller was bleeding and that the suspect had run out the back door and in to the back yard, jumping the fence leading to Larann Ln. The

suspect was described as a male black, athletic build, 6'0ft tall, short hair, wearing a green shirt and dark jeans. The suspect was still armed with a 6" blade knife.

Upon arrival Officer Miller and Mt. Healthy Police remained mobile, patrolling the area while PO Jones responded to the scene. He

spoke to the victim who met him at the front porch of his residence. The



victim was shirtless and PO Jones could see that he was bleeding from multiple areas on his upper body. PO Jones confirmed the information of the suspect's last location and

searched the immediate area before requesting the squad to continue to my location to treat the victim. During that time officers switched to an area wide radio frequency and began to set up a perimeter to trap the suspect in that area of the neighborhood.

Springfield Township Police were requested to assist with tracking the suspect with a K-9. Upon the arrival of K-9 officer, PO Jones assisted with the track and updated their location to dispatch while other units continued maintain perimeter. a searching the rear yards and crossing over to Larann Ln the K-9 no longer had a scent. The K-9 was unable to acquire a scent and after multiple efforts the track was terminated. With no further information or leads officers responded back to the scene to begin processing evidence.

The victim stated he heard a noise coming from his kitchen and went to investigate. It sounded like the garbage bag that was hanging from the handle to the rear door was moving. When he walked around the

corner and into the kitchen, he was met by the suspect who was standing in his kitchen with the back door now open. The victim could see that the suspect was armed with a knife and

> he defended himself by trying to push the suspect out of the rear door. A struggle over the knife ensued and the victim sustained multiple lacerations as a result. The suspect then fled out the rear

door and into the back yard. He was last observed jumping to backyard fence and running through the neighbors rear yard leading to Larann Ln.

### Criminal Damaging (2909.06)

On 08/21/2015 @ 2005 hours, the victim responded police to the department to a file criminal a damaging report. She stated that around 1500 hours, two (2) male black juveniles caused a large dent on the hood of her rental vehicle while they were "play wrestling" on the street. More specifically, she stated that she had parked the rental vehicle in front of her boyfriend's mother's residence on Mearl Ave. While the victim was inside the residence, a group of male juveniles were walking

by her rental vehicle when 2 males from the group broke off and began wrestling around with each other. The 2 juveniles were wrestling around the rental vehicle and at one point one of the juveniles were pushed/thrown onto the hood of the rental which caused a large dent. After causing the damage to the vehicle, both subjects immediately took off running from the scene and were unable to be located.

#### Person Shot

On the August 24, 2015, officers responded for shots fired at a residence. While officers were still enroute, dispatch gave an update for an 11 year boy who was shot. Officer Six was first on scene. There were approximately 15 people on scene however no one seemed to acknowledge police presence. Officer Six approached the group and informed them, he was there for the

child who was shot and needed their help to locate the victim. The group pointed toward the door of the residence, where one unknown juvenile said "he's in here" and

walked Officer Six inside.

Once inside, Officer Six was met by the victim (m/b/11) and the grandfather. The victim had quite a bit of blood on him, which appeared to be coming from his right side. The grandfather presented his hand forward, which appeared to have the fired projectile in it. The grandmother was shuffling around and seemed to have taken concern in the matter. She was asking what happened and who got shot. There were several juveniles (approximately 14-18) coming and going.

Officer Six checked the victim's injury and started to ask him some questions about the incident. The victim stated he was upstairs and had been walking around. He then heard a bang and felt the impact of the bullet. Officer Six asked who else was upstairs during this time. The victim stated only his brother remained upstairs. About this time. remaining officers arrived on scene. Officer Six advised the arriving

officers there may be a remaining, involved person upstairs. It was unknown if this person had sustained injury or had other involvement at this time. Officers Six, Lasonczyk and Kilgore

immediately started to the entrance of the stairs. Before officers could get out of the living room and down the hall to the stairs, two subjects came running down the steps. One subject is known to officers and was identified.

Officer Six asked this subject who else was upstairs and what happened. The scene was becoming more erratic and officers were now engaging multiple people (family members) at once. Medics were now on scene and attempting to assess the victim. The subject stated he was the only other person upstairs. He went on to say he heard the bang and

then heard his brother screaming. He was asked to show officers the area where he heard the shot originate from. He went immediately up to his room and stated he was on the bed. Officer Six noticed what

appeared to be an exit hole in the drywall, leading to the subject's room. Further inspection showed no other exit or entry anywhere else. Officers inspected the drywall in the subject's room and discovered an entry hole. The subject was asked if the room we were standing in was "his" room by Officer Lasonczyk. He replied "yes." He then said he was sitting on the bed when "it" happened.

Because of the evidence at the scene and the subject's admitted

position, he was now suspected of shooting his brother by an unknown source. Due to the increasing danger of the situation and immediate need to recover the firearm, the suspect was placed in handcuffs. He was escorted to a patrol vehicle detainment. Officers believed weapon to still be located within the area the suspect said he was sitting in, and conducted a search of this area. The firearm was not located there however. After a brief time and explaining what officers believed had occurred to the grandfather, he asked

to speak to his grandson. This was facilitated by police without question. The grandfather leaned over and spoke to his grandson. A few minutes passed and the grandfather approached Officer Six and said "He

told me where the gun at." The grandfather went on, "He said he put it in the room across from his in the big closet." Officer Six asked for some clarification as to the exact location of the firearm. The grandfather explained further.

Officer Six reentered the residence and entered the room directly across from the suspect's room. In the closet, the firearm was recovered. This was the approximate location the grandfather had relayed to Officer Six. Once the firearm was recovered, officers located the fired casing still in the chamber. The casing had jammed the slide about half way back and had not been ejected. No further evidence was located because of this.

The suspect was then informed he was now under arrest and was transported to NCHPD for processing. He has been charged with Domestic Violence, Tampering with Evidence, Having a Weapon Under Disability, and Discharging a weapon in a Habitation.

### **Domestic Violence (2919.25)**

On August 25, 2015, at 0915, PO Manning was dispatched to Dallas Ave for a person injured in a Domestic Dispute. Squad 78 responded and treated the victim for injuries, scrapes to his head. He subsequently refused transport. He

stated that he was involved in a heated discussion with the mother of his children in their vehicle. He got out of the car and walked to

his house, where she accosted him in the back yard hitting him with her fists and a computer tablet, causing the minor injuries. This is an ongoing issue between these individuals, where NCH police responded on the 14th of August at 1030 for the same type of incident. Forest Park Police were notified to go to the suspect's residence, and they made notification for her to come to NCHPD for final disposition of this issue. FRPK responded and picked up the suspect. She was transported to CJC and charged with Domestic Violence.

### <u>Disorderly Conduct</u> (2917.11)

A Subway employee advised that a F/B wearing pink scrub pants and a white tank top came in and requested some oatmeal cookies. As the employee was obtaining them from the case, the female demanded fresh cookies. The employee explained that they are fresh baked every day. The customer persisted and the employee made a new batch for the customer. The customer wanted the owner's phone number to complain.

The employee gave her the store number, explaining that they are not to

give his personal number out. The female left the store at that point.

Moments later, the female came back into the store, still irate, requesting the corporate phone number. The employee wrote it down and dropped it to the counter, while standing some distance away from the counter in order to not be so close to the female. The paper fell back towards the employee. At that time the female lunged over the counter, possibly trying to catch the paper and the employee went to try and catch it as well. The employee advised that the females hand was in his face and he pushed her hand away. At that time, the female swung at the employee as if to try and hit him.

There was no contact made. At that time, a male grabbed a hold of the female and escorted her out the front door. The female was last seen heading south on foot to an unknown location.

The employees and manager, who happened to be the victim employee's mother, were advised to contact the police immediately, if the female comes back.
