# **ARRESTS MADE IN SEPTEMBER 2015**

There were a total of **75** arrests made within the City of North College Hill in SEPTEMBER 2015.

**40** of the arrests were recite arrests (the person arrested was not physically taken into custody but issued a citation and told to appear in court).

**35** of the arrests were physical arrests (the person was physically taken into custody).

Of the total arrests made within the month of SEPTEMBER 2015, **42** were residents of North College Hill and **33** were non-residents.

# VEHICLE CRASHES REPORTED IN SEPTEMBER 2015


There were a total of 33 auto accidents within the City of North College Hill in SEPTEMBER 2015.

6 - of these crashes involved injuries.

27 - of the auto accidents were on public roadways.

5 - of the auto accidents were on private property.

1 - of the auto accidents were Hit/Skip related.



# TRAFFIC CITATIONS ISSUED

## IN SEPTEMBER 2015

The North College Hill Mayor's Court had year-to-date receipts totaling \$105,295.00 as of SEPTEMBER 2015.



There were a total of 81 traffic citations issued within the City of North College Hill in SEPTEMBER 2015.

24 of the citations were for moving offenses (OVI, Speeding, Fail to Obey a Stop Sign, etc.)

17 of the citations were for non-moving offenses (Expired license plates, not wearing a seatbelt, etc.)

12 of the citations were for parking related offenses  
(Parked where prohibited by signs, etc.)

28 of the citations were written warnings (the person  
cited was not required to pay a fine or appear in  
court).



# VEHICLES TOWED OR IMPOUNDED IN SEPTEMBER 2015

There were a total of 9 vehicles either towed or impounded within the City of North College Hill in SEPTEMBER 2015. (These vehicles were towed or impounded at the request of the police department)



# FALSE ALARMS RECEIVED IN SEPTEMBER 2015

There were a total of 42 false alarms received that required a response by the North College Hill Police Department in SEPTEMBER 2015.



16 of these false alarms were to businesses.

26 of these false alarms were to residences.

300 Total false alarms have been received in 2015.



The following narratives are a small sampling of the various calls for service the North College Hill Police Department routinely receives.

## **CALLS FOR SERVICE**

### **Criminal Damaging** **(2909.06)**

While in the area of Sterling Ave. and Betts Ave., Officer Jones was dispatched to Sterling Ave. for a burglary in progress. Upon arrival the home owner stated someone broke out her living room window. She also believed the suspect(s) may have run towards Betts Ave. due to the sound of a dog barking. Officer Jones observed no person(s) out on the streets nor did he hear any dogs barking. While he responded to the scene, Officer Cole remained on patrol in the area.



After checking the area Officer Cole responded to the scene to assist Officer Jones. The front living room window was completely broken out and the object that caused the damaged could not be determined. No suspects were observed and no entry was gained. The complainant believed that her garbage can was moved near the side of her house so it was checked for fingerprints. After processing the garbage can for prints none were gained.

While Officer Cole was speaking with the complainant, it was found that she currently is involved in a court case of domestic violence against her ex-

boyfriend. It is believed that some of his friends may have broken her window in retaliation but that cannot be substantiated. Officer Cole assisted the complainant with applying a cover to the broken window.

## **Domestic Violence (2919.25)**

Officers were called to Columbine Ct. for a subject being chased by a female armed with a butcher knife. When officers arrived on scene, PO Miller located the victim hiding behind a vehicle. He had no shoes or shirt on at the time. The apartment door was observed open but by the time he placed the victim in his cruiser, he noticed the apartment door was now shut.



The victim stated that he and his baby's mother were engaged in an altercation over text messages and Facebook post that he had made involving other women. The victim stated that after falling asleep, he was awoken and found the suspect standing over the top of him with a large silver kitchen knife. The victim said that she was holding the knife down at her side and he jumped out of bed and ran down stairs and outside. He said she chased him still

armed with the knife until they reached the front lawn.

Officers made contact at the door and it was answered by the suspect, holding a newborn baby. She was detained and checked for weapons and none were found on her person. The suspect was asked for her side of the story and she admitted to being in an altercation with Mr. King over infidelity issues. She denies ever possessing or retrieving a knife during the altercation. Several knives were located in the house, officers were unable to determine exactly what knife was held or used.

The victim stated he did not want to pursue charges however they were filed on his own behalf. He declined to cooperate with part of the arrest.

## **Aggravated Robbery** **(2911.01)**

Officers were dispatched to Claretta and Hamilton for an attempted street robbery. PO Wilber was already in the area and came upon one of the victims in the parking lot of Walgreens. PO Wilber came in contact with a teenage victim. He stated that they just tried to rob him at gunpoint and take his cellphone. He

also stated that they robbed his friend at gunpoint who lives close by. PO Wilber asked the victim what they were wearing. He stated that there were about 5 to 6 M/B's all in their teens. The victim stated that one was wearing

a green shirt and blue jeans. He stated also that a light skinned M/B with no shirt and blue jeans had a gun and pointed it at him. PO Wilber



asked the victim if he knew anyone involved. He stated to PO Wilber that the he did and advised PO Wilber who it was. PO Wilber then asked the victim if he could show him the Facebook picture that a 2<sup>nd</sup> suspect goes by. The victim directed PO Wilber to a Facebook name and PO Wilber clicked on a picture on Facebook and the victim stated "That's him! That's the guy!" PO Wilber recognized the picture as being s subject who he has had several contacts with before. PO Wilber showed mugshots of both juveniles the victim identified. He positively identified both subjects as being involved. The victim also stated that there was guy there named D-money.

A K-9 was called to track the suspects and the victim stayed in PO Wilber's car as the K-9 tracked. The victim was then transported to the PD where he gave PO Wilber a voluntary statement on what happened. He was then transported home.

## **Criminal Mischief (2909.07)**

Complainant advised that she returned home after work in the morning to find, what appeared to be excrement in front of her front door. The event occurred Saturday, Sept. 5th at approximately 0205. When asked why the wait to make a report, she replied that she was unsure if police would even respond for such an event. After several friends told her a police report should be made, she responded to NCHPD to file a report. She stated for the most part, she lived a "drama free" life.

She did recall seeing an ex-friend at the bar the same night. It is unknown if she had any involvement at this time. The victim also stated her current boyfriend was going through a custody battle. Although he does not live there, he does stay there occasionally. His baby's mother and the victim were involved in a physical altercation, three years prior. It is also unknown if this subject is involved at this time. The victim stated she

wanted the incident documented but not require a report. She also stated she would discard the excrement.

## **Burglary (2911.12)**

On 09/14/2015, Officers were dispatched to Pin Oak Dr. for an intrusion alarm on the rear door showing glass breakage. PO Henn arrived on scene and found the rear kitchen window open to the left of the rear door. PO's Henn Maus found the rear door unlocked and they entered the residence. While searching the residence, they observed the master bedroom door was kicked open as it was secured by a hasp lock. The residence was searched and no one was located inside.

PO Henn requested a canine unit to respond to the scene. A canine unit from Cheviot Police Department responded and conducted a track. The canine unit tracked west from the rear yard of the residence leading into the VFW hall in the rear of the residence. The canine continued the track through the VFW parking lot onto Brownsway Dr. The track ended on Brownsway Dr. and it was believed the suspect entered a motor vehicle parked on the street.

The resident arrived on scene and conducted a walkthrough of the residence with Det. Fritz and PO Maus. The victim stated the only disturbance found in the residence was the entry into the master bedroom. He stated the suspect entered the closet of the master bedroom. The victim stated no items appeared missing. Det. Fritz processed the scene for finger prints and removed a Planters Peanut can that was knocked down from the master bedroom closet for processing.

## **Theft (2913.02)**

On 09/14/2015, PO Maus was called to the Dollar General for a theft report. He arrived on scene and spoke to an employee. The employee stated three male black juveniles entered the business and picked up some candy bars and walked around the store. The employee stated she confronted the suspects in an aisle and asked what they did with the candy bars. The employee stated one of the suspects told her he had put them down, but could not show where. The employee stated she instructed the



suspects to leave the store. The employee stated they became argumentative with her and used profanity. The employee stated the suspects then left the store and then returned. The employee stated the suspects reentered the store and removed a bag of chips from the display and immediately walked back out the store.

### **Assault (2903.13)**

PO Jones responded to a report of an assault that just occurred at Kroger. Upon arrival, he met with the victim, who stated he was assaulted by his ex-girlfriend in the parking lot. He stated he left his ex-girlfriend's house after an argument. He then noticed his she was following him in her vehicle. The victim pulled into Kroger and was attempting to walk inside the store when his ex-girlfriend jumped out of her vehicle and ran up to him while making the comment "ya thought ya lost me!" The suspect punched the victim in the face just below his left eye and said "that was a good one!" The punch caused a laceration below his eye and also caused redness in his eyeball.

An ambulance was called to check the

victim's injuries. Once the medics cleared the victim, PO Jones spoke with him about the situation further. He stated that he was worried she would make some claim that he was drunk and driving to get him in trouble. PO Jones advised him that he shouldn't worry because he did not seem intoxicated. There was no odor of an intoxicating beverage on his breath and the eye that wasn't punched showed no signs of intoxication either.

The victim was advised that a report would be made and at his request, charges would be filed for assault against his ex-girlfriend. Camera footage from the parking lot will be obtained, if available from Kroger.

### **Theft (2913.02)**

On 09/19/2015 @ 1743 hours, PO Kodish responded to Kroger regarding a loss prevention officer that was holding a 14 year old male juvenile. More specifically, the loss prevention officer advised that the male juvenile had been detained after it was discovered that he had concealed approximately \$ 97.79 worth of store merchandise in his



backpack and then failed to pay for any of the items in question. The loss prevention officer stated that he observed the juvenile enter the store after parking his bicycle in the front foyer. He stated that he also noticed the juvenile had a very large camouflage (light brown colored) backpack on his back and that with today being a Saturday, it was believed he wouldn't have been attending school.

After a short while, the officer stated he observed the juveniles walking toward the front of the store and that the backpack appeared to now be filled with something, due to the bottom of the backpack almost dragging on the floor. The officer stopped the juvenile in the front foyer and asked to look inside the backpack. When the backpack was opened, it was immediately discovered that the merchandise from the store had been placed in there by the juvenile. At that moment, he was detained and then escorted to the upstairs office for processing. While upstairs, the juvenile admitted to the officer he has stolen from this Kroger store approximately 3 other times in the past but that he had never been caught.

Officers made contact with juvenile's mother, who was currently at her place of employment. She contacted a family friend and requested he respond to Kroger to pick up her son. A short while later, this friend arrived at Kroger and the juvenile was released into his custody, as was the bicycle. The juvenile was advised by Kroger management and security that he was no longer permitted on Kroger's property and if he returned, he could be arrested for Criminal Trespassing.

## **Robbery (2911.02)**

On 9/21/15 at 1:20 AM, Officers were dispatched to Shell Gas Station, 6840 Hamilton Ave, to investigate a person who was assaulted in a robbery. Upon arrival on scene, contact was made with the victim, who is a clerk at the business. He reported that he was robbed by two black, males while inside the car wash.

The victim stated the following in regards to the incident; He escorted a black, female through the entrance of the car wash to help her find a wallet. He did not previously know the female. Two black, males approached him from

behind, grabbed him by the neck, and robbed him of his property. The suspects also forced him to remove his shorts during the struggle. The suspects fled the scene on foot, running southbound towards Goodman Ave. Suspect #1 was described as a male, black, approximately 20 years of age, 6' tall, 165 lbs., dark skin, with blond dreadlocks, wearing a black shirt, with jeans. Suspect #2 was described. The victim could not provide a description of Suspect #2. Taken in the robbery was a white Samsung Galaxy III cell phone, approximately \$40 in cash, and the victim's Ohio driver's license. The victim also reported that his glasses were knocked off of his face during the struggle with the suspects.



At approximately 1:30 AM, Springfield Township Police K-9 Unit responded to the scene to attempt a track. The track began at the entrance to the car wash, and was called at Fricker's 1580 Goodman Ave. NCH EMS responded on scene at approximately 1:25 AM, but the victim declined any treatment.

At approximately 1:40 AM, the manager of Shell, who responded on scene after being notified by the victim, played back the surveillance

video from inside the office. The surveillance video displayed the following; at 1:02 AM, the female participant enters Shell Gas Station. At 1:05 AM, the victim and female participant exit the store. At 1:07 AM, the victim and female participant enter the car wash. At 1:09 AM, both suspects enter the car wash, and are seen grabbing and assaulting the victim. Suspect #1 was observed wearing a black jacket with red sleeves, white pants, and a black, knit, hat. Suspect #2, who appeared to be 18 to 24 years of age, was observed wearing black pants, black hooded sweatshirt, and black sunglasses. The female participant was observed wearing a white tank top and blue jeans. Before the robbery occurred, the victim is observed placing his arm around the back of the female participant. The video footage did not observe the victim searching in the car wash for property.

At 2:30 AM, the victim was placed into PO Smith's cruiser, and advised his Miranda Rights. During questioning, the victim made revisions to his original statement, which included the following; He had contact with the female participant approximately two days prior, exchanging several text messages.

The victim believes that the female participant lured him into the car wash for the robbery. The victim also stated that he has possibly seen one of the suspects at the basketball courts in Crutchfield Park.

## **Aggravated Menacing** **(2903.21)**

PO Wilber was dispatched to the McDonald's for a M/B juvenile wearing a red hat, white shirt, and khaki shorts that threatened to come back to the store and shoot her. As PO Wilber was responding, he passed by a m/b juvenile wearing a Cincinnati Reds



hat, white shirt, and gray shorts. He matched the description so he slowed down. When he slowed down, the juvenile cut into a backyard on Goodman Avenue. PO Wilber responded to the McDonald's and watched the video. When he watched the video, the subject he observed I saw on Goodman was in fact the suspect. The suspect came in with 2 girls. While watching the video you can see the m/b making a gun motion with his left hand as he is walking out of the business. The motion is directed inside the store towards the employees. The victim stated the suspect made statements like "I'm gonna pop you", "I'll be back I'm gonna shoot you".
