# ARRESTS MADE IN MAY 2016

There were a total of **83** arrests made within the City of North College Hill in MAY 2016.

**45** of the arrests were recite arrests (the person arrested was not physically taken into custody but issued a citation and told to appear in court).

**38** of the arrests were physical arrests (the person was physically taken into custody).

Of the total arrests made within the month of MAY 2016, **36** were residents of North College Hill and **47** were non-residents.

## **IN MAY 2016**


There were a total of **44** auto accidents within the City of North College Hill in MAY 2016.

# TRAFFIC CITATIONS ISSUED

## IN MAY 2016

The North College Hill Mayor's Court had year-to-date receipts totaling \$61,202.00 as of MAY 2016.



There were a total of **96** traffic citations issued within the City of North College Hill in MAY 2016.

**42** of the citations were for moving offenses (OVI, Speeding, Fail to Obey a Stop Sign, etc.)

**10** of the citations were for non-moving offenses (Expired license plates, not wearing a seatbelt, etc.)

**10** of the citations were for parking related offenses (Parked where prohibited by signs, etc.)

**34** of the citations were written warnings (the person cited was not required to pay a fine or appear in court).



# VEHICLES TOWED OR IMPOUNDED

There were a total of 1 vehicles either towed or impounded within the City of North College Hill in MAY 2016. (These vehicles were towed or impounded at the request of the police department)



# FALSE ALARMS RECEIVED

## IN MAY 2016

There were a total of 22 false alarms received that required a response by the North College Hill Police Department in MAY 2016.

8 of these false alarms were to businesses.



14 of these false alarms were to residences.

136 Total false alarms have been received in 2016.



The following narratives are a small sampling of the various calls for service the North College Hill Police Department routinely receives.

## **CALLS FOR SERVICE**

### **Aggravated Menacing/Domestic Violence (2903.21/2919.25)**

Officers were dispatched to Sterling Ave. for a person with a gun. The person with the gun was a M/B juvenile. Officers were updated that the juvenile was now running towards Savannah Avenue through backyards along with his sister. Officers arrived and could not locate the suspect. PO Wilber talked to the juvenile's mother and she stated that her son was mad at his stepdad and that he came into the living room and then to the bathroom door with a gun in his hand and kicked the



bathroom door to get to his stepdad. The mother stated that is when she had to force her son out the door and he fought her the whole way out the door. She stated that the gun was black and that's all she could remember. The mother was treated by the squad due to her anxiety and trouble breathing.

On 05/02/2016 @ 1200 hours, PO Manning advised that he had located the suspect at the NCH High School. The suspect was wanted by police due to an incident that occurred at his residence on yesterday's date. Officers, as well as the suspect, responded to an address on Catalpa

Ave to retrieve the "BB firearm" that the suspect had in his possession during the incident on yesterday's date. The "firearm" was located, retrieved and the suspect was transported back to the PD to write a statement depicting his side of what happened at his residence, involving his step-father. After he completed his written statement, he was transported to 2020 by PO Kodish without further incident.

### **Panhandling (4511.51)**

While on Patrol, Lt. Maus observed a subject standing on the Exit Ramp from East Bound Ronald Reagan Highway at Hamilton Ave, panhandling. Lt. Maus observed the subject take a dollar bill from a stopped motorist. The defendant was arrested and \$8 US Currency was taken from the defendant for evidential value. Defendant was issued a summons to court and released from the Police Department.



A complainant stopped at the PD to report that his neighbor made threats to him while he was out cutting his grass. The complainant stated as he was cutting his grass, the suspect called him a "Simple minded mother f\*\*ker, and that he was going to whomp my mother f\*\*king ass!" The complainant stated he was fearful that the suspect would harm him. He stated that he did not want charges pressed, he just wanted it to stop.

The complainant stated the disagreement between them stated when he would come out to cut his grass and ask the suspect to move his car so grass would not get on his car. The suspect's car was parked in his driveway. This has been going on for a few years. Each time the suspect told the complainant his car is fine, it does not have to move.

PO Palmisano responded to the suspect's address to talk to him. He was not home but PO Palmisano talked to a female who lives there. PO Palmisano advised her of the incident. She stated the same as the complainant, but did not hear today's conversation.

### **Menacing (2903.22)**

PO Palmisano advised her to inform the suspect that the comments he is making is a criminal offense of Menacing, and that he continues he can be arrested for Menacing. PO Palmisano informed her to tell him if there are problems to contact the police. She stated she will tell him

a pry mark was observed on the a-pillar of the right, front door.

## **Disorderly Conduct** **(2917.11)**

On 05/16/2016 @ 2032 hours, officers were leaving a residence on Centerridge Ave. and they observed a small group of people standing in the front yard / driveway at another residence on Centerridge Ave. As officers approached the residence in question, a couple of the subjects raised their hands at the officers in an effort to flag them down.

When the officers pulled to the side of the roadway, they immediately observed two (2) females engaged in a physical altercation. The females were physically fighting each other in front this residence. Officers quickly exited their vehicles and were able to separate both subjects involved in the altercation. Both females were handcuffed and placed into separate police cruisers while officers attempted to figure out what had just occurred.

## **Criminal Damaging/Theft** **(2909.06/2913.02)**

On 5/16/15 at 4:25 am, PO Smith was dispatched to Clovernook Health Pavilion to investigate a theft from a motor vehicle. Upon arrival, PO Smith made contact with the complainant. The complainant stated that he was at Clovernook Health Pavilion to retrieve some items from his vehicle, a 2002, maroon, Chrysler PT Cruiser, at approximately 4:10 am on 5/16/15, and discovered that the front right side window was busted. The complainant's spouse, who is an employee at Clovernook Health Pavilion, stated that she parked the vehicle in the lot at approximately 5:30 pm on 5/15/16. The complainant reported that several compact discs were removed from the front of the vehicle. Upon inspecting the vehicle,



During the altercation between the females, a male subject was observed standing near them while they continued their turbulent behavior. After detaining the two (2) females in the police cruisers, officers started to approach the male subject to inquire as to what he had observed and to what had started the fight in the first place. Officers observed the male subject talking to another female, who



was in a vehicle that was stationary in the roadway, in front of the residence in question. As officers got closer to his location, they could hear him yelling and cursing at the female, who was in the vehicle. PO Shumate walked over to the male subject, and while trying to calm him down, he continued his disorderly behavior and even raised his voice in an effort to ignore and not comply with what PO Shumate was instructing him to do, which was to quiet down and to calm down. The male subject was given numerous opportunities to calm down and to cease and desist his disorderly behavior, but each one proved unsuccessful. It was at that moment that PO Shumate instructed the male subject that he was under arrest and for him to put his hands behind his back. The male subject was not compliant at first and for a short time;

he actively resisted PO Shumate while being handcuffed.

After all three (3) subjects had been handcuffed and allowed a few minutes to calm down; officers were able to sort out what had occurred between everyone involved. The male subject advised officers that his mother had passed away earlier this morning and that he was having a hard time dealing with his loss. He stated that one of the females is his wife and that they have been having some marital issues lately and that on today's date, he had arrived at the house with one of his cousins, the other female, so that he could collect some of his belongings and then leave for the night. He further stated that while he was loading up his cousin's vehicle with some of his personal effects, his wife arrived on scene with her mother and when she exited her vehicle, she immediately started an argument with him. It was reported that the cousin had stepped in during the argument, to take her cousin's side and that was when she and the wife engaged in a heated verbal altercation, which escalated into a physical fight between them. It was then discovered that the female that the

male subject was yelling and cursing at in the vehicle was his mother-in-law.

After speaking to each party involved and obtaining their side of the story, officers advised all of them that they would be receiving a citation for Disorderly Conduct and that it was in the best interest for everyone to take a break from one another so that they could calm down and possibly talk at a later time when everyone's emotions had subsided.

After issuing citations to all three (3) of them for Disorderly Conduct, the male subject and his cousin left the scene. The wife, as well as her five (5) year old daughter and mother, went into their residence for the evening.

## **Breaking & Entering** **(2911.13)**

05/16/2016 at 2231 hours second shift officers responded to Clean Getaway for an alarm. Officers arrived and found a PFO on the rear door. After clearing the business they re-secured the door and notified the owner before leaving.



The owner arrived on scene and noticed change was missing from the register. Watching the video you can see a male black subject with grey sweatshirt blue jeans, and a red back pack. Walk up to the business and peak through the window. Roughly a minute later you can see the

subject crawling on the floor from the back room to the front of the business towards the cash register. The subject stops in front of the cash register. After looking around he got up on his knees and began to grab the change out of the register. You can see the subject take all the change except for the pennies (total amount of change taken was unknown.) After he grabbed the change he stood up and ran to the back of the business and left through the rear door. PO Cole was unable to lift any prints off the register or the outdoor cigarette disposal bin.

Canvassing the local businesses the night manager of Walgreens told officers the subject in the photo walks around the business searching for cigarette butts. He told PO Cole if he sees him again he will notify the PD.

## Attempted Theft (2913.02)

Officers were called for a subject in tan shorts and a gray shirt, attempting to steal steaks from Save-A-Lot. On arrival, PO Lasonczyk spoke with the Assistant Manager, and he advised this subject appeared to be highly intoxicated and had tried to walk out of the store with \$100.00 worth of meat. The meat was dropped by the entrance and the subject was last seen walking northbound on Hamilton Ave. PO Kilgore located the subject in the lot of the Greater Cincinnati Credit Union and detained him. The Assistant Manager did not want to file charges on the subject, but did want him banned from the store. The suspect was advised he could not go to Save-A-Lot and was transported home to Highland Ave.

## Burglary (2911.12)

Officers Six and Shumate responded to Mearl Avenue for an active burglary taking place. The home owner was not home however, was alerted via security cameras in the residence. The resident advised dispatch she could see glass on the floor and could hear voices near the damaged window.



Officer Six and Shumate arrived on scene and established a perimeter. Officer Shumate could readily observe what appeared to be an open side door. Officer Six then called for additional units from Mount Healthy to respond and assist with searching the building. He also requested an Area Wide Channel and the notification of a K-9 Unit.

Officers checked the building to find an entry point and found the rear door leading to the crawl space had been kicked in. This door did not lead into the house. Further inspection showed the front window of the door was broken out. It did not appear as though the suspect had actually made entry here as the window was pretty high on the door. Officer Shumate was able to unlock the door however, allowing Officer Shumate and Six to enter the residence. The residence was then cleared but did not appear to be disturbed. As Officer Six arrived on scene he observed approximately 5 m/b juveniles leaving the area. It is

unknown if they were involved at this time. The residence was re-secured and the home owner was

advised to call Police upon their arrival.

## **Aggravated Menacing** **(2903.21)**

Officers were dispatched W. Galbraith Rd. for a person armed with a knife. The suspect was described as a male black wearing a yellow shirt, walking east on Galbraith Rd. The subject was located and was ordered to the ground at gun point. The subject complied and was detained where he was identified. When asked, the suspect indicated he was in possession of a knife. A black handled folding knife was found in his right front pants pocket.



With the knife recovered and the suspect detained, PO Miller responded to talk with the complainant. She stated that she was sitting on her porch with her three kids when she noticed the suspect walking down the sidewalk stumbling. The complainant does not know the suspect but hollered out to him as he walked by her house and asked if he was all right or if he wanted to sit down. The complainant stated that the suspect replied by stating he doesn't know her and that she was a

men or a tranny because of her deep voice. The complainant told the suspect to keep walking then if he was going to insult her. She said after a few minutes the suspect reappeared in her yard now holding a silver knife in his hand stating that he was going to cut her. The complainant told the suspect that if he came onto her porch she would "blow his ass away" (shoot him). The complainant said she was lying only to scare the suspect away and that she never had a gun. She said that the suspect then walked away and walked a few house east before crossing the street and then yelled back to her that he was coming for her and he wasn't alone.

The suspect stated that while he was walking on Galbraith a black SUV pulled up to him and called him "Sexy". He thought it was a female at first but noticed a male in the passenger seat. He then said the vehicle occupants accused him of having a gun and he stated he didn't have a gun but had a knife. The vehicle occupants then stated they had a gun before driving east on W. Galbraith. He said the vehicle turned around and then drove back towards him.
