# **ARRESTS MADE IN DECEMBER 2016**

There were a total of **42** arrests made within the City of North College Hill in DECEMBER 2016.

**20** of the arrests were recite arrests (the person arrested was not physically taken into custody but issued a citation and told to appear in court).

**22** of the arrests were physical arrests (the person was physically taken into custody).

Of the total arrests made within the month of DECEMBER 2016, **11** were residents of North College Hill and **31** were non-residents.

# VEHICLE CRASHES REPORTED IN DECEMBER 2016


There were a total of 43 auto accidents within the City of North College Hill in DECEMBER 2016.

2 - of these crashes involved injuries.

26 - of the auto accidents were on public roadways.

10 - of the auto accidents were on private property.

7 - of the auto accidents were Hit/Skip related.



# TRAFFIC CITATIONS ISSUED

## IN DECEMBER 2016

The North College Hill Mayor's Court had year-to-date receipts totaling \$119,935.00 as of DECEMBER 2016.



There were a total of **103** traffic citations issued within the City of North College Hill in DECEMBER 2016.

**51** of the citations were for moving offenses (OVI, Speeding, Fail to Obey a Stop Sign, etc.)

**13** of the citations were for non-moving offenses (Expired license plates, not wearing a seatbelt, etc.)

12 of the citations were for parking related offenses (Parked where prohibited by signs, etc.)

27 of the citations were written warnings (the person cited was not required to pay a fine or appear in court).



# VEHICLES TOWED OR IMPOUNDED IN DECEMBER 2016

There were a total of 2 vehicles either towed or impounded within the City of North College Hill in DECEMBER 2016. (These vehicles were towed or impounded at the request of the police department)



# FALSE ALARMS RECEIVED IN DECEMBER 2016

There were a total of 24 false alarms received that required a response by the North College Hill Police Department in DECEMBER 2016.

14 of these false alarms were to businesses.



10 of these false alarms were to residences.

330 Total false alarms have been received in 2016.



The following narratives are a small sampling of the various calls for service the North College Hill Police Department routinely receives.

## **CALLS FOR SERVICE**

### **Burglary (2911.12)**

On 12/02/2016 @ 1635 hours, PO Kodish was dispatched to Fourworlds Dr. for a burglary report. Upon arrival, he was met by the complainant, who advised that an unknown person(s) had entered her apartment, smoked marijuana and then moved several items around the house.

The complainant stated that she resides in her apartment with her young grandson and that they were both away from the apartment today.

Her grandson attends the NCH

Elementary School and she works outside her residence. She stated that when they both arrived home this evening, her grandson stated that something smelled funny in the apartment. She smelled the same thing as her grandson and she stated that it was strong smell of burnt marijuana. The smell permeated throughout the entire apartment and the complainant advised that while

she was looking around to see where the source of the smell was coming from, she noticed several items throughout her apartment had been moved or left

in some sort of disarray. She stated

that there were some towels in her bathroom that were observed lying on the floor, a couple bottles of alcohol were observed lying on their side in the dining room and she also noticed her house phone had been removed off the charger and that it was just lying on the table next to the charger.

The complainant stated she keeps an immaculate house and that these items listed were never or has ever been left the way she discovered them in her apartment. There were no signs of forced entry into the apartment and she stated that the only people who have keys to her apartment are her and the management of the apartment complex.

The complainant advised that nothing appeared to have been taken from inside her apartment and that she believes it might be someone from management that entered her apartment without permission. She also advised that she was going to change the locks to the apartment and look into purchasing an alarm system.

On 12/03/16 Officers were called for a domestic between two sisters physically fighting. PO Cole arrived on scene and observed three individuals in the front yard, the victim lying on the ground. PO Cole was advised by the witness that the sisters were involved in a physical fight and the defendant had cut the victim with a knife.



PO Cole escorted the defendant to his cruiser and placed her in the rear seat so he could attend to the victim. The victim suffered two lacerations, one to her left wrist and one to left calf. The wounds appeared to be nonlife threatening but required her to be transported to the hospital.

The witness stated all three of them went out for a night of drinking. She states while on the way home the victim stated she was going to jump out of the car while going down the highway. She states the defendant, who was seated in the back seat grabbed the victim from behind. She states the victim was attempting to find the car door handle to open the door. She states at some point the victim ended up in the rear seat and both the victim and the defendant

were arguing and "tussling around". She states this occurred all the way home from Ronald Reagan Highway and West Galbraith Rd. She states when they got home the victim and defendant continued to physically fight inside the car and that is when the defendant cut the victim with a knife.

The victim could only state that her sister, the defendant had cut her and she didn't want her to go to jail.

The defendant states she was engaged in an altercation with the victim, her sister as she was preventing her from jumping out of the moving car. She states during the altercation the victim began to choke her and bite her so she cut the victim in self-defense. She did have what appeared to be a bite mark on her left shoulder. She was asked if she wanted a squad to look at her and she refused.

The defendant was transported to the North College Hill Police Department to complete arrest paperwork. She was then transported to the hospital for treatment as the jail would have refused her to sustaining a human bite. She was treated and transported to the jail.

## **Theft (2913.02)**

Officer Six responded to Family Dollar for a theft that had just occurred. The unknown suspect had taken several bottles of laundry detergent. The estimated total is approximately \$150.00. The suspect had loaded up a cart, walked into the employee only section hiding the items in his shopping card. Once inside this area, he walked out the side door which is alarmed. The manager was busy ringing customers through the register. Another customer heard the alarm and alerted the manager, who then called police. Management is working on getting the video and will contact police when the video is made.



## **Criminal Damaging (2909.06)**

PO Miller was dispatched to Betts Ave. for report of a vehicle tampering in progress. Upon arrival, he was greeted by the complainant, who stated that her ex-boyfriend has been harassing/stalking her due to a recent break up. She said that she just got

off of work and went to her sister's house. Within minutes they heard banging at the front door. When they looked outside they saw the ex-boyfriend.

Refusing to answer the door, they watched the ex-boyfriend walk over to the complainant's car and put something into the gas tank, before leaving the area in a black Altima. After he had left, the complainant went outside to check her vehicle and had found that he had shoved a candy bar into the gas spout.

The complainant called the police and before PO Miller could arrive, the suspect called and left a voice mail message on complainant's cell phone about how her new car is going to drive.

The complainant requested that charges be filed and warrants were issued. She was advised on how to obtain a protection order.

### **Theft of an Auto (2913.02)**


On 12/13/2016, Lt. Maus was called to Dallas Ave. for a report Auto Theft that had just occurred. He arrived on scene and was met by the victim. The complainant stated unknown subject(s) took his motor

vehicle a 2000 Jeep, Grand Cherokee, blue in color, without his permission to do so. He states the motor vehicle was in the rear of his residence running and unlocked when the offense occurred.

The complainant was advised the process of how the motor vehicle would be reported and to notify his Insurance Company.

### **Robbery (2911.01)**

On December 23, 2016, officers responded for a hold up alarm at the United Dairy Farmers. PO Cole was the first unit on scene. The manager of the business walked to the door and stated they were robbed. The manager gave a description of a young male black with a black hoodie and blue jeans. She stated he had the hoodie tight so you could not see his face and a semi-automatic pistol in his right hand.



The manager stated the suspect walked in from the south side of the building and walked to the far end of the counter. The suspect pointed the firearm at the two employees and pushed them towards the counter stating to empty the cash drawers into a bag. The employees emptied the

registers (\$78.00 total) and gave the bag to the suspect. The suspect then with a calm posture walked out the door to Hamilton Ave., towards De Armand Ave. The K-9 tracked and lost the track around De Armand and Hamilton hinting the suspect may have left in a vehicle.

### **Assault (23903.13)**

PO Lasonczyk responded to Frisch's for trouble with a customer. The complainant, a manager for Frisch's stated the suspect and 3 other adults came in to the restaurant and ordered the Breakfast Bar. They ate and ordered a couple other items to go.

She stated she saw the adults putting items from the Breakfast Bar into the carryout containers.

When she confronted the adults about this, they started yelling and cussing at her, saying "Check with our server because we are not stealing anything."

The complainant left the area where they were sitting and returned to the register. When the subjects came to the front counter, they again



started to yell and cuss at the complainant. At that time, she just wanted them to leave and told them to get out. The suspect then threw a Big Boy sandwich at the complainant, striking her with the same. The suspects then left the building. Another employee was able to get the license plates of the 2 vehicles the subjects got into. The complainant did positively identify the registered owner of one of the vehicles as the subject that threw the sandwich at her.

### **Assault (2903.13)**

Officers were called to Kroger for a female who just had assaulted the manager. When PO Wilber arrived, he located the suspect over by the pharmacy area. He took the female into custody. After he detained the suspect, he went back into Kroger to watch the video. While inside an employee stated that she heard the suspect tell someone she was speaking to on the phone that she was about to walk out with it, meaning the groceries. The suspect had all the groceries bagged up, and the manager told her to wait where she was since none of her payments were working. The suspect did not have any way to pay for the groceries. She then took the cart of bagged groceries and walked away with the cart. The manager then grabbed the cart to

keep the suspect from having it. That is when the suspect hit the manager

in the head twice. The merchandise in the cart added up to \$263.79.
