ARRESTS MADE IN FEBRUARY 2017

There were a total of 88 arrests made within the City of North College Hill in FEBRUARY 2017.

40 of the arrests were recite arrests (the person arrested was not physically taken into custody but issued a citation and told to appear in court).

48 of the arrests were physical arrests (the person was physically taken into custody).

Of the total arrests made within the month of FEBRUARY 2017, 27 were residents of North College Hill and 461 were non-residents.

IN FEBRUARY 2017

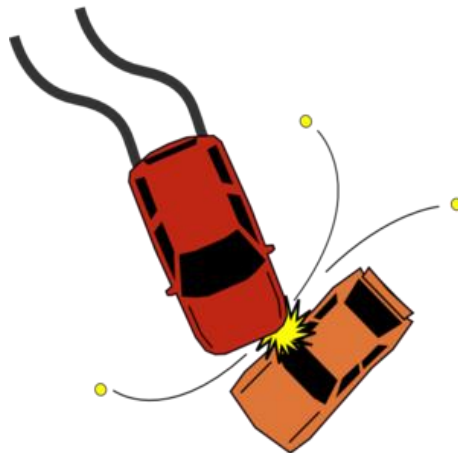
There were a total of **26** auto accidents within the City of North College Hill in FEBRUARY 2017.

3 - of these crashes involved injuries.

20 - of the auto accidents were on public roadways.

6 - of the auto accidents were on private property.

2 - of the auto accidents were Hit/Skip related.



TRAFFIC CITATIONS ISSUED

IN FEBRUARY 2017

The North College Hill Mayor's Court had year-to-date receipts totaling \$20,054.00 as of FEBRUARY 2017.



There were a total of 111 traffic citations issued within the City of North College Hill in FEBRUARY 2017.

66 of the citations were for moving offenses (OVI, Speeding, Fail to Obey a Stop Sign, etc.)

14 of the citations were for non-moving offenses (Expired license plates, not wearing a seatbelt, etc.)

10 of the citations were for parking related offenses (Parked where prohibited by signs, etc.)

21 of the citations were written warnings (the person cited was not required to pay a fine or appear in court).



VEHICLES TOWED OR IMPOUNDED IN FEBRUARY 2017

There were a total of 14 vehicles either towed or impounded within the City of North College Hill in FEBRUARY 2017. (These vehicles were towed or impounded at the request of the police department)



FALSE ALARMS RECEIVED IN FEBRUARY 2017

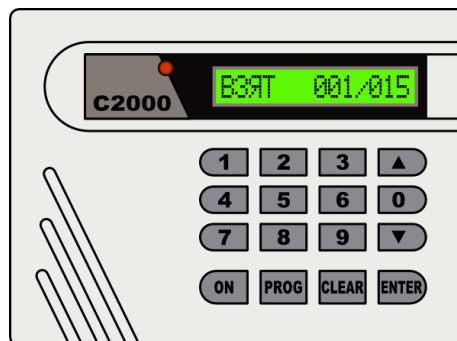
There were a total of 32 false alarms received that required a response by the North College Hill Police Department in FEBRUARY 2017.

16 of these false alarms were to businesses.



16 of these false alarms were to residences.

48 Total false alarms have been received in 2017.



The following narratives are a small sampling of the various calls for service the North College Hill Police Department routinely receives.

CALLS FOR SERVICE

Burglary (2911.12)

Officers were called for a burglary report. Upon arrival they were met by the victim who stated an unknown person or persons entered her residence by force, and took several items including an Xbox One and an unknown number of men's shoes. The unknown person(s) gained entry by forcing the front door open by unknown means, breaking the door frame. Estimated value of the Xbox is \$400.00; unknown value and number of shoes taken.



Misuse of a Credit Card (2913.21)

Officer Six responded to NCHPD to see a complainant on station. The complainant was accompanied by her mother, who was the victim. The victim wanted to report unauthorized use of her credit card. She had given her granddaughter her Visa credit card to use on car repairs. The victim believes she gave the suspect the card on January 9th, 2017. The card at the time had a zero balance. The victim initially authorized the suspect to make the repairs to her vehicle at the cost of \$2000 dollars. A short time after receiving the card, the

suspect calls the victim and states the car repairs would be more than originally thought. The victim then authorizes the suspect to use an additional \$1200.

On the 15th of January 2017, the suspect wrecked the vehicle that was authorized for repair. The victim calls the suspect to see how she is and request the card back. The suspect did not answer the phone; however she did call back the next day. The conversation was mainly about the wrecked motor vehicle. The victim does make an effort to request the card be returned. The suspect stated she would drop the card off in the next few days when she went to work. On the 20th of January, the victim and suspect speak again. The victim requests the card back for the second time. The suspect then gives another excuse and states she will drop off the card on the way to her job.

A few days later, the suspect called the victim again. This time she states that she is looking to buy another car. The suspect explains how she needs \$800 for a deposit. The suspect explains she has a job in Kentucky and would hate to lose it. She says she has money but it was

all "tied up." As soon as she can get a car, the suspect will pay the victim. The victim agrees to authorize this purchase so the victim would not be without transportation.

In the same time period, the suspect says she is homeless and now needs to stay at a hotel. The suspect goes on to say the hotel will only cost about \$70 a night. The victim agrees and tells the suspect to not spend over \$200. The suspect calls back and says she spent \$500. The victim reluctantly agrees and asks for the card back for the third time. The victim also requests the receipts for the transactions. The suspect promised to bring everything to the victim just as soon as she gets the car and goes to work, again.

On the 29th of January the victim calls to check on the card balance. The company states she is over her limit and in total, there is \$15,283.01 charged to the account. The victim learns she has several transactions on her Discover Card as well. These total \$449.62. At this time the suspect's involvement in the Discover transactions are unknown. The victim did mention she noticed the card



missing about the same time the suspect collected the other card.

When Officer Six interviewed the victim, she stated all dates used are approximate. She stated she has called the suspect several times and requested the card. The suspect always provides some excuse as to why she cannot return the card, according to the victim. The suspect seems to be manipulating the victim's good nature. The victim has racked up a \$7,000 Verizon phone bill, which the victim co-signed for.

Also from approximately, December 3rd, 2016 the suspect has repeatedly requested cash from the victim. The victim stated the suspect calls and states she is having a problem with the fines at court. The suspect makes the matter seem urgent causing alarm to the victim. These cash transactions have led to over \$12,000. This has left the victim with less than \$500 in her account. The victim noted that she borrowed \$20 from the neighbor, just to have money in her purse. When all done, the total is as follows and does not include the Discover bill.

\$15,283.01 - Visa
\$12,000.00 - Cash disbursements
\$7,000.00 - Verizon bill

\$34,283.01 IN TOTAL

Assault (2903.13)

On the above date and time, Lt. Maus was called to Fricker's an assault report. He arrived and spoke to the manager, who stated a regular customer was involved in an altercation with another patron. She also stated the "regular" had walked out on his bar tab valued at \$22.25.

Lt. Maus spoke to the victim of the assault, who stated as he was walking in the parking lot with his wife when he was approached and assaulted by the suspect. The victim states as he was walking in the parking lot on the east side of the building and the suspect was observed jumping over the railing from the patio. He stated the suspect charged at him yelling "I heard you been talking shit about me". The victim stated the suspect continued to charge at him and then punched him in the chest. He stated the suspect continued to yell at him and his wife, causing his wife to become upset and scared. He



stated the suspect was then escorted to a motor vehicle in the area by another subject, possibly his friend.

A witness stated while he was on the patio, the suspect engaged in a verbal argument with him. The witness stated the suspect was belligerent and acted as he was going to assault him, but the situation was mediated by other patrons on the patio that separated the two. The witness stated he saw the assault on the victim.



running from the car. They were last seen running through the alley behind St. Paul's Church, towards the High School.

Felonious Assault (2903.11)

Officers were dispatched to Columbine Ct. for a trouble run that turned into a fight in progress, with a subject armed with a knife. The subject had tossed the knife on the ground. Officers arrived and approached the apartment and made contact with a subject who turned out to be the suspect. This subject sounded out of breath as she was walking outside the apartment looking for her phone. She stated a female attacked her. She had a cut on her hand and mud on her clothes.

Officers located the knife next to blood and a large amount of hair/ fake hair. This subject stated the argument started when another subject made threats to her daughter at a club (The Avenue). She stated the other subject came to her house to fight her. The suspect came to the side of the apartment with a knife when the other subject attacked her in-between the apartment and the parking lot. Both

Theft of Auto (2913.02)

The complainant called and stated the 2 teenage male blacks had taken a silver Honda Accord, which is registered to her mother, without consent to do so. The vehicle was parked in front of the complainant's residence. She had started the car so it could warm up, and she was going to leave shortly. She heard the engine rev and she looked out the window. She saw the vehicle going through the parking lot towards Bising Ave. She got in her other vehicle and followed the car. The Honda pulled in to the lot of 1610 Bising and the complainant blocked it in so they could not leave again. She started to walk away and saw the suspects

parties began to swing profusely at each other. The suspect stated she did not know she still had the knife in her hand while she was swinging/stabbing the other subject. The suspect stated a male subject dragged the other subject away and that's when officers arrived.

Officers collected the knife for evidence and took pictures of the crime scene. Officer Miller explained to the suspect that if a victim appears she could be charge for the incident before we left.

Roughly a minute after officers cleared the incident, dispatch notified us of a victim who was brought into the hospital after being stabbed several times possibly related. Officers confirmed the victim was the other subject involved in this incident, who had severe lacerations to the face and arm. Officers drove back to Columbine Ct. to bring the suspect to the PD for further questioning and charges.

PO Cole drove down to University hospital where he was able to locate two witnesses of the incident. The victim's sister had blood all over her arms and chest. She stated they were going to drive to Columbine Ct to clear things with the suspect. She then stated her sister got out of the vehicle and walked over to her apartment. The victim then



yelled she's stabbing me. The witness stated she then got out of the vehicle and swung on suspect several times to separate them. She stated a male subject then grabbed the suspect and dragged her into the apartment and they drove victim to the hospital.

A second witness's story matched the first witness story. While the first witness wrote a statement, PO Cole walked over to the victim's room and took photos of most of her lacerations. Several of the lacerations were already bandaged. One of the staff members said she had 2 lacerations on her head and 4 on her arm. Another member stated she had a total of 5 lacerations. Officers will do a follow up for the exact number and locations. The victim was unable to talk or give a statement. Officers advised her mother after she was released to drive to the police department to give a statement and to take photos of the lacerations after they were sutured.

The suspect was transported down to jail for felonious assault.

Theft (2913.02)

The complainant stated she was at Super Laundry doing her laundry. During her visit, she began to load a dryer. Another person then loaded her belongings into the same dryer.

The two then got into an argument. A short time later the complainant noticed her dryer was done and took her clothes to leave. When she got home she noticed approximately \$200 of her son's uniform clothing were now missing. The complainant stated that although she remained on the premises, she did step out to her vehicle a few times. The complainant believes the other involved party had taken the clothes out of spite.

Domestic Violence (2919.25)

On 2/13/17 at 11:56 PM, a public service (phone call) was received reference a domestic dispute on Knollridge Ln. Upon arrival on scene, contact was made outside the residence with the victim. The victim was visibly shaken, and had what appeared to be a hematoma on her forehead. PO Smith requested EMS respond to the scene to evaluate her injuries, which also included lacerations on her lip and right hand, and a small red mark on her right lower leg.

The victim stated the following:

At approximately 10:30 PM that night, she was at home with a male

friend. After the friend left for the evening, the defendant, who is her live-in boyfriend, asked her for his debit card. A verbal altercation began. During the course of the verbal altercation, she cut up the debit card. This caused the defendant to become increasingly angry, and he began to strangle her.

The victim advised that the physical altercation occurred in the bedroom. PO Smith asked her if the defendant had consumed any alcoholic beverages, and she stated, "Yes." He then asked if the defendant was inside the residence, and she stated that he was currently in the bedroom. When additional units responded on scene, they entered the residence and made contact with the defendant, who was in the bedroom.

The defendant stated the following:

He and the victim began to argue over their relationship ending. She became upset, and started scratching his neck. He made physical contact with her to defend himself. After the physical altercation ended, they both used a frozen bag of green beans to aid the injuries, and began to discuss their relationship. After assuring her



that everything was ok, he returned to the bedroom to go to sleep.

The defendant had visible scratch marks on both sides of his neck. An odor of alcoholic beverage was observed on his breath.

After speaking with the defendant, PO Smith again made contact with the victim. He asked her how the defendant got the scratches to his neck, and she stated that she was defending herself. He asked her who initiated the physical contact, and she stated that the defendant pushed her first, but she was not sure who threw the first punch. She also stated that her eyeglasses and cell phone were damaged during the altercation.

Based on the statement of both participants, and the severity of the victim's injuries, the defendant was arrested for domestic violence, 2919.25 of the Ohio Revised Code, and transported to Criminal Justice Center for processing. The victim was transported to Mercy West Hospital by North College Hill EMS for further evaluation.

Aggravated Menacing **(2903.21)**



A complainant, who owns property on Shamrock Ave. called and advised the suspect, a former tenant, was on the property today and they got involved in a verbal altercation. PO Lasonczyk checked the immediate area, but was unable to locate the suspect. On arrival to Shamrock, PO Lasonczyk spoke to the complainant,

who stated the suspect had moved unexpectedly and he returned today. She asked him if he needed to get any property and he became very aggressive. He stated she owed him his deposit, though he moved without telling her. She advised that if he felt she owed him money, he would need to take her to court. The suspect became more agitated and made a comment about "burning down the building." PO Lasonczyk asked the complainant what she would like us to do and she stated she wanted him to call the suspect, and requested he do it immediately. PO Lasonczyk advised her he does not use to personal phone to make calls like this and that he would go to the PD to make the call. She said PO Lasonczyk could use *67, but he again told her he would use the PD phone. PO Lasonczyk checked the area more, but was still unable locate the suspect. PO Lasonczyk

responded back to the PD, made the call, and left a message as the

suspect did not answer.
