ARRESTS MADE IN MAY 2017

There were a total of **79** arrests made within the City of North College Hill in MAY 2017.

52 of the arrests were recite arrests (the person arrested was not physically taken into custody but issued a citation and told to appear in court).

27 of the arrests were physical arrests (the person was physically taken into custody).

Of the total arrests made within the month of MAY 2017, **22** were residents of North College Hill and **57** were non-residents.

IN MAY 2017

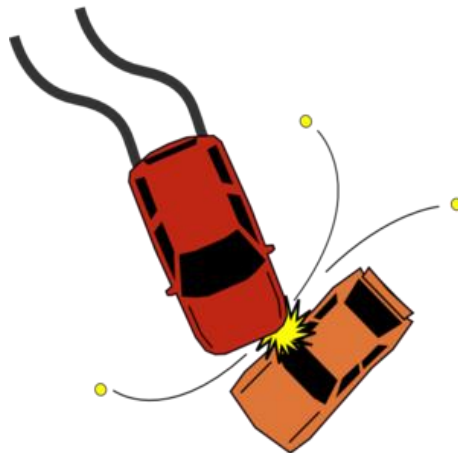
There were a total of 30 auto accidents within the City of North College Hill in MAY 2017.

3 - of these crashes involved injuries.

19 - of the auto accidents were on public roadways.

3 - of the auto accidents were on private property.

5 - of the auto accidents were Hit/Skip related.



TRAFFIC CITATIONS ISSUED

IN MAY 2017

The North College Hill Mayor's Court had year-to-date receipts totaling \$53,412.16 as of MAY 2017.



There were a total of **123** traffic citations issued within the City of North College Hill in MAY 2017.

70 of the citations were for moving offenses (OVI, Speeding, Fail to Obey a Stop Sign, etc.)

17 of the citations were for non-moving offenses (Expired license plates, not wearing a seatbelt, etc.)

18 of the citations were for parking related offenses (Parked where prohibited by signs, etc.)

18 of the citations were written warnings (the person cited was not required to pay a fine or appear in court).

IN MAY 2017

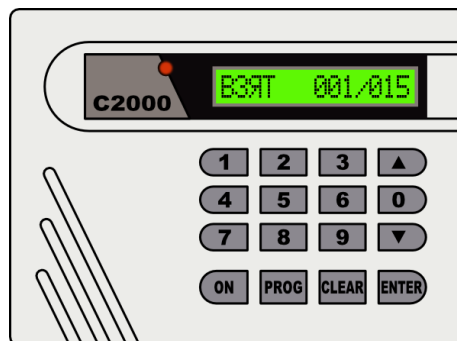
There were a total of 33 false alarms received that required a response by the North College Hill Police Department in MAY 2017.

18 of these false alarms were to businesses.



15 of these false alarms were to residences.

128 Total false alarms have been received in 2017.



The following narratives are a small sampling of the various calls for service the North College Hill Police Department routinely receives.

CALLS FOR SERVICE

Felonious Assault (2903.11)

On 05/01/2017 the victim responded to the North College Hill Police Department to report an assault. The victim states she was at a residence on W Galbraith Rd attending a memorial celebration for a deceased friend. The victim states she was intoxicated and was lying across the rear seat of a pick-up truck parked in the driveway of the residence when she heard a female yelling. The victim states she heard a female yelling "who was talking shit about me". The victim states she then heard her husband state "Natasha said it, she is in the truck, go get her".

The victim states a friend went over to the truck and stood by the door to keep her inside and others from getting into the truck. The victim states her husband and others went over to the truck and attempted to get the friend to move away from the door so that the defendant could get to her. The victim states her husband then pushed the male friend away from the truck and an unknown individual opened the truck door. The victim states she then began to get out of the truck and while getting out she was attacked by the defendant.

The victim stated she heard her son yelling "leave my mom alone"

when she was struck with a closed fist by the defendant. The victim states she was struck in the face approximately twice which caused her to fall on the ground next to the truck. The victim states while she was on the ground, the defendant got on top of her and continued to assault her by repeatedly punching her in the face and head. The victim states she does not remember much after the defendant was on top of her and assaulting her. The victim states she just remembered being picked up off the ground and getting back in the truck and her son drove the truck away from the scene and took her home.

The victim states when she arrived home in Price Hill she called 911 to report the incident and Cincinnati Police arrived. She states she was advised to call North College Hill Police to report the incident and an Ambulance was requested to respond as her eye was visibly injured and swollen. She states the Cincinnati Police Officer drove her to the hospital as there was going to be a long wait for Cincinnati Fire to respond for treatment or transportation to the Hospital. She stated she was taken by Cincinnati Police to Christ Hospital where she was treated for her facial injury. She

states she was evaluated at Christ Hospital and advised she had several fractures in her Orbital Bone which requires a follow up with a surgeon for further treatment.

Theft From Vehicle **(2013.02)**

Complainant reports on May 4, 2017 between the hours of 2:30 am and 5:00 am, she had two vehicles parked in the driveway and left the doors unlocked, someone went in the vehicles. They took nothing from the Kia but took \$4 in change out of the console and a silver heart necklace from the rear view mirror. The complainant was advised to inventory the vehicles and notify me with any other items thought to be missing. Two other people on the street stopped and stated their vehicle was also gone through and stated they would make a report after coming home from work today.



Drug **Possession/Drug** **Paraphernalia** **(2925.11/2925.14)**

Officers were dispatched to McShell for a report of a male in the gas station restroom

Criminal Damaging (2909.06)

yelling and refusing to come out. Upon arrival, PO Shepherd and P.O. Wilber entered the men's restroom to find a subject in the stall with a needle on the floor near him. He immediately admitted that the needle was his and that he had just used it to inject heroin. The subject was placed in handcuffs, and upon searching him, PO Shepherd located a package of additional needles, and a small folded piece of paper which contained a powder substance that he admitted to being heroin.

The Lifesquad was requested to respond to the scene because of subject's erratic behavior and admission to having just injected heroin. The squad transported Crawford to U.C. Hospital for treatment. P.O. Ryan assisted the squad with the transport and placed a holder on the subject at the hospital.

Warrants were put out for subject's arrest upon his release from the hospital. The charges include Felony Drug Possession and Possession of Drug Paraphernalia.



PO Henn was dispatched to see a complainant for a property damage report. Upon arrival, he was met by the victim, who states the rear window of her vehicle was damaged by unknown means while that vehicle was parked on the street near her residence. The victim states she returned home approximately a half hour prior to calling police and the vehicle was not damaged at that time. The vehicle does have damage to the entire rear window, and appears to have been struck by some unknown object toward the top of the window, near the vehicle roof. Nothing out of place or unusual was seen in the direct vicinity of the victim's vehicle, and it does not appear the projectile entered the vehicle through the glass. The victim states a neighbor was outside mowing a lawn when she returned home. I was able to speak with that subject and he stated he did not observe anyone in the area of the vehicle. I also spoke with another neighbor, inquiring if she had seen anything. She also stated she knew nothing about the incident. The victim states she has not had any problems with anyone, and has no idea who may be responsible for the damage.

Aggravated Robbery **(2911.01)**

Officers were called to Ameristop for a report of a Robbery that had just occurred. The suspect was described as a male black with dreads, dressed in all black. PO Wilber was first on scene and started to view the video. PO Lasonczyk arrived and a clerk was still waiting on customers that had come in after the Robbery. I advised the store needed to be closed and PO Lasonczyk spoke to the clerk that was robbed as well as a witness that was in the store at the time of the robbery.

A customer in the store stated she was speaking with the clerk about Lottery tickets when the suspect walked up to the counter. She said he had come in behind her and was shopping before he came to the counter with a can of beer and a bag of chips. She said he said something about a bag and she realized he was telling the clerk to put money in the bag. She stated the suspect kept reaching on his left side and displayed a gun, though he did not



point the gun at her or the clerk. She began to walk away. He looked at her and told her he was not going to hurt her. The clerk then gave him all the money and the suspect left the store, turning to the right and around the building (south on Simpson,) towards Buddy Rogers, which is behind Ameristop. She described the suspect as a male/black of medium complexion. He was "in his 30's," and had dreads, or "spikey hair." He was wearing all black, with a black hoodie. He was described as approximately 6' 00" tall and thin build.

The clerk said he was waiting on a Lottery customer, but she was still deciding what tickets she wanted, so he asked her if he could take care of the customer that walked up with a can of beer and a bag of chips. This "customer" came up to the counter and told the clerk to open the drawer and give him "everything in the drawer!" He pulled at a gun on his left side and displayed the gun, but did not point it at him. He gave the suspect the money, an undetermined amount of cash. The suspect then left the building, turned right, and ran towards Buddy Rogers.

Both the clerk and the customer also said there was a red Chevrolet Cobalt that was parked in front of the store while the Robbery was occurring. No one got out of the car, but after the suspect ran out of the store, the male occupant rolled down the window and asked "What just happened?" He was told the store had just been robbed and the subject said "He was walking!" The subject then "took off" quickly in the direction the suspect had gone. It is unknown at this time if the subject in the red Cobalt was also involved. He was described as a male, black with dreads and a mustache.



the vehicle was locked, and he has the keys to the vehicle.

Assault (2903.13)

A complainant responded to NCH PD to report that someone had assaulted her son. They explained to me that the victim was walking home from school and was near NCH Bakery when he accidentally bumped an unknown male black, approx. in the 6th grade. The unknown 6th grader then proceeded to punch the victim in the face twice. He made contact with the victim's left cheek bone, which was swollen and bruised.

Theft of a Vehicle (2913.02)

PO Henn was dispatched to Pippin for a vehicle theft report. Upon arrival, he was met by the reporter who states an unknown person or persons removed his work vehicle from the listed location. According to the reporter, he parked the vehicle in the lot across from his residence over the weekend, and on today's date, he found the vehicle missing. The vehicle is a Zimmer Heating and Cooling work truck with job related equipment inside. The reporter states

The victim explained to PO Elston that he does not know the name of the suspect but believes that he is in the 6th grade at NCH Middle School. PO Elston told him that if he sees him at school tomorrow to tell a teacher in hopes of getting the suspect identified. The complainant explained to PO Elston that she called the school and notified them of the incident also. The school directed her to the police department to make a report.

PO Elston sent the information to the SRO and attempt to follow up on this incident tomorrow.

Disorderly Conduct **(2917.11)**

Officers were called to investigate an fight in progress. Upon arrival, Lt. Petrocelli spoke with the caller, who resides near where the fight was occurring. She states that she walked outside and saw a boy in a red shirt being assaulted by a boy in a Blue shirt. She states that the boy in red kept repeating that he was stating that he was "Sorry".



Lt. Petrocelli then spoke with the boy in the red shirt and his Mother. The boy states that he was walking across the street, minding his own

business, while drinking water from a water bottle. He states that he accidentally allowed water to fall from his mouth directly into the path of the boy in the blue shirt that was unfortunately for him riding his bicycle past the other subject.

Apparently boy on the bicycle believed the act was intentional and took umbrage to the act and knocked the subject with the water to the ground and struck him several times.

Both juveniles were charged with Disorderly Conduct and will be notified to Downtown juvenile court.
