ARRESTS MADE IN JUNE 2017

There were a total of 62 arrests made within the City of North College Hill in JUNE 2017.

28 of the arrests were recite arrests (the person arrested was not physically taken into custody but issued a citation and told to appear in court).

34 of the arrests were physical arrests (the person was physically taken into custody).

Of the total arrests made within the month of JUNE 2017, 17 were residents of North College Hill and 45 were non-residents.

VEHICLE CRASHES REPORTED IN JUNE 2017


There were a total of 39 auto accidents within the City of North College Hill in JUNE 2017.

0 - of these crashes involved injuries.

24 - of the auto accidents were on public roadways.

8 - of the auto accidents were on private property.

7 - of the auto accidents were Hit/Skip related.



TRAFFIC CITATIONS ISSUED

IN JUNE 2017

The North College Hill Mayor's Court had year-to-date receipts totaling \$62,297.16 as of JUNE 2017.



There were a total of **181** traffic citations issued within the City of North College Hill in JUNE 2017.

104 of the citations were for moving offenses (OVI, Speeding, Fail to Obey a Stop Sign, etc.)

29 of the citations were for non-moving offenses (Expired license plates, not wearing a seatbelt, etc.)

20 of the citations were for parking related offenses (Parked where prohibited by signs, etc.)

28 of the citations were written warnings (the person cited was not required to pay a fine or appear in court).



VEHICLES TOWED OR IMPOUNDED IN JUNE 2017

There were a total of 14 vehicles either towed or impounded within the City of North College Hill in JUNE 2017. (These vehicles were towed or impounded at the request of the police department)



FALSE ALARMS RECEIVED

IN JUNE 2017

There were a total of 31 false alarms received that required a response by the North College Hill Police Department in JUNE 2017.

16 of these false alarms were to businesses.



15 of these false alarms were to residences.

159 Total false alarms have been received in 2017.



The following narratives are a small sampling of the various calls for service the North College Hill Police Department routinely receives.

CALLS FOR SERVICE

Felonious Assault/Aggravated Arson (2903.11/2909.02)

The victim contact officers via PD phone and stated he was set on fire near the 1900 block of Goodman Ave while he was walking home from work around the 1900 block of Goodman. Officers walked around Goodman and did not locate any evidence and then responded to the victim's home. The victim answered the door and had his shirt off with an ice pack on his back. He had several large blisters on his back. Officers dispatched a squad.



The victim stated three male black subjects wearing all black with hoodies ran up behind him and threw rubbing alcohol on his back and lit it on fire. He stated he dropped to the ground and rolled until the flames were gone. When he got the flames off the subjects were gone. That's when he walked home and called police. Officers asked him if he knew the subjects or had problems with anyone and he stated no. The victim gave officers his burnt shirt for evidence.

The victim declined transport by the squad. Officers advised a report will be produced and if he finds out any more to contact the PD.

Criminal Damaging **(2909.06)**

Officers Six and Kilgore met with the victim at his residence. He advised he and his wife were watching TV. They heard a loud bang behind them and when he got up he noticed the front window had a large crack in it. The crack appeared to have been caused by a BB gun. The victim originally stated he believed the person involved may have gone into the apartments next door. Officer Kilgore checked the area and could not find anyone out or anything that seemed to be related.

Theft (2913.02)

The victim stated he had \$400.00 in US Currency hidden under the floor mat on the front passenger's side of the vehicle that is parked in his driveway. The vehicle is not used and does not have current registration. He also has a sheet covering the roof and windows of the vehicle. The sheet was taped to the vehicle, using duct tape. The victim last saw the money at approximately 2100 hours on June 5, 2017. When he went to get the money this morning, he noticed the sheet on the



passenger's side of the vehicle was no longer taped to the windshield. The doors were still locked; however, when he checked under the floor mat, the money was gone. No one else, to his knowledge, has keys to the vehicle and he does not know how anyone would have gotten into the car.

Passing Bad Checks **(2913.11)**

Officers were called to Huntington Bank for a subject attempting to pass a fraudulent check. Upon arrival, we were directed to the subject standing at the cashier window. They went to a private office to discuss the incident. According to the suspect, he received a check from a female that is known to him, as payment for a tattoo he did for this female. The suspect states he normally does not accept checks for work performed, however he has done other pieces for the female in the past, and felt comfortable in taking the check as payment. The suspect, who resides in the area, then took that check to the Huntington Bank in NCH, in an attempt to cash said check. The check in question is written on Huntington Bank, in the amount of \$30.00. The bank

employee stated she had contacted the account holder and confirmed that the check was not to be honored. The suspect did have numerous text messages from the female subject in his phone. The text messages did reflect plans for him to do a tattoo for her, and the amount expected for the work would be \$30.00.

PO Henn was able to speak via telephone to a subject who identified himself as the listed account owner, having obtained that number from the bank personnel. The owner confirmed he does have an 18 year old daughter by the name given by the suspect. The owner stated they no longer use the checks in question, and had no idea his daughter had any of their checks in her possession. He was advised to contact his local law enforcement should he wish to pursue criminal charges or file a report for the stolen checks. The suspect was advised the check will not be honored, and he would need to seek civil action against the female should he wish to receive payment for his services. All parties' information was obtained, and the suspect was released.



Domestic Violence (2919.25)

On 6/13/17 at 1:27 am, PO SAmith was dispatched to Savannah Ave to investigate a person injured in an assault. Upon arrival, contact was made with the complainant. The complainant stated that her daughters had physically assaulted their siblings.

The complainant stated the daughters were angry because she would not drive them to a friend's house in Mt. Healthy earlier that evening. The complainant then stated at approximately 12:30 am on 6/13/17, the daughters physically assault the siblings in the boys bedroom of the house, and damaged several items in the residence. She stated that all three victims were struck with punches, and one daughter used a bottle opener from the kitchen and cut another sibling on his left calf.

NCH EMS responded to the scene for medical evaluation. Transport to the hospital was refused by the complainant for all three victims. One son had a small laceration present on his left calf. Another victim had visible swelling near her left eye. The third victim did not have any visible injuries.

Menacing (2903.22)

PO Cole was dispatched to Balfour Ln. for a menacing report. PO Cole spoke with the victim who stated that his neighbor threatened to kill him a few hours prior to calling the police. When asked why he delayed in calling the police he stated he had other things going on in his life.

PO Cole made contact with his neighbor and asked him about the incident. The neighbor stated that earlier in the day he was parking his vehicle and the complainant was outside and an argument started over parking. During the argument, the complainant insulted him by stating he still lives with his mom. The neighbor stated that his mother had just passed away 2 weeks ago and was upset over that statement. He admitted that he threatened the complainant. He stated that he said the statement out of anger. He further stated that after making his statement, the complainant said that he would get his gun and shoot him.

PO Cole spoke with the complainant again and asked for more details about what lead up to

the threat being made. The complainant stated he was outside working his car and his neighbor threatened him for no reason. When pressed again and asked if he made any statements he stated he made a comment about him living with his mother and had forgot that she just passed away. The complainant denied ever making any threats towards his neighbor. When the complainant was asked how he wanted to handle the situation he advised that he wanted me to inform his neighbor to stay away from him and leave him alone. He was so advised.

Burglary (2911.12)

The complainant stated that as she was getting ready to go to work, she heard someone knocking on the front door. She looked out and saw her ex-boyfriend. She stated he did live with her at this address for approximately 5 months, but moved out in January, 2017. She stated he wanted to come in and when she refused, he said "Well, can I use your phone charger?" She again refused and she went back to getting ready for work.



A short time later, she heard the bells she has hanging from her back door. She immediately ran out the front door. She said she tried to call the North College Hill Police (521-7171,) though the phone at the PD never rang. She said she then called the Hamilton County Communications Center (825-2280,) but again received no answer. We received the dispatch as a result of a 3rd party call. The complainant initially stated she did not see anyone in the house, but later stated she did see the suspect inside.

In the back of the house, we did find that someone had broken a window, and the frame of the back door leading to the house was shattered. She stated the suspect had broken the window, opened it, and climbed inside. At that time, he had access to the door leading to the kitchen, where the door frame had been broken, showing further forced entry. She said he then went to her bedroom, which is at the front of the house and took \$45.00-\$50.00 from her purse. She said he left when she yelled "The police are here!" She said the subject inside the house then ran back to the kitchen, unlocked the exterior door and ran towards Clover Ln.



PO Brown was able to lift fingerprints from the back window, which will be submitted for examination.

Large Juvenile Fight

Officers were dispatched to a large fight involving 30-50 individuals. Upon arrival, they found a large amount of people standing around screaming and yelling at each other. Two juveniles claimed injury, and were treated by Sq. 78 (refusal).

Officers found all the parents of the alleged combatants and had them meet and talk to each other. They found PO Manning later in the evening and told him that the original fight was over things that were stated by people that were not at this fight, and that the statements were unknown to the combatants; just they were talking about each other on social media. Problem was mediated by the parents.

Drug Abuse Instruments **(2925.12)**

Officers were notified of a suspicious vehicle in the Kroger parking lot that has been there for

Theft of Motor Vehicle (2913.02)

The complainant reported that her tan 2000 Toyota Sienna mini-van, was taken from her driveway without permission by person(s) unknown. The offense occurred sometime between 06/27/17 @ 2300 hrs and 06/28/17 @ 1100 hrs.

The complainant advised that the doors were unlocked and a spare key was in the vehicle. There are Winton Woods park stickers on the windshield and a dented left rear quarter panel. The left front door is also scratched up. The complainant also stated that her wallet was in the vehicle with an unknown number of credit cards. She was advised to contact her card companies and cancel the cards and to advise of any fraudulent charges on those cards.

over 20 minutes. As PO Cole approached the vehicle the operator started the truck. PO Cole noticed looking through the window the driver hide a black and pink bag under his leg and syringe caps on the ground and a water bottle lid filled with a liquid substance. The driver stated there was nothing in the bag. When asked to look inside he pulled an empty cigarette carton out of the bag and placed it on the dash. PO Cole asked both subjects to step out. The operator dropped an open syringe and his lighter. Once both subjects were detained, PO Cole walked back up to the vehicle and saw a small white box in the cigarette carton. The passenger stated there was heroin in the white box and mixed heroin in the pill bottle. The operator stated the bag was his and was transported to the PD. Officers charged the operator with drug paraphernalia and told him if the drugs in the white box and pill bottle come back as heroin he will be notified and charged for possession.
